Thank you for your consideration of H.B.1378 that would require the Department of Transportation to develop plans for the construction of secondary access roads for the Wai'anae district on O'ahu. I support this measure and urge you to vote in favor of H.B. 1378.

The careful assessment of tangible solutions to alleviate the traffic burden for residents on the Leeward Coast is long overdue and greatly needed. A secondary access way to serve the roughly 43,000 residents in the area is necessary for both the safety and the livelihood of my constituents.

We must not let that cost continue to burden future generations to come. Please support H.B. 1378. Mahalo for your consideration.

H.B. 1378, H.D. 1 RELATING TO HIGHWAYS

Senate Committee on Transportation and Energy

The Department of Transportation (DOT) supports the intent of this bill.

The DOT is currently in the procurement phase to conduct a corridor study of the Nanakuli, Maili, Waianae, and Makaha corridor. The scope of the study is to assess and provide recommendations to provide a second access into and out of the area, reduce congestion, increase capacity, and improve safety. The study will also consider the following modes of transportation: freight, vehicular, transit, bike and pedestrian modes.

The DOT recommends this corridor study be completed for the purpose to leverage federal funds for the proposed projects identified in the study. The corridor study is estimated to take two years to complete.

At this time, funding to construct a secondary access road is not available. As such, we believe that options that consider building new roads outside of the existing corridor will be considered infeasible. We recommend that funds appropriated for this effort be allowed to be used for planning, design, construction and operation to provide the most flexibility.

Aloha Chair Inouye and Vice Chair Dela Cruz and Committee Members:

My name is Gail Gomes and I am a forty plus year resident of the Wai'anae Coast. I am the editor of our local community newspaper, *Westside Stories*, however today I am submitting testimony as an individual.

I am requesting your support of **HB1378 HD1** to appropriate the funds to the Department of Transportation (DOT) for planning and procurement for construction of secondary access road or roads that will pass through the Westside of O'ahu (the moku of Wai'anae) and to serve as alternative routes to Farrington Highway for travel within, into, and out of the Westside. I would respectfully submit that the bill be amended a bit from *"Waianae district" means the leeward coast of Oahu from Nanakuli to Kaena point that is enclosed by the leeward slopes of the Waianae mountain range* to **from Kapolei/Honokai Hale to Ka'ena Pt** as currently we are unable to access our Westside once we leave the Kapolei/Makakilo/Honokai Hale areas

This was sadly highlighted on all three local news stations recently as there was a fatal accident near the Kapolei off ramp. No one was able to enter or leave the entire Westside of O'ahu including those living/working in Ko Olina and Honokai Hale. Families were unable to pick up their children from school, come home from work and City bus service came to a halt. Emergency vehicles had to have police escorts through the traffic (both westbound and eastbound) as traffic was literally stopped for hours so HPD could complete their investigation and the medical examiner could arrive on the scene and attend to their duties.

For too long "Westsiders" have been "held hostage" by Farrington Highway. It doesn't seem to matter what day of the week it is, there is always traffic backed up for at least one half mile due to traffic lights. On weekdays, we now have a contra-flow lane from 3:30 to 6:30 pm to aid westbound drivers to get home (from traffic that backs up to Kapolei) but now eastbound drivers are forced into one lane and traffic backs up for at least a mile if not more taking a minimum of 45 minutes to an hour to leave the Westside. Many of the teachers at the various schools now have given up tutoring time or extra-curricular activities to avoid the traffic mess.

In case of a natural disaster (tsunami warning), Farrington Hwy is closed by Department of Emergency Management at Honokai Hale. I personally was stuck in the "giant parking lot" that was Farrington Hwy and had to turn around and go to Makakilo to wait out the warning. Not fun with 2 small children in the car! We have had the same area closed due to flooding and school children who attend school off the Westside (Kamehameha Schools and other private schools) were stuck for hours on their school bus.

We have had hostage situations at Nānākuli Avenue and Farrington Hwy and no one could exit or enter the Westside until that situation was resolved (8 hours). We have had gas trucks catch on fire at St. Rita's Church (5 hours). Recently we had a water main break near St. Rita's Church and vehicular traffic had to be routed through Kalaniana'ole Beach Park. City busses and large trucks were stuck and couldn't access our area with necessary food and gasoline supplies.

The there were the two hurricanes, Iwa and Iniki which shut Farrington down totally for up to two weeks. Emergency services were able to open only one lane and we had staggered times we could enter/leave the coast.

Sad to say, road rage does occur and that often leads to accidents. At least once a week, Farrington is closed for accidents and while HPD investigates the scenes, drivers are forced to wait in their cars. This past week, March 6 to March 12, we had **six** major accidents that closed down various sections of Farrington Highway. Sad to say we also had **three** pedestrian related accidents — at least one of them was fatal.

In addition, our emergency vehicles are forced to sit in traffic while trying to either get to the scene of an accident or transport an injured person to a trauma center after being stabilized at our Waianae Coast Comprehensive Health Center. During peak traffic times, this is impossible.

Our current "Emergency Access Route" is woefully inadequate. As we learned **twice** last week, accidents happening on Farrington Hwy fronting Kamehameha School's Community Learning Center Nānākuli/Ka Waihona o ka Na'auao PCS, there is no emergency access route off our Westside from Lualualei Naval Road (prior to the accident scene). Once again, folks were unable to get to work/school and were "stranded" for over three hours.

I am urging everyone on this committee to **please support HB 1378 HD1** to appropriate the funds to the Department of Transportation (DOT) for planning and procurement for construction of secondary access route, a necessary and vital source for our Westside community.

Aloha,

I am writing in support of HB 1378 H D1 to help bring traffic relief for the Wai'anae Coast residents. I support the initiative to urge the Department of Transportation to design and plan, but most all, begin construction on a secondary access route for the leeward coast of Wai'anae.

I moved to Makaha in 1982 and resided here until 1992. I returned in 2006 and was appalled to see there had been little changes in the leeward coast infrastructure and highway over the 14 years I was away. Living in Makaha is like living in a cul-de-sac. One way in, one way out!

Not only is this concept a safety issue for the leeward coast residents, it is not in keeping with road construction and planning in the 21st century!

With the scarity of affordable homes on Oahu, the leeward coast population is growing. Adding to the traffic problems is the lack of jobs on the Wai'anae coast. Adding more homes and businesses in Kapolei is a double-edged sword. Although closer jobs are available to the leeward residents, motorists still must get in and out of Wai'anae to make a living. For those residents who have jobs past Kapolei, they must first fight to get in and out of Wai'anae and secondly fight the increased traffic on H-1. Since the rail starts in Kapolei, it will have little impact on reducing any day to day leeward coast traffic. Adding the new left hand turning lanes hopefully will help traffic to flow smoother. However, one traffic light outage, road construction/maintenance reducing a lane, vehicle breakdown, accident, or (the worst) a fatality, causes the entire coast to back up to Kalaeloa and beyond! This is unacceptable to motorists trying to reach their destinations.

A second access road will greatly improve the quality of lives of motorists of the leeward coast. I ask that this bill be passed so Wai'anae can be brought into the 21st century!

Comments: The concerns for needed transportation relief shared by residents of the Waianae coast have been exhausted and exacerbated for far too long. The question of needing an alternative means of transportation to service the Waianae coast is no longer uncertain. The people of West Oahu need resolve. It comes down to identifying a possible solution, funding its plan, design, and construction. I am in support of the intent of HB1378 HD1 Section 2.(a) "the department of transportation shall develop plans for construction of secondary access roads to serve as alternative routes to Farrington highway for travel within, into, and out of the Waianae district of Oahu. Plans shall include route maps, timelines for implementation, measures to avoid or mitigate disruption of access to currently available routes, and any other information the department deems necessary." However, I feel its intent is being met by an existing State of Hawaii Department of Transportation (HDOT) project proposal, "Farrington Highway (Route 93) Corridor Study," in reference to the department's Request for Proposal (RFP) Scope of Work Information document published November 30, 2016. Similar language relating to the plight of Waianae coast transportation issues, study objectives, and outcomes is shared both in the RFP as well as HB1378. Although, the RFP does not wait until the year 2030 to begin such plans. I stand on the previous written testimony of the State of Hawaii Department of Transportation. In fact, per the Oahu Metropolitan Planning Organization's (OahuMPO) Draft Transportation Improvement Program 2015-2018 Revision #15, the "Farrington Highway (Route 93) Corridor Study" intends to encumber a total of \$500,000, of which will comprise 80 percent federal funds and 20 percent local funds within FFY 2017.
