H.B. 1378 RELATING TO HIGHWAYS

House Committee on Transportation

The Department of Transportation (DOT) **supports the intent** of the bill. However, we feel this bill is unnecessary.

The DOT is currently in the procurement phase to conduct a corridor study of the Nanakuli, Maili, Waianae, and Makaha corridor. The scope of the study is to assess and provide recommendations to provide a second access into and out of the area, reducing congestion, increasing capacity, and improving safety. The study will also consider the following modes of transportation: freight, vehicular, transit, bike and pedestrian modes.

The DOT recommends this corridor study be completed for the purpose to leverage federal funds for the proposed projects identified in the study. The corridor study is estimated to take two years to complete.

I, Olivia M. Arana, support Bill HB1378 for the following reasons:

As one of the many Wai'anae residents who work in town (and has a son who attends high school in town), I have experienced this commute for 8 years now. When there are issues such a car accident, a car stall, pedestrian accidents, flooding, broken traffic lights and road work, we become trapped on Farrington Highway. With only one way in and one way out on Farrington Highway, having no emergency/secondary access road can cause us to be stranded in our cars for hours. In cases like this when traffic is at a standstill on Farrington, there is a domino effect in nearby Kapolei and H1 Campbell, with cars having to wait their turn to get into Nanakuli and beyond. It is pure ridiculousness.

Situations like these don't only cause us to be very emotionally frustrated, but mentally distraught as well. While we spend majority of our mornings and evenings in a long commute, it just kills us inside when we lose precious time with our families at home when we're stuck on the road. Aloha Chair Aquino and Vice Chair Quinlan and Committee Members:

My name is Gail Gomes and I am a forty plus year resident of the Wai'anae Coast. I am the editor of our local community newspaper, *Westside Stories*, however today I am submitting testimony as an individual.

I am requesting your support of **HB1378** to appropriate the funds to the Department of Transportation (DOT) for planning and procurement for construction of secondary access road or roads that will pass through the Westside of O'ahu (the moku of Wai'anae) and to serve as alternative routes to Farrington Highway for travel within, into, and out of the Westside. I would respectfully add that the bill be amended a bit from *"Waianae district" means the leeward coast of Oahu from Nanakuli to Kaena point that is enclosed by the leeward slopes of the Waianae mountain range* to **from Kapolei/Honokai Hale to Ka'ena Pt** as currently we are unable to access our Westside once we leave the Kapolei/Makakilo/Honokai Hale area.

For too long we have been "held hostage" by Farrington Highway. It doesn't seem to matter what day of the week it is, there is always traffic backed up for at least one half mile due to traffic lights. On weekdays, we now have a contra-flow lane from 3:30 to 6:30 pm to aid westbound drivers to get home (from traffic that backs up to Kapolei) but now eastbound drivers are forced into one lane and traffic backs up for at least a mile if not more taking a minimum of 45 minutes to an hour to leave the Westside. Many of the teachers at the various schools now have given up tutoring time or extra-curricular activities to avoid the traffic mess.

In case of a natural disaster (tsunami warning), Farrington Hwy is closed by Department of Emergency Management at Honokai Hale. I personally was stuck in the "giant parking lot" that was Farrington Hwy and had to turn around and go to Makakilo to wait out the warning. Not fun with 2 children in the car! We have had the same area closed due to flooding and school children who attend school off the Westside (Kamehameha Schools and other private schools) were stuck for hours on their school bus.

We have had hostage situations at Nānākuli Avenue and Farrington Hwy and no one could exit or enter the Westside until that situation was resolved (8 hours). We have had gas trucks catch on fire at St. Rita's Church (5 hours). Recently we had a water main break near St. Rita's Church and vehicular traffic had to be routed through Kalaniana'ole Beach Park. City busses and large trucks were stuck and couldn't access our area with necessary food and gasoline supplies. The there were the two hurricanes, Iwa and Iniki which shut Farrington down totally for up to two weeks. Emergency services were able to open only one lane and we had staggered times we could enter/leave the coast.

Sad to say, road rage does occur and that often leads to accidents. At least once a week, Farrington is closed for accidents and while HPD investigates the scenes, drivers are forced to wait in their cars.

In addition, our emergency vehicles are forced to sit in traffic while trying to either get to the scene of an accident or transport an injured person to a trauma center after being stabilized at our Waianae Coast Comprehensive Health Center. During peak traffic times, this is impossible.

I am urging everyone on this committee to **please support HB 1378** to appropriate the funds to the Department of Transportation (DOT) for planning and procurement for construction of secondary access, a necessary and vital source for our Westside community.
