DEPARTMENT'S POSITION: The Department of Human Services (DHS) supports the measure.

<u>PURPOSE</u>: The purpose of the bill is to authorize the Department of Health to allow two private-pay individuals to be cared for in the same community care foster family home if certain requirements are met.

Community Care Foster Family Homes (CCFFH) were created specifically for the Medicaid program for low-income recipients. CCFFH is an integral part of the long term care continuum of care for the Medicaid program and provides a less restrictive community-based home for Medicaid recipients who are at a nursing facility level of care. CCFFH allow recipients to remain in the community rather than go into a nursing facility, which is a major national goal and the personal preference for many individuals and families.

Currently, CCFFHs are licensed for two residents and may request for a third bed. One of the residents may be private-pay. Also, in order to obtain the third bed, it must be for a Medicaid recipient. This bill would permit the Department of Health to allow two private pay residents and only one Medicaid recipient if the enumerated conditions of the proposed part (1) (B) are met. While currently, DHS does not anticipate a high number of individuals to seek this accommodation, a change in law may influence a change in behavior that was not anticipated at the time of the law's passage.

DHS notes that with this change, there remains some potential of reduced CCFFH beds for Medicaid recipients, which, in certain communities, could result in individuals having to remain for longer periods of time in an acute hospital bed until a community-based bed becomes available, or going into a more costly nursing facility. None the less, we believe the bill provides for sufficient protections in order to mitigate this risk.

Comments: We supported this bill last year as a humanitarian attempt to assist a particular elderly couple that wished to reside together. We were disheartened by the rigidity and lack of compassion demonstrated by the Department of Health and the Department of Human Services. The arguments they put forth made no sense at all. That individual case aside, this bill makes perfect sense as a matter of public policy in general. These isolated situations of married couples seeking to live together are few and rare and will do nothing to disrupt the Medicaid system or alter the number of beds that are available. For that reason, we hope that the Legislature will direct the Departments to allow these scenarios under reasonable parameters. While we welcome the support of the Departments for this HD1 version, we do think that some of the conditions required in the bill are too open ended and difficult to measure or enforce. Yet, this certainly is a step in a good direction.

Dear Chair Nishimoto, Vice Chair Buenaventura and Members of the Committees:

We **strongly support HB1396**, which allows for two private-pay clients in a Community Care Foster Family Home (foster homes) where the specified circumstances are met. This issue has been ongoing for years as manifested in many legislative bills and even lawsuits. This problem will continue and get even worse. There is obviously a failure in the system to address this problem, so it's time for a change to be made.

Medicaid clients will continue to have a place in our homes and will continue to be first priority. **There are a lot of vacancies in CCFFH homes.** Medicaid clients will not be turned away as there is sufficient capacity. There is no shortage of space for Medicaid clients in our program, but the inflexible rule of having only one private-pay client is often detrimental to non-Medicaid clients.

Indeed, the heart of the foster home program is the family. We take the elderly and disabled into our home and make them a part of our family. A sense of being part of a family is vital to any human being. Although we count our clients as part of our own family living in the home where we live, some clients would do even better if they could bring their own family into the home.

Clients who are separated from their own family often suffer severe trauma and depression. Outcomes would improve if they were able to live with their own family members like their spouse. Imagine being in a loving marriage or relationship for 50 years and then suddenly being separated. We want to admit clients who will fit well with our clients for their own well-being.

Private-pay clients need care just as everyone else. They should have a right to remain in our home if it is their free choice and the choice of their family. They deserve to be treated with dignity and have their choices respected.

For these reasons, we strongly support HB 1396.

This will only happen if both the department of health works with department of human services, reviews all other options for the privte pay couple and after checking with the State Attorney General's office finds this rare exception is proper and legal. This will also assure the State will not lose Medicaid funding from the federal government. Finally, if this bill becomes law, the current lawsuit by the Kawamoto family should be dismissed against the State of Hawaii, because they will no longer have standing, because the new law will allow the Kawamoto husband and wife to lawfully reside in the same comunity care foster family home together. In the end this will be a win-win for the Legislature, because they no longer have to draft legislation again for similar cases in the future, the department of health with work with the department of human services to ensure the integrity of the Medicaid care homes are not violating any Federal Law should they decide and agree in rare cases to allow for two private pay couples in a "marriage or civil union", and the Attorney General's office will review the case to ensure no violation of the Medicaid rules to ensure continued Federal funding of Medicaid for the State Medicaid system and clients in Hawaii. Good morning chair, vice chair & the committees, my name is **Elma Velasco Tierra**, owner of Eltierra Adult Foster Care. I strongly support **HB1396** because this is another version of SB190 in 2009 & was sunset in 2011.

In 2009 we had a patient named **Sidney Kaide**, he was a private pay. After 5 years his wife **Terry Kaide** had a back surgery so she could not take care herself anymore. At this point she wanted to join her husband in the same community care foster home. But the problem is she is not allowed because we, CCFFH can only have one private pay. When SB190 was introduced in 2009 the family worked hard to help passed the bill. The hardships that they went through was physically and emotionally draining. **Terry Kaide** in a wheelchair flew from Hilo to the State capitol wherever there was a hearing until the bill was passed. When Terry came to visit her husband from another adult foster home she said to her husband (bed bound) holding his hands, "we work hard for our savings thinking that when we get old we have money to support ourselves... and now we are being punished by the law for being able to pay for our care.. We are not asking money at this point, just to be together for the last days of our lives. Sixty three years we are together...it's hard for me to understand why there is such a law that separate us when we get old".

In April 2009, **Gov. Lingle** SB190 signed into law and she said "it ends an injustice for one family and it brings hope to families who may find themselves in a similar situation. It is about real people and their lives together"... While the governor was signing the bill **Terry Kaide** watched from her wheelchair and said "I'm so happy I feel great so now we don't have to get permission to live together". We are free.

The SB190 after signing into law sunset in two years. The promises were gone!

In closing I sincerely ask to support the intent of **HB61396** that will give equality and justice for elderly, likes the Kaides once enjoyed.
