Mahalo Legislators for your support of state funding for Hawaii's commemoration of the Centennial of World War One.

The WWI Centennial is a global event with Europe already well into their observances beginning in 2014. The US involvement and Hawaii's direct tie to the Great War was triggered with the April 2, 1917 sinking of a merchant marine ship, the USS Aztec. Five Hawaii residents were aboard that ship. Four days later, congress authorized the declaration of war. More than 10,000 from Hawaii would end up volunteering to serve in WWI. The civilian contributions included bandage rolling at Iolani Palace and much more. We are determined to share Hawaii's WWI history.

The national World War One Centennial Commission in Washington, DC is coordinating efforts in every state to honor the nation's contributions to that war effort and sacrifices made.

To that end, Governor Ige's task force has developed a public education and events plan for a commemoration period that runs from April 2, 2017 to the 100th anniversary of the armistice that brought the war to an end on November 11, 1918 (what we now know in the US as Veterans Day).
