The Department of Business, Economic Development & Tourism (DBEDT) supports the intent and offers comments on HB 1481, which would require DBEDT to establish a working group to study the uses of and the best practices regarding "blockchain technology".

DBEDT appreciates the need to defend against cyber-attacks in order to protect Hawaii's businesses. DBEDT recognizes the potential for blockchain technology to improve public and private sector resiliency.

With a possible 14 to 28 members in this working group, DBEDT will need additional staff to manage the scope of work:

- 1) Study the uses of blockchain technology;
- 2) Develop curriculum and training methods;
- Promote best practices for enabling blockchain technology to benefit local businesses and residents.

DBEDT requests an appropriation of \$100,000, provided it does not displace our priorities in the Executive Budget.

Comments: Have you ever sent a payment or made a transfer where the money left your account and disappeared for a few days before finally reaching the recipient? This is just one simple case where Bitcoin would be able to securely remove the processing time. All of ways that you can think of transmitting money, Bitcoin could improve that process. As far reaching as Bitcoin applications are, the underlying technology, the blockchain, has the potential to be even more revolutionary across multiple industries.
