in consideration of HB 1543 RELATING TO ENERGY TRAINING.

Chair Lee, Vice Chair Lowen, and Members of the Committee.

The Department of Business, Economic Development and Tourism (DBEDT) opposes HB1543 which requires DBEDT to establish an optional energy training course for state and county employees responsible for permitting, inspecting, licensing, and approving construction projects that contain renewable energy systems and related technology.

DBEDT is not equipped with the appropriate human and financial resources to develop the curriculum required by this measure. However, DBEDT is open to providing feedback to the appropriate agencies on energy matters that would aid them in developing energy related training. It is our opinion that such assistance from DBEDT would not require legislative action.

Dear Chair, Vice Chair and Committee Members:

The International Code Council (ICC) is a 58,000 member, non-profit public benefit corporation dedicated to helping the building safety community and construction industry provide safe, sustainable, energy-efficient and affordable construction through the development of codes and standards used in the design, building and compliance process by state and local governments including the State of Hawaii and its Counties.

The Hawaii State Building Code Council (SBCC) has recently passed approval of the 2015 International Energy Conservation Code (IECC) which is up for final adoption by the state and the Hawaiian Counties. The 2015 IECC is an up-to-date energy efficiency code which has been reviewed and modified by the Hawaii State Building Code Council in partnership with the Hawaii State Energy Office in order to meet the unique energy efficiency needs of Hawaii and the energy policy goals as set by the Hawaii Legislature. Clearly the goal is to have 100% renewable energy sources by 2031.

HB 1543 charges the Department of Business, Economic Development and Tourism, the (Hawaii State Energy Office) with the task to provide training courses to state and county officials involved with permitting and inspecting and approval of energy systems technologies and approve compliance with adopted state and local energy efficiency code requirements.

The ICC endorses the training objectives in the bill. In order for the state to meet its energy policy goals, training is needed for state and local code officials and approving authorities so they are most familiar with the newest energy system technologies and energy efficiency code provisions. The ICC encourages the legislature to identify a funding source so the charge given to the Hawaii State Energy Office to provide training can be realized.

ICC strongly supports and urges passage of HB 1543 because an adequately funded training effort will help to accomplish the goals of the legislature.

Aloha Chair Lee, Vice Chair Lowen, and members of the Committee,

On behalf of the Distributed Energy Resources Council of Hawaii ("DER Council"), I would like to testify in strong support for HB 1543 which requires DBEDT to establish an optional training course for state and county employees responsible for permitting, inspecting, licensing and approving construction projects that contain renewable energy systems and related technology.

The DER Council is a nonprofit trade organization formed to assist with the development of distributed energy resources and smart grid technologies which will support an affordable, reliable, and sustainable energy supply for Hawaii.

In the last few years, the renewable energy industry has been undergoing a rapid technological evolution. Both the components of renewable energy installations and the configurations of the installations have continued to evolve, and inspectors and plan checkers need to be informed and up to date to do their jobs. They are expected to understand a very wide variety of system and component variables ranging from smart inverters, AC and DC configurations, various battery chemistries, fire safety and enforcement protocol, and the many battery management systems that ensure safe and efficient operation of systems that include battery energy storage, just to name a few.

Unfortunately, there is no formal or ongoing means in place by which inspectors and plan checkers who work for the state and county can learn about the ongoing changes in the renewable energy industry. This means that state and county employees have different levels of understanding about renewable energy installations, resulting at times in the inconsistent application of the rules and an inefficient process where plans and inspections can be greatly delayed if the installation has unfamiliar technology

The state and county employees who work to ensure that renewable energy installations are safe and properly designed and installed should be given the option of trainings in renewable energy so that they can get the information that they need. We urge this committee to support HB 1543.
