### In consideration of **HOUSE BILL 1570** RELATING TO THE ENVIRONMENT

House Bill 1570 proposes to require lessors of rental motor vehicles to include an option to the lessee in the motor vehicle arrangement to contribute a sum to the Department of Land and Natural Resources (Department) for the preservation and protection of the environment. The Department supports this bill to supplement funding for programs that protect Hawaii's world-renown beauty and the natural resources needed to sustain the visitor industry.

Check-offs are used in 36 states to provide funding for conservation programs. The funds receiving check-offs support a variety of critical natural area protection and land acquisition programs.

The visitor industry clearly relies on natural resources. The Koolau Forest Watershed on Oahu is estimated to provide a net present value of \$1-3 billion for ecotourism alone. ii Forests prevent erosion that muddies beaches, coral reefs, and fisheries. Forests also mitigate climate change effects from rental vehicles by absorbing greenhouse gases. Protection sustains the native plants and animals unique to our islands and important to the Hawaiian culture.

The Land Conservation Fund (LCF) supports the Legacy Land Conservation Program (LLCP). The LLCP protects rare and unique cultural, natural, agricultural, and recreational resources from destruction by funding the acquisition of fee title or conservation easements by nonprofits, counties, and state agencies.

The Office of Hawaiian Affairs (OHA) Beneficiary Advocacy and Empowerment Committee will recommend that the Board of Trustees <u>SUPPORT</u> H1B570, which will allow Hawai'i's visitors to voluntarily contribute towards the maintenance and conservation of our natural and cultural resources.

Numerous studies in Hawai'i and abroad have indicated that visitors to areas of natural beauty and importance are often more than willing to contribute financially to maintaining the environmental quality of these areas. Given the prominence of our natural environment as a tourism driver, these "user fee" studies therefore indicate the existence of a currently untapped revenue source for natural resource protection, i.e. visitors who may be willing to contribute financially to the environment they travel thousands of miles to enjoy.

By allowing visitors to voluntarily contribute to our natural environment at the time of their visit, this measure will allow the state to tap into a substantial potential revenue stream for the protection and conservation of our islands' resources. Given the clear need for greater financial investment in our watersheds, coastlines, and other natural and cultural resources, and given the growing strain placed on these resources by the visitor industry, this measure thus provides much-needed revenues from an appropriate source of funds, without burdening taxpayers or our existing tourism industry. In addition, visitors who contribute funds under this measure will know that they played a part in protecting the natural resources and environmental integrity of our island home.

Therefore, the OHA urges the Committee to <u>PASS</u> HB1570. Mahalo for the opportunity to testify on this measure.

Dear Chair Lee and Members of the Committee on Energy and Environmental Protection:

We submit this testimony on behalf of Enterprise Holdings, which includes Enterprise Rent-A-Car, Alamo Rent-A-Car, National Car Rental, Enterprise CarShare and Enterprise RideShare (Van Pool).

Enterprise **opposes** H.B. 1570 which requires lessors of rental motor vehicles to include an option to the lessee in the motor vehicle agreement to contribute a sum to the Department of Land and Natural Resources for the preservation and protection of the environment beginning July 1, 2019.

Enterprise already offers a voluntary contribution for research to offset carbon emissions on each contract. The details are available on a website we identify for our renters. We do not feel that it is appropriate for the state to require rental car companies to include the voluntary contribution provided for in H.B.1570. Rather, this should be left to each individual company. As it is, the state already collects from rental car customers substantial sums of money to be used for state purposes. We do not feel that it is justified to solicit additional contributions from renters, and feel that it will alienate our customers.

The Hawaiian Islands Land Trust ("HILT") is a nationally accredited, 501(c)(3) non-profit organization that protects over 17,500 acres of land in Hawai'i with scenic views, agricultural resources, wildlife habitats, water resource areas, cultural and historical values, and outdoor recreation opportunities. Established in 2011 as a statewide consolidation of smaller land trusts on each of the major islands, HILT complements the stewardship others are providing for mountaintop watersheds by concentrating largely on needs and opportunities for coastal and agricultural lands. The importance of these lands stems from the fact that they are rich in cultural values and often under the greatest threat of development.

To connect people in beneficial ways to these precious landscapes, HILT fosters public appreciation and stewardship of strategically situated HILT owned preserves throughout the Hawaiian Islands. HILT also holds and monitors perpetual conservation easements, HILT's primary conservation tool, to assist owners who wish to ensure long-term protection of lands with high conservation values.

HILT supports HB 1570 to provide the opportunity for persons renting cars in Hawaii to make a voluntary contribution toward the protection of the State's unique environment, which is a critical component of our tourism-based economy.

Many unique and environmentally and culturally significant lands in Hawaii have been protected through the legacy land fund that benefit both residents and visitors.

The additional funding made available to the land conservation fund through voluntary contributions provided by this bill would allow for the protection and enhancement of unique and special landscapes in Hawaii, some of which may not have been protected in the past due to limited funding. These funds and projects enhance the quality of life for residents and those visiting Hawaii and ensure that those places that make Hawaii unique and special and preserved and enhanced for future generations.

Aloha Chairman Lee and members of the Energy and Environmental Protection Committee,

The Sierra Club of Hawai'i strongly supports HB 1570, which seeks to add an option on rental car contracts for lessees to add a voluntary donation to DLNR to support conservation and management of legacy lands.

We have 20,000 members and supporters throughout the Hawaiian Islands. Since 1968, the Sierra Club of Hawai'i has been working to protect the unique natural and cultural resources of our islands.

DLNR manages over 1.3 million acres of state land, including 750 miles of coastline.<sup>1</sup> This land includes water resources, the habitat of many endangered species, public recreation areas, and forest reserves. The Club agrees that DLNR would benefit from extra funding to help the agency protect the State's land, coastal areas, and natural resources for the sake of residents, guests, and future generations.

Including a checkbox on car rental agreements to provide an optional donation to DLNR is an uncontroversial way to raise more funding. Travelers visiting Hawai'i to enjoy the unique natural resources of the islands will likely be willing to voluntarily donate to the protection and maintenance of our environment.
