Testimony by Navy Region Hawaii

Chair Nishimoto, Vice-Chair San Buenaventura, and Representatives,

Although Navy Region Hawaii most certainly does not oppose the intent of this bill, it does wish to clarify one statement at the end of Section 1's second paragraph, and asks that this statement be modified accordingly. That statement reads in relevant part "In Hawaii, cesspools and leaking underground fuel tanks have begun to contaminate fresh water resources, and significant potential for further contamination remains."

To the extent that this could possibly refer to the Navy's Red Hill Bulk Fuel Facility, the Committee should know that the Facility's fuel tanks pass tank tightness testing since biannual testing began in 2008. The Navy has since gone to annual testing and the most recent test was just completed on Feb. 2, 2017. Each tank passed this test, once again demonstrating that <u>there</u> are no leaking tanks at Red Hill. This test, conducted over a 5 day period for each tank, confirms the tanks are within industry standard.

There was a release of fuel from one tank in January 2014, but United States Environmental Protection Agency (EPA) addressed the issue of effects on drinking water in an on-the-record statement made during the first Legislative Red Hill Task Force meeting held on Oct. 6, 2016. From the official record of that meeting, EPA expert Steve Linder said "we think it's very unlikely that that contamination, that mass – from the tanks would get anywhere near the Board of Water Supply Wells."

Since 2006, the Department of Defense invested more than \$200 million to continue modernizing Red Hill and to conduct environmental testing. Chair Nishimoto and Members of the Committee:

The Department of the Attorney General appreciates the intent of this bill and submits these comments.

This bill proposes an amendment to article I, section 2 of the Hawaii State Constitution to include access to clean drinking water, meaningful health care, and a quality education as inalienable rights of all people.

While access to clean drinking water, meaningful health care, and a quality education are indisputably important goals that the State should aspire to, ample state and federal laws already exist to protect access to them. This bill is not merely an affirmation of individual rights. See section 1, lines 8 to 14, on page 3. We advise the committee that elevating these goals to the level of inalienable rights under the State Constitution may have unintended consequences that could lead to litigation against the State.

We are happy to work with the legislature over the course of the session as this bill progresses to try to find appropriate wording that might address this issue.

SUBJECT: House Bill 1582: Proposing an Amendment to Article I, Section 2 of the Hawaii State Constitution to Include Access to Clean Drinking Water, Education and Health Care Among the Inherent and Inalienable Rights of Individuals

We strongly support House Bill 1582. This bill proposes the Hawaii State Constitution be amended to include access to clean drinking water, meaningful health care and quality education be among the inherent and inalienable rights of individuals of our state. As a steward of our drinking water, we strongly support the right to clean drinking water and to protect the source of this water – Oahu's irreplaceable groundwater aquifer.

Since at least 2005, groundwater samples from under and around a Navy owned underground fuel facility in Halawa Valley show the presence of various petroleum contaminants are present in the groundwater. Although the sampling conducted to date indicates that water provided by public water systems remains compliant with standards for safe drinking water, the results of the Navy's investigation make clear that fuel released from the facility has impacted the very groundwater aquifers that sustain Honolulu's drinking water supply. Unfortunately, little corrective action has taken place in the ensuing decade to clean up these conditions and, as a result, the significant fuel releases from the facility continue to impact this vital source of drinking water.

Article XI, Section 1 of the Hawaii State Constitution requires that, "[f]or the benefit of present and future generations, the State and its political subdivisions shall protect and conserve ... all natural resources, including ... water ... and shall promote the development and utilization of these resources ... in a manner consistent with their conservation". The constitution further declares in Article XI, Section 7 that "[a]II public natural resources are held in trust for the benefit of the people." and "The State has an obligation to protect, control and regulate the use of Hawaii's water resources for the benefit of its people.". The Supreme Court of Hawaii has concluded that this constitutional mandate "encompasses a duty to promote the reasonable and beneficial use of water resources in order to maximize their social and economic benefits to the people of this state" and, moreover, this responsibility is "unlimited by

any surface-ground distinction," extending to all water resources, including groundwater. In re Water Use Permit Applications, 94 Haw. 97, 133-135, 139 (2000).

House Bill 1592 upholds the right to clean drinking water and affirms the constitutional mandate that this water be protected and held in trust for the benefit of the people. We cannot over emphasize the significance and importance of this bill and urge your passage of this measure.
