In consideration of HOUSE BILL 1589 RELATING TO HUNTING SAFETY

House Bill 1589 proposes to authorize civilians to use firearm noise suppressors while hunting. The Department of Land and Natural Resources (Department) acknowledges the intent of the measure and offers the following comments.

The stated purpose of the bill is to "improve the safety of hunters in Hawaii." Current language in the bill identifies the risk of damage or hearing loss as a reason for allowing firearms noise suppressors to be used for hunting. The Department concurs that hunter safety is paramount and a worthwhile cause; however, suppressors may not be the most effective solution to preventing hearing loss.

Due to the various calibers and types of firearms, the reduction in noise levels with the use of suppressors is variable. A much more cost effective and user friendly solution is the use of conventional hearing protection such as earmuffs or ear plugs. Many products offer the added value of enhanced hearing via the use of battery powered technology. These are standard when using range facilities along with adequate eye protection. Traditional hearing devices have been used for many years without the need to train the individual on proper use and fit. The bill recognizes these items are readily available and help reduce exposure to the dangerous noise levels associated with gunshots.

The use of suppressors would require adherence to federal law and also require the tracking and registering of those devices. This may place additional burdens on local law enforcement or additional steps for the ethical hunter to remain in compliance.

SUBJECT: House Bill No. 1589, Relating to Hunting Safety

I am David Nilsen, Acting Major of the Records and Identification Division of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD opposes House Bill No. 1589, Relating to Hunting Safety.

This bill proposes changes to various sections of Chapter 134 of the Hawaii Revised Statutes to allow the use of noise suppressors or silencers by hunters. This bill also authorizes the manufacture and sale of noise suppressors or silencers in the state of Hawaii. The HPD does not agree that the use of firearms in the act of hunting poses a threat to the hearing of the hunter. The number of rounds fired by a hunter while engaged in the hunt will not be significant enough to endanger the hunter's hearing. The HPD believes that allowing noise suppressors or silencers to be legally obtained in the state of Hawaii will only make their use in the commission of criminal acts more common. Having these dangerous items readily available will only potentially increase gun violence.

The HPD strongly urges you to oppose this bill.

My name is Audrey Takamine, committee chair for the Government Affairs committee with the Japanese Chamber of Commerce & Industry of Hawai'i (JCCIH). The Japanese Chamber of Commerce & Industry of Hawai'i has been incorporated since 1951 and represent 290 members of the business community. I would like to testify in **strong support of HB1479 HD1** which establishes the Hilo community economic district located in East Hawaii and places it under jurisdiction of the Hawaii community development authority. Establishes the Hilo community economic revolving fund. Requires all revenue, income, and receipts of HCDA for the district to be deposited in the Hilo community economic revolving fund, and a designated per cent to be transferred to the special land and development fund under the department of land and natural resources.

In 1976 the Legislature created the HCDA to revitalize urban areas that were underused and deteriorating. The establishment of the Hilo community economic district would serve to accomplish this very task in the Hilo area. We are faced with many challenges. Written Testimony to the House Water and Land Committee House Bill 1589: Relating to Hunting Safety February 9, 2017

Chairman Yamane, Vice-Chair Kong, and members of the Committee:

My name is Knox Williams. I am the President and Executive Director of the American Suppressor Association, a non-profit trade association which represents the suppressor community. I am writing in regards to House Bill 1589, which seeks to legalize the possession of suppressors, and their use while hunting in Hawaii. Suppressors are currently legal to own in 42 states, 40 of which allow their use while hunting.

For most people, suppressors are known only as silencers, and the only time they have seen them in use is on the silver screen. Although entertaining, Hollywood's depiction of suppressors does not have any basis in reality, giving people an understandably false expectation for what suppressors actually do.

The terms "silencer" and "suppressor" refer to the same thing – a muffler for a firearm. In order to understand suppressors, it is important to note that nothing can actually silence the noise of a gunshot. Physics will simply not allow it. On average, suppressors reduce the noise of a gunshot by 20 - 35 decibels (dB), roughly the same sound reduction as earplugs or earmuffs. They work in the exact same way as mufflers on cars, which function by trapping the hot expanding gasses and allowing them to slowly cool, thereby reducing the noise to safer levels.

Even the most effective suppressors on the market, on the smallest and quietest calibers, like .22 LR, reduce the peak sound level of a gunshot to around 110 - 120 decibels. To put that in perspective, according to the National Institute for Occupational Safety and Health (NIOSH), that is as loud as a jackhammer (110 dB) or an ambulance siren (120 dB).

In a 2011 study, entitled "Noise and Lead Exposures at an Outdoor Firing Range – California", the Centers for Disease Control and Prevention (CDC) stated, "The only potentially effective noise control method to reduce students' or instructors' noise exposure from gunfire is through the use of noise suppressors that can be attached to the end of the gun barrel. However, some states do not permit civilians to use suppressors on firearms."

In a similar study from 2014 on noise exposure at shooting ranges, NIOSH recommended, "If feasible and legally permissible, attach noise suppressors to firearms to reduce peak sound pressure levels."



These studies recommend suppressor use at ranges, where people generally wear hearing protection. However, hunters almost never wear them, because traditional hearing protection devices hinder their ability to hear their surroundings. In the field, it can mean the difference between a successful and an unsuccessful hunt. The "it's only one shot" mentality is exactly why most hunters ultimately have to wear hearing aids. By supporting this legislation, you are doing your part to give hunters in Hawaii the option to use suppressors, ensuring that future generations will no longer have to choose between their passion and their hearing. In addition to hearing protection, suppressors also mitigate noise complaints from those who live near shooting ranges and hunting lands.

In 2013, Montana Governor Steve Bullock held the common misconception that suppressors could silence a firearm, which led him to veto suppressor hunting legislation in his state. However, once he became properly educated on the issue, he reversed course and urged the Montana legislature to legalize their use in the field. In a letter to the Speaker of the House from March, 2015, he wrote:

"The public perception of suppressors as the same thing as silencers, where the assassin quietly dispatches his victim, no longer holds true. Suppressors mitigate the sound of a shot, but do not silence it. The use of suppressors for hunting, when hunters cannot wear ear protection because they need to be aware of their surroundings, can help protect against hearing loss. This is especially true for our younger hunters, even those who are not actually hunting but are accompanying their parent in the field.

I understand the concerns regarding the risks of increased poaching and do not take this lightly, but other states have not found this to be the case."

Gov. Bullock's change of opinion wasn't ideological, it was educational. Should you be interested, we are happy to host a suppressor demonstration at the time and place of your choosing. Thank you for your time and consideration. On behalf of hunters and sportsmen and women in Hawaii, I respectfully urge you to vote in support of H.B. 1589.

Gay & Robinson currently hunts feral goats and pigs on its property as part of its eradication program to protect crops of its farming tenants from damage and loss. Both goats and pigs do enormous damage to the crops and proliferate due to the difficulty in targeting and eliminating these invasive pests. They come down from and retreat to the mountain which is difficult for our hunters to access due to the terrain. They also do damage to fauna and native plants in the mountain.

The use of a silencer will help to increase out kill ratio and create a higher success rate in eliminating these pests. The loud noise by a rifle will cause any of these animals nearby our first target to scatter and get away before multiple kills can be made. The use of the silencer will help us achieve multiple kills.

We also use a rifle for our slaughter operation at Makaweli Meat Company. Use of a silencer will allow us to keep the other animals in waiting from being spooked and creating adrenaline in the animal which degrades the quality of the meat. This will create a more humane treatment during the slaughter process. By eliminating the loud noise, it will also avoid hearing damage by our shooters in the slaughter process. The loud noise can also be somewhat unnerving to other employees nearby.

HOUSE BILL 1589 – SOUND SUPPRESSORS FOR HUNTING – SUPPORT

As the trade association for America's firearms, ammunition, hunting, and recreational shooting sports industry, the National Shooting Sports Foundation ("NSSF") seeks to promote, protect, and preserve hunting and the shooting sports. NSSF has a membership of more than 12,000 manufacturers, distributors, firearms retailers, shooting ranges, and sportsmen's organizations. Our manufacturer members make the firearms used by law-abiding Hawaii sportsmen and women, the U.S. military, and law enforcement agencies throughout the state.

On behalf of NSSF, I would like to express our support for House Bill 1589 ("HB 1589"), a proposal to legalize the ownership, possession, and use of suppressors for hunting in The Aloha State.

Firearm suppressors, or "silencers" as they are sometimes called, are devices which help reduce the noise of gunfire to hearing safe levels when attached to the end of a firearm's barrel. Suppressors are generally nothing more than containment systems with a series of baffles which help contain and re-direct the expanding gasses that exit the end of the firearm's barrel when it is discharged. Using suppressors can make shooting safer, more enjoyable and also help make shooting ranges and hunting lands more neighborly.

The ownership and possession of firearm suppressors is currently legal in 42 states and 40 states allow suppressors to be used for hunting. Firearm suppressors have many practical benefits for civilians. One of the "ten commandments" of firearm safety is for shooters to wear eye and ear protection. A suppressor solves the need for ear protection for shooters who would normally be affected by the noise of the gun shot. This makes for more effective firearms training. Without ear plugs, all shooters will be able to communicate without shouting at each other and hear and comply with instructions and range safety commands easier. One of the gun's loud report and recoil. This anticipation causes shooters to "flinch" before the gun even goes off, to

experience slight tremors in the hand from nervousness, and even to close their eyes or blink right before they pull the trigger. All of these issues cause the gun to move from the intended target area. The use of suppressors will dramatically increase accuracy because of the reduced muzzle report, reduced recoil, and decreased muzzle flip, all making for a more ethical hunt.

Noise Induced Hearing Loss is a serious threat to our men and women in the military and law enforcement communities. The ability to hear is crucial to the performance of their duties. Many people have received medical retirement because of Noise Induced Hearing Loss. Much of this hearing loss occurs due to repeated exposure to gunfire, both operationally and in the training environment. According to the National Institute for Occupational Safety and Health (NIOSH), any exposure to noise over 140db causes immediate and irreparable hearing loss. Unsuppressed handguns and rifles generally create a muzzle report well above this threshold. Gunfire noise is a "preventable" occupational risk and an unnecessary liability. A suppressor can protect against hearing loss, allowing for a safer and more enjoyable shooting or hunting experience.

NSSF supports all efforts to remove restrictions on the use of suppressors for recreational use and hunting, and it is for these reasons NSSF supports HB 1589.

TESTIMONY IN FAVOR OF HB 1589

For the use of silenced firearms in the harvesting of animals Submitted by Bruce B. Robinson, Niihau Ranch Partner To: Rep. Yamane Chairman, Water & Land

Niihau Ranch is currently engaged in the commercial harvesting of eland on the island of Niihau. Eland is the largest species of antelope with big bulls weighing up to two thousand pounds. The harvesting of these large animals requires a large caliber rifle using a magnum load to ensure a clean and humane taking of the animal.

On Niihau we use the Remington 700 Ultra Magnum in the .375 caliber which is very efficient and achieves the excellent results. Unfortunately, this rifle has a deafening muzzle blast which is very hard on the shooter's ears. This requires the use of ear protection by the shooter which is a safety issue as the shooter is prevented from hearing safety instructions or nearby animals. The use of a noise suppression device would mitigate this problem.

Furthermore, the loud muzzle blast of the rifles makes multiple takings very difficult as the first shot spooks the rest of the herd. When harvesting the animals for commercial use, the United States Department of Agriculture (USDA) inspectors who accompany the shooter require that all animals be harvested with a head shot. A silencer on a rifle with a loud muzzle blast improves accuracy.

Commercial harvesting of wild animals should be done as quietly as possible to eliminate the release of adrenaline into the animal's body which causes a gamey flavor in the meat. The less noise, the more humane the harvest and the tastier the meat.

The use of a silenced firearm will allow the shooter to better select the right animals to harvest as the herd will be calmer. The reduction of muzzle blast will also result in the most humane harvesting possible because the animals will not be agitated and will probably be harvested without foreknowledge.

This legislation should also be expanded to cover slaughter houses. The use of silenced firearms in slaughter facilities will reduce the level of agitation in the animals and result in a more humane operation.

The use of silenced firearms in commercial slaughter facilities will afford greater hearing protection for workers and less disturbance to any neighbors.

In summary, I urge passage of legislation for the use of silenced firearms in commercial slaughter operations for the following reasons:

- 1. Safety and health of workers
- 2. More humane harvesting of animals.
- 3. Better quality of meat harvested.
- 4. Improved herd health due to better controlled harvesting of animals.
- 5. More economical operation.
- 6. Improved accuracy of the shooter.
- 7. Improved community relations

I am writing in support of HB 1589 and ask that you pass this very important bill.

Many long-time hunters suffer from hearing deficits caused by prolonged exposure to gunshots. The ability to use noise suppressors would greatly reduce this exposure and therefore the risk of premature hearing problems.

Contrary to popular belief, noise suppressors use in crime is virtually non-existent and currently they are legal in 42 states. Hawaii and California are the only two states west of the Mississippi where suppressors are illegal by state law.

Despite some concern over illegal hunting using suppressors, states that allow them during hunting have not reported any increase in these activities.

A recently released White paper from the Bureau of Alcohol, Tobacco, Firearms, and Explosives, suggests taking suppressors off the controlled items list under the National Firearms Act of 1934. This fact alone should indicate how reasonable and important allowing suppressor use during hunting is for the health and safety of hunters.

I would humbly request that the inclusion of a threaded barrel that accepts the attachment of a suppressor be removed from the proposed definition of an "Assault pistol" because many handguns used for hunting are large and heavy. As such, a pistol weighing more than 50 ounces, or exceeded 12 inches in length that included said threaded barrel would therefore be classified as an "assault pistol" and thus illegal.

For these, and many other reasons, I strongly urge you to support and pass HB 1589.

Committee Chair, Vice Chair, and Members,

Please pass HB 1589 and help move Hawaii into the 21st century and join the 42 other states that already recognize the rational, logical, and evidence-based reasons and data and thus have legalized the ownership of firearm sound suppressors by citizens. There is no reason that Hawaii citizens should have to bear the negative consequences of using unsuppressed firearms for hunting.

Below I list some of the benefits of suppressors, as well as counter some of the myths about suppressors being used as crime tools. Hawaii citizens deserve the right to benefit from the use of suppressors while hunting.

In many European countries, which "gun control" groups... I mean "commonsense gun safety" groups... I mean "gun violence prevention" groups hold up as sparkling models of a well disarmed citizenry, NOT using a suppressor is considered "rude". Some countries actually mandate that they be used, at least in certain vicinities that are relatively populated and would be "disturbed" by louder sounds.

Of course, suppressors are not "silencers", as they are often portrayed to be in Hollywood movies. On average, suppressors reduce the noise of a gunshot by 20-35 decibels, roughly the same sound reduction as earplugs or earmuffs. A shot from a 9 mm pistol equipped with a silencer is about as loud as a thunderclap for the person firing the firearm. These tools do NOT allow for someone to discharge a firearm in total "stealth" mode unnoticed by people in the surrounding area, so there is no enhancement for criminal intent.

If the Occupational Safety and Health Administration had been around in the 1930s, firearms civil rights lawyer Stephen Halbrook quipped to *The Washington Post*, it probably **would have mandated** their use.*

The one shortcoming of the bill that needs to be fixed via amendment is that the use of suppressors is limited to actual hunting and hunting areas. This use location limitation needs to be expanded to the use at ranges so that hunters can properly and accurately sight in their firearms, which are effected by the addition of a suppressor, as an accurate first shot is part of the practice of ethical, humane hunting.

I'd actually suggest a second amendment (to conform to the Second Amendment): expand the legality of suppressors beyond hunters to all Hawaii firearms owners. As with the national Hearing Protection Act at the federal level, all firearms owners deserve to have the benefits of sound suppression if they so choose.

THE ROLE OF SUPPRESSORS

Suppressors, also known as silencers, are the hearing protection of the 21st century sportsman. Despite common misconceptions, suppressors are not silent. They are simply mufflers for firearms, which function by trapping the expanding gasses at the muzzle and allowing them to slowly cool.

Benefits of Suppressors

HEARING PROTECTION

Noise induced hearing loss and tinnitus are two of the most common afflictions for recreational shooters and hunters. Everyone knows that gunfire is loud, but very few people understand the repercussions that shooting can have on their hearing until it's too late.

Suppressors reduce the noise of a gunshot by an average of 20 - 35 dB, which is roughly the same as earplugs or earmuffs. By decreasing the overall sound signature, suppressors help to preserve the hearing of recreational shooters, hunters, and hunting dogs around the world.

SAFER HUNTING

Most hunters do not wear hearing protection in the field because they want to hear their surroundings. The trouble is, exposure to even a single unsuppressed gunshot can, and often does, lead to permanent hearing damage. Suppressors allow hunters to maintain full situational awareness, while still protecting their hearing. The result is a safer hunting experience for the hunter, and for those nearby.

NOISE COMPLAINTS

As urban developments advance into rural areas, shooting ranges and hunting preserves across the country are being closed due to noise complaints. Although it can still be heard, suppressed gunfire helps mitigate noise complaints from those who live near shooting ranges and hunting land.

ACCURACY

One of the most common problems for shooters is decreased accuracy caused by flinching in anticipation of the firearms discharge and recoil. By containing the explosion of the gunpowder at the muzzle, suppressors reduce recoil, and help decrease muzzle flinch. These benefits lead to improved accuracy, better shot placement, and more humane hunts.

MYTHS ABOUT SUPPRESSORS ENHANCING CRIMINAL ACTIVITY*

[T]here are some 900,000 registered silencers in this country, and they are rarely used in crimes.

Chicago has a lot of bloodshed, including 762 homicides and more than 3,500 shootings last year, but silencers figure in little or any of it. Anthony Guglielmi, a spokesman for the Chicago Police Department, told me, "We seldom recover silencers. Sometimes you may get a gun with a makeshift silencer, but even that is rare."

A report last year by the VPC cites a handful of shootings in which silencers were used. But the paucity of examples confirms that they are not of great interest to criminals. An earlier study by Paul A. Clark published in the Western Criminology Review found **only two federal court cases involving the use of a silencer in a murder between 1995 and 2005.**

He also unearthed eight cases in which "a silencer was actively used during commission of a crime but not used to physically injure anyone." That works out to one serious silencer-related crime per year, in a country that in 2005 had 16,740 homicides and 417,000 robberies.

If silencers were truly valuable to ordinary criminals, there would undoubtedly be a thriving black market and plenty of crimes committed with them. But the federal Bureau of Alcohol, Tobacco, Firearms and Explosives traced only 125 silencers in 2015—not all of which were connected to crimes. As Clark notes, a minimally clever miscreant can get the same noise reduction by wrapping his gun in a towel or pillow.

Any useful technology can be put to villainous ends. But the existing rule on silencers is a major hassle for the law-abiding and an irrelevance to criminals.

On behalf of the Hawaii members of the National Rifle Association, we strongly support House Bill 1589. HB 1589 would allow the use of sound suppressors on firearms while taking wildlife. Currently, 40 states allow the use of suppressors while hunting.

Sound suppressors attached to firearms (often referred to as "silencers) are an additional tool available to help protect from hearing damage, increase accuracy and safety, and reduce noise complaints from surrounding residents. While suppressors do not eliminate the sound of a firearm, they do reduce the muzzle report of a firearm in much the same way a muffler works on a car.

Hearing damage is common among individuals who have been hunting for an extended period of time due to "unprotected shooting". Hunters need to be totally aware of their surroundings and the environment in which they are operating. They must be able to hear ambient noise leaving many to forego hearing protection. HB 1589 provides an opportunity for hunters to acquire and use a suppressor on their firearm, allowing the hunter to stay completely engaged in their surroundings while protecting their hearing and anyone who may be part of the hunting party. Suppressors also provide some measure of reduction of felt recoil, beneficial to all shooters but, especially, younger shooters and female shooters by increasing accuracy and safety.

As a hunter who participates in a pig eradication program, I'm all too familiar with the intense blast generated by hunting rifles and shotguns, and can very likely attribute a slight hearing deficit to that activity. While I always had earplugs available, and used them whenever possible, there were times when a shot had to be fired (a charging pig, for example) without enough time to get my hearing protection in place.

Because of this, I am in full support of HB 1589.

As this bill notes, these noise suppression devices will not actually silence a firearm but, instead, bring down the peak noise level to a much less harmful point. A shot will still be heard at a distance. But there is a greatly reduced risk of permanent hearing damage to the person firing the weapon.

A bill has already been introduced in Congress (H.R.3799 - Hearing Protection Act of 2015) seeking to eliminate the the \$200 Federal transfer tax on suppressors. It's apparent that there are other states who are beginning to better understand and appreciate the importance of these noise suppression devices.

Hawaii's bill, if it becomes law, would help protect the hearing of hunters who help feed their families and communities.

I am writing to voice my support of HB1589 relating to hunting safety. I am a hunter and am fully aware of the points being made within this bill. I along with many of my fellow hunters do opt to hunt without ear protection due to the fact that it reduces our sense of hearing reducing our capabilities which can lead to us missing opportunities and potentially unsafe situations. As a result we accept the ramification of taking a shot without ear protection which naturally is that it's loud. The ability to add a noise suppressor to my hunting rifle would be beneficial to myself and other hunters allowing us to better protect our hearing without reducing our own senses in the field. These devices are safe when used properly and difficult to be acquired by those who should not have them in the first place. Please realize that in addition to any stipulations you make to acquire them within our state they already do require a process due to federal regulations. They are still regulated as a NFA item requiring individuals such as myself to voluntarily submit to a federal background check by the BATF and pay a \$200 tax for every device I wish to purchase. This detail already ensures that only law abiding citizens will normally be capable of purchasing a noise suppressing device. This federal step does not go away regardless of our own state law making it the minimum requirement to purchase these devices before any additional state regulations are enacted in regards to owning within our state. I am not against state level regulations on noise suppressors such as registration with the police department since we already do that for all our firearms anyway. Besides myself I believe our island communities stand to benefit from the passing of this bill and ask for your consideration in the matter.

Aloha Chair Yamane and Members of the Committee,

I support SB 1589. There are some very good reasons for this bill.

- 1. **First and foremost is noise suppression**. A constant issue with the nearby residents is the noise emanating from the Kokohead range. This is understandable. The noise level will most certainly diminish with the legalization of suppressors. Firearms equipped with silencers make for happier neighbors. And happy neighbors harbor more good will toward guns and gun owners.
- 2. Health--sustaining your hearing. According to the National Institute on Deafness and Other Communication Disorders, "15 percent of Americans between the ages of 20 and 69 (26 million people) have high-frequency hearing loss due to exposure to noise at work or during leisure activities." This includes tinnitus, or acute ringing in the ears. Silencers decrease the decibel level of a supersonic firearm by 14 to 45 dB which means Hawaii gun owners will not have to be subject to this risk.
- 3. **Silencers are very rarely used in crime**, and there's no evidence that indicates they would be used more frequently if their regulations were removed.
- 4. Hawaii would be joining 41 other states to allow silencers, with Vermont and Minnesota being the latest to legalize their use.

As of 2014, there were no known poaching incidents using a firearm suppressor that is registered under the National Firearms Act (NFA) of 1934, which is a branch of the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE). Those who claim that hunters who use suppressors to lower the sound will somehow become poachers or violate game limits are only exposing their bias and lack of understanding of the issue. Again, the majority of states allow hunting with suppressors and poaching with registered sound-suppressing devices simply doesn't happen. I am compelled to guestion the ethics of any hunter or hunting groups who disparage

the character of other law-abiding hunters by using such arguments — since most hunters would never contemplate such illegal activity. Do these same opponents of suppressors claim that allowing archers to hunt with bows enables or facilitates poaching or the taking of illegal limits? After all, arrows are much more quiet than a suppressed firearm. In fact, arrows are virtually silent while suppressors are not. Just as opponents of compound bows and crossbows tried to paint them as tools of evil intent, time has proven them just as wrong as they are now about suppressors. Increased use of suppressors will help to eliminate noise complaints, which have been used more frequently as an excuse to close shooting ranges, informal shooting areas and hunting lands throughout the country. And using firearm suppressors to lower noise is not only logical but it is effective in protecting hunters' hearing and increasing accuracy. It is an appropriate use of technology. They merely lower the peak noise pressure from as high as 180 decibels to a much safer level of around 145 decibels. For a comparison, a jackhammer chipping away at concrete produces approximately 109 deciblels, so 145 decibels is anything but silent. There are now 40 states that authorize their citizens to use suppressors while hunting. It is the right thing to do for Hawaii's hunters and those exposed to the report of firearms in hunting areas. As a DLNR Hunter's Education graduate, certified NRA handgun instructor & Range Safety Officer, member of the National Rifle Association, Hawaii Rifle Association, and United States Practical Shooting Association/IPSC, I feel it is vital for this bill to pass.

Although I have only been involved in the shooting community for the past 3 years, I have documented a 40% hearing loss in one year and about 20% in the other. Whether I am involved in a competition, instruction or practice, my safety equipment always consists of: eye protection, a billed cap, long sleeve shirt, long pants, boots, in-ear sonic protectors and ear-muffs. I cannot afford to lose any more hearing loss. I am 49 years old, teach sixth grade and manage a spa part-time. I need to be able to hear what the students, parents, staff and clients are saying without having to constantly ask, "I'm sorry, can you please repeat that?!" as I lean in with my better ear.

Also, as a recent graduate of DLNR's Hunter's Education class, valuable insight was gained as to the minute sounds the hunter must be aware of to warrant a safe hunt for all involved. The cracks of twigs, various calls/whistles, warning sounds and animal footsteps are a few that would alert hunters as to activity in the area. If a hunter is wearing ear protection, these faint sounds could be missed and may prove to be detrimental.

The use of firearm noise suppressors will ensure that the hearing health/ability of hunters, competitors, instructors and range safety officers would be just that, Healthy. I may be of the, "Older" end of the spectrum, but I am very active and plan to be that way. I would like to keep the level of hearing that I currently have (although diminished). The plastic corrugated eyebrow extended over the firing line at Koko Head rifle range, placed by the City to discourage pointing guns over Koko Head Crater rim, reflects sound behind the line such that hearing protection is now necessary in the parking lot. Earmuffs over ear plugs are required and still the noise level when the range is in use is quite high. Would you consider a amendment allowing suppressors at shooting ranges?

Suppressors significantly alter the impact point of rifle bullets. It's unethical to take shots at game animals unless your rifle is properly sighted before your hunt.

Comments: Thank you for the opportunity to provide testimony. I am writing today to support HB 1589. As an avid hunter and shooter hearing protection is a big concern for us. While hunting most hunters will forego hearing protection in order to be able to hear the game animals when they are in close proximity to them. What a suppressor will do is drop the 145+ dB level that is created when a gun is fired down to a level that is more acceptable according to OSHA standards. The suppressor will drop the dB level by 15-45 dB making the levels to about 100-115 dB. At the 115 dB level that is similar to the dB levels of a chain saw or rock concert. What a suppressor will not do is completely remove the sound of the gunfire as depicted in movies. If HB 1589 is passed I would suggest that you add a provision to give the hunter the opportunity to use the suppressor while at the public shooting range in order to sight in his gun. Reason for this is that in the market today there are many ammunition manufacturers as well as firearms manufacturers. Every gun and cartridge are different and when you add a suppressor to the mix you add another variable to the equation. Some rifles prefer ammunition from different manufacturers over others and will print on the target dramatically from manufacturer to manufacturer. When you add a suppressor to the mix it changes the pressures created by the action of firing the gun. This will also change how the bullet prints on the target and must be verified before going out to the field to hunt. Thank you for your time, Brandon Leong

Sound suppressors attached to firearms (less accurately called "silencers") are an additional tool available to help protect hearing, increase accuracy and safety, and reduce noise complaints by surrounding residents. While suppressors do not eliminate the sound of a firearm, they do reduce the muzzle report of a firearm, reducing the risk hearing damage. I strongly urge state legislators to join the legislators of the other 40 States already permitting suppressors for hunting and may I suggest, extend to shooting ranges. Suppressors are the hearing protection of the 21st century sportsman. Hawaii is one of 10 State which have not joined the other 40 States in recognizing the misconceptions about the benefits of suppressors.

Despite common misconceptions, mainly from movies, suppressors are not silent. They are simply mufflers for firearms. There are many benefits to using a suppressor, including:

HEARING PROTECTION: Noise induced hearing loss and tinnitus are two of the most common afflictions for recreational shooters and hunters. Everyone knows that gunfire is loud, but very few people understand the repercussions that shooting can have on their hearing until it's too late. Suppressors reduce the noise of a gunshot by an average of 20 - 35 dB, which is roughly the same as earplugs or earmuffs. By decreasing the overall sound signature, suppressors help to preserve the hearing of recreational shooters, hunters, and hunting dogs around the world.

<u>SAFER HUNTING</u>: Most hunters do not wear hearing protection in the field because they want to hear their surroundings. The trouble is, exposure to even a single unsuppressed gunshot can, and often does, lead to permanent hearing damage. Suppressors allow hunters to maintain full situational awareness, while still protecting their hearing. The result is a safer hunting experience for the hunter, and for those nearby.

NOISE COMPLAINTS: A great example is Hawaii Kai and Koko Head shooting range and frequent noise complaints. Although it can still be heard, suppressed gunfire helps mitigate noise complaints from those who live near shooting ranges and hunting land.

<u>ACCURACY</u>: Suppressors reduce recoil, and help decrease muzzle flinch. These benefits lead to improved accuracy, better shot placement, and more humane hunts.

House Bill 1589

I'm in support for this bill for the following reasons. This state prides itself in being progressive however we are behind of the curve in the matter of hearing protection. OHSA has already stated, employers must protect their employees of noise levels above 85 dB (decibels). At 85 dB hearing lost is permanent. A normal human conversational speech is 76 dB and a person speaking loudly is at 82 dB. Any noise over 140 dB is the threshold of pain. A gun shot is measured around 167 dB which is almost twice the level causing permanent hearing lost.

According to NIOSH (National Institute for Occupational Safety and Health) A Pregnant women's fetus are very susceptible to loud noise.

- Increased noise levels can cause stress. This can cause changes in a pregnant woman's body that can affect her developing baby.
- Sound can travel through your body and reach your baby. Although this sound will be muffled in the womb, very loud noises may still be able to damage your baby's hearing.
- Hearing protectors (ear plugs or earmuffs) can protect your hearing, but if you're pregnant the only way to protect your baby's hearing is to stay away from the loud noise as much as possible.

I live 3 miles from the Kokohead Shooting complex (which is our only public shooting range) and one can hear the gunfire during the week days, weekends and nights (when the police are doing night shoots). Firearms with suppressors used at the range would go a long way in reducing noise to the neighborhood residents and making it a healthy environment.

As shooters we can use ear muffs and ear plugs to protect ourselves. However the noise we generate radiates from our firearm and harms others who are not protected. The use of suppressor on a firearm would lower the noise level to a safe level. It will not make a firearm Hollywood silent. There still will be a report but like a car/motorcycle muffler it reduces the exhaust noise to a safe level for everyone

There would be no cost to the State of Hawaii and local government by passing this Bill as they do not need to put any resources (manpower and money) into control and management of the sale and ownership of suppressors.

This because, Suppressors are controlled by the Federal BATF (Bureau of Tobacco and Firearms) The NFA (National Firearms Act) Branch is responsible for collecting fingerprints, taxes, background check and either granting or declining the applications for a suppressor.

Technology in the use of noise suppressors can help us preserve hearing for Hawaii's future generations, It's a little late for me, being retired LEO, a hunter and competition shooter over 48 years. We should embrace the technology to protect improve our hearing health. Michael M. Fujioka
