HB 1594 – RELATING TO THE UNIVERSITY OF HAWAII PROMISE PROGRAM

Chair Woodson, Vice Chair Hashem and members of the committee:

Thank you for the opportunity to testify in support of HB 1594. This measure would establish a new scholarship program called Hawai'i's Promise that provides support for students with financial need as defined by the U.S. Department of Education, to attend any campus of the University of Hawai'i system at no cost for tuition, fees, books, supplies and transportation.

Hawai'i's Promise would be a "last dollar" scholarship. Other sources of financial aid such as federal Pell grants, UH opportunity scholarships, and other public and privately sponsored scholarships would be applied first, and then Hawai'i's Promise would provide for any unmet needs in the categories mentioned above. This measure would allow any Hawai'i resident who meets the eligibility criteria to attend a UH campus, at no cost for tuition, fees, books, supplies, and transportation. We are hopeful that this measure will encourage more students to attend a UH campus, leading to obtaining our goal of 55% of the State's population having a degree by 2025.

The University of Hawai'i fully supports this bill.

My name is Isaiah Baclaan current President of the Associated Students of the University of Hawai'i - West O'ahu and I am presenting testimony as a private citizen in support of HB 1594 . My name is Jake Manegdeg. As president of the Filipino American Citizens League, I am proud to submit our full support of this bill. The Filipino American Citizens League was formed over twenty years ago to contribute to the advancement of civil rights and social justice for minority groups, underserved populations, and vulnerable communities through education, advocacy, and social action.

The achievements and contributions of Filipinos in Hawai'i since 1906 have been well documented. But as we enter upon the 111th year of Filipinos in Hawai'i, Filipinos and other disadvantaged groups including Native Hawaiians, Samoan, Pacific Islanders, low income, LGBTQ, Hispanics, African Americans and more still have a long way to go to attain parity in society.

Our Coalition is concerned about all disadvantaged students. In particular, we are aware of the disproportionate number of Filipino students who are under-achieving and struggling in our public schools and underrepresented in our state colleges and university. What are the root causes of this? Filipinos are under-represented in executive positions, and over-represented in low-paying entry level positions with little or no job security in the visitor, service, food, retail, construction, and agricultural industries. This segment of Filipinos in Hawai`i's workforce can never afford the cost of middle class comforts and stability for themselves and their families because of income inequality, no matter how many part-time jobs they squeeze into 24 hours, often, at the expense of not seeing their children.

That is why we taxpayers should be investing in, not divesting from education. Students who would qualify for these scholarships will be the economic engine for Hawai'i's future.

> Supporting Testimony for HB1591 and 1594 Hearing: Thursday, February 9, 2017, 2:02 PM

To the House Committee on Higher Education,

My name is Meiyi Wong, and I'm 21 years old. This spring, I will receive my Associate Degree in Human Services from Honolulu Community College. From there, my plan is to attend the UH School of Social Work and earn my BSW. My ultimate goal is to earn my MSW to fulfill my dream of becoming a licensed social worker in mental health.

As a full-time college student who has been attending HCC for the past two years, I can personally attest to the myriad benefits free tuition would offer. Most students I know are struggling to balance work, school, volunteering, family responsibilities, and their personal lives, and a frequent topic of discussion among us is the rapidly climbing cost of tuition and books. Many of us young adults are forced to rely on our parents' financial support, for much longer than we'd like, because we simply can't afford the cost of living in Hawai'i while pursuing an education. Several of my classmates who are supporting themselves, and often their families as well, can only attend school part-time due to their hectic schedules. These men and women are often working more than forty hours per week while juggling papers and studying for exams, and still they may be living paycheck to paycheck. Jobs that community college students are eligible for typically don't pay enough to cover both living and tuition expenses, resulting in a generation of students who are stressed and sleep-deprived not due to partying it up in the dorms but to working night shifts in bars and tending to crying babies while trying to complete tomorrow's English homework.

I am fortunate enough to have my father's support for my schooling, knowing that were I to be on my own, I would not be in school at all. I've worked since I was eighteen years old, and none of my jobs have paid me more than \$13 an hour. I spent six months working in a restaurant where I was paid below minimum wage to be on my feet all day. I've held two jobs simultaneously, working full-time, and my combined paychecks were not even enough to pay the rent for my modest apartment. Add to that the fact that employees are increasingly being relegated to "on-call" status. I can't imagine the pressure and difficulties faced by students who are trying to maintain their GPAs while paying for classes each semester, commuting to school and their jobsite(s), and carving out mandatory time for housework, family, and themselves. Providing free tuition for eligible students would relieve us of an enormous burden. Imagine what would happen if students no longer had to worry about coming up with the money to fund their education, education crucial to getting their dream job or simply a job that pays enough to sustain a decent standard of living. How many recent (and not-so-recent) high school graduates could be motivated to begin pursuing their degrees, how many hundreds of hard-earned dollars could be saved and devoted to other necessary expenses, how many hours could be spent not working overtime in retail but in playing with one's children or working out to better one's

health. Instead of investing precious time in menial jobs merely to pay the bills, students could take up opportunities for travel, volunteer with causes that are meaningful to them, or pursue independent projects, contributing their unique genius to a world that needs them. I strongly pledge my support for HB1591 and HB1594, and the ideas they espouse. It's commonly stated that students are the future; it's time to afford us tangible proof that you believe in our potential and are willing and intentional regarding your support of us.

To whom it may concern,

I recently heard about bill HB 1591 and HB 1594, and am writing in hopes that you will consider passing both bills. I feel it would be important for students like myself, to continue to get there education, without having to worry about how to pay for classes or books, and I believe this bill would help many students like myself. I am currently a non traditional student at HCC and was told by financial aid, that I have exhausted all of my aid, I am only one class from graduating with my A.A.S degree, and with bills like HB 1591 and HB 1594, it will allow me to continue to go to college and make going to school a lot eaiser financially.

"For young adults ages 25–34 who worked full time, year round, higher educational attainment was associated with higher median earnings; this pattern was consistent from 2000 through 2014. For example, in 2014 the median earnings of young adults with a bachelor's degree (\$49,900) were 66 percent higher than the median earnings of young adult high school completers (\$30,000). The median earnings of young adult high school completers were 20 percent higher than the median earnings of those without a high school credential (\$25,000). In addition, median earnings of young adults with a master's or higher degree were \$59,100 in 2014, some 18 percent higher than the median earnings of young adults with a bachelor's degree. This pattern of higher earnings associated with higher levels of educational attainment also held for both male and female young adults as well as for White, Black, Hispanic, and Asian young adults. **SOURCE:** U.S. Department of Education, National Center for Education Statistics. Dear Honorable Committee Chair Rep. Justin H. Woodson, and Vice Chair Rep. Mark J. Hashem, and Members of the Committee:

My name is Rovy Anne Dipaysa. During the summer 2014, after graduating from Waipahu Intermediate School and before beginning Waipahu High School, I enrolled in the Waipahu High School Early College Program as one of the State of Hawaii's first Early College Olympians with the aim and purpose of earning my Associate in Arts degree by the time I graduate from high school. Presently, I am in 11th grade at Waipahu High School and by the end of this spring semester, I will have completed 50 of the 60 credits (or 83%) required for the Associate in Arts degree. After I graduate from high school, I plan to attend UH West Oahu and major in Healthcare Administration. Ultimately, I have high aspirations to earn a Ph.D.; however, I am still exploring various fields study for graduate school.

As a new immigrant, who arrived in Hawaii in May 2012, I stand firmly in support of HB 1591 and HB 1594 because I believe that higher education is a powerful way to transition people out of the poverty.

"Using data from the Beginning Postsecondary Students Longitudinal Study, Wendy Erisman and Shannon Looney found that approximately half of students who entered four-year and two-year colleges in 1995 had earned a credential six years later. The figure was similar for immigrants and for the native-born (including the children of immigrants)."

As a first-generation immigrant, my family struggles in poverty. When we lived in the Philippines, my family came from a rural area where subsistence was a daily challenge. My family and I were blessed to have been given visas to come to America where, through hard work and sacrifice, we could have a better life. When we moved to Hawaii, we rented a crowded and cramped apartment (together with our extended family) because my parents were unable to own or even rent their own place. Because my parents did not have chance to go to college here in the U.S, they both have low-income jobs. The hardships of poverty have been the driving force behind my motivation to get a college education so that I can help move my family out of the poverty.

When I was in 8th grade at Waipahu Intermediate School, Dr. Mark Silliman, Early College Director at Waipahu High School, introduced us to the Waipahu High School Early College Program. Without any hesitation, I seized the opportunity and took my first Early College course when I was a rising freshmen in the summer 2014 term before I took any high school classes. I felt that this was the start of my journey toward earning a college degree. Together with 13 other Early College Olympians at Waipahu High School, we anticipate getting our Associate in Arts degree by the same time we graduate from high school in May 2018. However, our journey will not end there. All of my Olympian classmates agree that our goal is to go beyond the Associate degree. We all aspire to earn a Bachelor's, Master's or even a doctoral degree one day.

I humbly submit this testimony in support of Hawaii's Promise bill, not merely for myself, but for the many thousands of lower-income, underrepresented, first generation college students who live in Hawaii and who follow in our early college foot steps. The passage of this bill should not be viewed as a "handout," but rather a "hand up." We ask only to be given the opportunity to improve our lives and the quality of life for everyone in our communities. In return for passing the Hawaii Promise, we promise to work hard and help the State of Hawaii reach its goal of having 55 percent of it citizen earn a college degree by 2025. Thank you for supporting the passage of this bill and for investing in a more promising future for all of Hawaii's residents.

Aloha! My name is Patricia Duh. I am currently a 21-year-old who is working, trying to obtain a bachelor's degree at the University of Hawaii – West Oahu. I have been enrolled in college since the fall of 2013. I attended Kauai Community College for two years and one semester and have been at the University of Hawaii – West Oahu since fall of 2016. Since being in college, I have had a total of \$13,000.00 in tuition expenses. This amount does not include fees, books, and materials needed for my classes. Now that I am attending a four-year university and not a community college, my tuition has increased by \$2,088.00 for being a full-time student.

I would like to submit testimony in strong support to House Bill 1594 which would establish the Hawaii promise program to provide scholarships for the unmet direct cost needs of qualified students enrolled at any University of Hawaii campus and to appropriate funds to establish and implement the program.

This program would make the world of a difference to those who are attending college already and for those who want to attend college but cannot afford too. Let's look at a foster youth for an example; for one, foster youth are already at a huge disadvantage because they normally do not have family to fall back on to help cover the costs of college. Nationally, only 2 - 9% of former foster youth attain a bachelor's degree. Having been a former foster youth myself, I can definitely say that the costs of college is the biggest setback for a foster child. This program would allow not only former foster youth the opportunity to have an equal chance at college as their peers but others who are struggling financial wise to attend college as well.

Comments: I would respectfully ask the lawmakers to consider lowering the threshold of credits students must be enrolled in to qualify for the promise program or making provisions for non-traditional students who are unable to attend school full-time. In my experience teaching students pursuing an early education degree, many of my students of "promise" are only able to attend college part-time. The students in my classes over the years are often working mothers in low-wage jobs who are balancing school with work and caring for their families. They are primary caregivers for young children and/or elderly parents. And, they will forsake their educational dreams in order to meet the immediate financial obligations of their families. These students pursue their education part-time in the evenings, on-line, and on weekends making slow and steady progress while raising their families and keeping a roof above their heads. Requiring a threshold of 15 credits in order to qualify for scholarships means that many of the people we are trying to help would need to be able to give up their jobs to pursue an education fulltime. This is not a realistic option for the growing number the non-traditional, minority women who are seeking a college education. Given the cost of living in Hawai'i, I suspect it is also not possible for a portion of the 69% of the adult population who has earned an associate's degree of less (Research and Economic Analysis Division, 2016). Please consider lowering the number of credits a student must carry so that working adults are able to qualify for scholarship relief or designate some funding for the population of students who must pursue coursework a little at a time. My experience is that when students do not have the means to attend school full-time, most are persistent and see their program through to completion. even if it takes years. Perhaps eligibility for this group could be based on GPA, continuous enrollment, and steady progress. This would put into place requirements that would encourage adults who might want to pursue college, but who cannot give up work in order to obtain a degree. Research Economic Analysis Division. My name is Charlene Cuaresma, Chair, NaFFAA Region 12, which represents the interests of Filipinos in Hawai'i, Guam, and the Commonwealth of Northern Marianas Islands. We are an affiliate of the National NaFFAA. Washington policy-makers, private industry and national advocacy groups recognize NaFFAA as the Voice of Filipinos and Filipino Americans throughout the United States. We are a non-partisan, non-profit national affiliation of more than five hundred Filipino-American institutions and umbrella organizations that span twelve regions throughout the continental United States and U.S. Pacific territories. I am happy to submit strong support for this bill.

Institutional support through scholarships for qualified students consistent with the provisions of this bill is essential to promote access, diversity, and leadership development for Hawai'i's future leaders. Inadequate financial resources is an obstacle for students who cannot rise above the systemic and persistent disparities without financial assistance. While financial need affects students across the board, one example of the insurmountable uneven barrier is seen with Filipinos, where they comprise 21 percent of public school students, but only 12 percent of students at UH Mānoa; where Filipinos make up a large segment of community college students, but their transfer rates to 4-year degrees and advanced professional degrees at the University of Hawai'i Mānoa are disproportionately low. Subsequently, it is unacceptable that Filipinos. Rising to become the second largest ethnic group (15% by one race only, 25% by more than one race) in Hawai'i since 2010 is not keeping pace with the investment in resources needed for parity to uplift a disproportionate part of our community from service workers to colleagues. If given the support today, more Filipinos will have the potential to make substantive contributions in fields vital to Hawai'i's economic health and quality of life. More importantly, this bill will build the capacity of qualified scholarship recipients to break the cycle of income inequality in their own family, in this generation, in our Aloha State.

Thank you for hearing this bill, and for the opportunity to offer strong support for you to advance student excellence and equity for qualified students in Hawai`i's institutions of higher learning on every island.
