In consideration of HOUSE BILL 172 RELATING TO PRIVATE PROPERTY

House Bill 172 proposes to authorize a property owner or agent to enter adjacent property under certain conditions to control *Albizia* trees. **The Department of Land and Natural Resources** (**Department**) **supports this measure and offers the following comments.**

Due to their extreme height and brittle branches, *Albizia* trees pose a threat not only to properties on which they are rooted, but on adjacent properties where branches and other debris may fall during high wind events. The Department recognizes that the ability of landowners to control *Albizia* on adjacent properties may decrease health and safety risks associated with this species.

The Department suggests that the term "eradicate" be replaced with the term "control," as "eradicate" denotes the complete and total removal of a species from a given geographical region, and is typically used in Hawai'i to refer to island-wide or statewide removal. The actions described in this measure are specific to property boundaries, and the term "control" is more appropriate.

The Department further suggests that health and safety concerns be addressed in the measure through the following amendment to proposed language for 708- (a)(1) found on page 2, line 14:

- (1) Reasonably believes Has consulted with a certified arborist to confirm that the albizia trees on the adjacent property:
 - (A) Create a condition that could become hazardous to the entering owner's property or persons thereupon if left untreated;
 - (B) May be felled and removed or otherwise treated according to current established methods that minimize risk to human health and safety, and without damaging any structure, utility pole, or utility line; and

The Department notes that it may be beneficial to address in the measure issues of liability for any injuries or damages resulting from the removal of an *Albizia* tree.

House Bill 172 – Relating to Private Property

Chairs Lee and Yamane, and Members of the Committees:

The Hawaiian Electric Companies are submitting this written testimony in support of HB 172.

HB 172 authorizes a property owner or agent to enter adjacent property under certain conditions to eradicate albizia trees before they come hazardous. HB 172 further provides defense to criminal prosecution. The Hawaiian Electric Companies support the bill for the following reasons:

- Albizia trees are a hazard to public safety and critical infrastructure.
- Stands of brittle, invasive Albizia trees up to 250 feet tall grow on many public and private properties. Tropical Storm Iselle brought down many Albizia trees, blocked roadways, and caused millions of dollars in damage to homes and important electric utility lines. Broken tree trunks continue to send out new growth creating even more unstable conditions, while seedlings are rapidly germinating in disturbed areas.
- There are many landowners that either refuse or fail to respond to repeated notices to control or eradicate invasive species on their property.
- Albizia trees located on private properties often create hazardous conditions for adjacent properties.
- The ability for an owner to enter an adjacent vacant property to eradicate albizia trees after attempting to contact the owner of said property is essential to stopping the hazards caused by Albizia trees, and ensures that Hawai'i's public safety and critical infrastructure needs are met.

I fully support this bill because it allows property owners to deal with the threat of Albizia on adjacent lots - though I wish this bill could be broadened to include any vacant lot with Albizia in subdivisions because any lot with Albizia makes the Albizia eradication efforts of community volunteer groups and BIISC futile since those untreated lots will continuously spread their seeds and cause new Albizia growth.

My husband and I run and operate a 15 acre macadamia nut farm in Pahoa on the Big Island of Hawaii. Our property is surrounded by many vacant lots with Albezia trees growing on them. During Tropical Strom Iselle and the strong wind storms we have had in the past couple of years many of these Albezia's have fallen on our property causing damage to our macadamia nut trees and our fence line. We have had to move our tents and greenhouses away from areas on our property where neighboring Albezia trees may fall on them. It takes 15 years for a macadamia nut tree to regrow to full production which causes us a loss of that crop for 15 years. This bill would be very helpful in allowing us to go onto the adjacent properties to remove the Albezia's.

We are homeowners in Hawaiian Beaches for almost 4 years. The property adjacent to our home has about 15 - 20 albizia trees. A few of them are growing out from a lava tube (approx. 10ft. in diameter). We are limited to enjoy our backyard because of these trees. The trees are approx. 130' high. Our property is totally fenced in and where branches have fallen, majority of our fence is damaged!

We have asked for help from the engineering department (Hawaii County) a couple of years ago. However after 30 days of the County trying to get the owners of the property to comply or respond, we were told there is nothing they can do about it UNLESS the owners gives them permission! With this said, we are back to ground zero!!!

In 2015, we contacted the Civil Defense office in Honolulu. They had an Arborist come in and perform a survey of the trees. The Arborist informed us that they are hazardous and will be at the top of the list. Well it is now February, 2017 and we are still dealing with these trees. A few weeks ago, Civil Defense contacted us and stated that the owners have yet to respond or comply!

First off, the owner listed on the property tax website is deceased! The deceased children were paying the taxes.

We are on pins and needles here whenever we want to work on our backyard! The trees have already damaged our fence and the side of our home. We have tried to file a claim with our homeowner insurance. However, We do not have \$10,000 for deductible! For every branch that falls and damage our property, it is a separate claim with Pyramid Insurance.

Problem here is the owner is deceased! Someone is paying the \$100/year in taxes! No other name as far as we can see that we can go after to take care of the problem or even to take them to court for property damage!!!!

SOLUTION: Since the owner is deceased, County to take property back or have the authority to enter without permission since no-one lives at property, hire a tree company to go in and clear property!!!

I know to you "it is not that simple"! It doesn't have to be complicated! When a letter is sent to the owner to comply and they do not respond within an allotted time, the county and government should have the authority to enter and go in to resolve the issue for the sake of the people living around the threatening property.

Our neighbor adjacent to the property with the trees, the mother is paralyzed and her bedroom is next to the property mentioned! Now is the County & Government waiting for us or anyone in our family to loose their life in order to respond?

We are at your mercy to PLEASE HELP us resolve this issue regarding these deadly albizia trees! We cannot enjoy our home because of these trees. We have already paid (\$1500.00) enough money into that property mentioned just so that we were safe during Iselle!

Your help and cooperation in this matter is greatly appreciated!
