#### TESTIMONY ON HOUSE BILL NO. 374, RELATING TO DENTAL ASSISTANTS.

TO THE HONORABLE DELLA AU BELATTI, CHAIR, TO THE HONORABLE TAKASHI OHNO, CHAIR, AND MEMBERS OF THE COMMITTEES:

My name is Paul Guevara, D.M.D., M.D.S., Chairperson of the Board of Dental Examiners ("Board"). I appreciate the opportunity to testify on House Bill No. 374, Relating to Dental Assistants which clarifies the allowable and prohibited practices requirements for dental assistants and prohibits the ordering of a person without a dental hygienist license to perform services or procedures within the scope of practice of dental hygiene.

The Board has not had an opportunity to review this bill. The next meeting of the Board is Monday, February 13, 2017 (the morning immediately preceding this hearing), at which time the Board will discuss and determine its position on this measure. I will be available to relay the information to the committees at this hearing and to answer any questions that the committees may have.

In a previous discussion regarding the allowable and prohibited practices requirements for dental assistants, the Board strongly opposed the proposal to prohibit Testimony on House Bill 374 Tuesday, February 14, 2017 Page 2

the dental assistants from infringement upon or overlapping of the duties and scope of practice of licensed dental hygienists under chapter 447, HRS.

The proposed amendments to subsection (b) on page 2, lines 20 and 21, and page 3, lines 1 through 6, would prohibit a dental assistant from performing any services that would overlap or conflict with the practice of dental hygiene. The Board would prefer the flexibility of the rulemaking process in the future to accommodate advances in technology that may benefit the public while at the same time affords it protection.

The proposed language would cement the allowable and prohibited duties of the dental assistants.

In regards to the overlap or conflict of services, we note that there are many examples of overlap of services among professions. For example, both a dentist and dental hygienist can administer intra-oral infiltration and block anesthesia injections; a physician and advanced nurse practitioner can perform some of the same services; an architect and professional engineer can perform some of the same services.

Thank you for the opportunity to testify on House Bill No. 374.

Dear Respected Members of the House Committees on Health and Intrastate Commerce:

The Hawaii Dental Hygienists' Association (HDHA) supports the intent of **HB 374.** We would like to congratulate you on your leadership in initiating this important discussion during this legislative session. This bill will bring a muchneeded resolution to an existing debate with the Hawaii Board of Dental Examiners regarding the allowable and prohibited duties of a Dental Assistant.

In a dental office, dental assistants are an important part of the dental team. Each team member plays a critical role in the execution of outstanding patient care. With that said, HDHA feels that clarity in HRS 448-3 needs to clearly delineate the allowable duties and prohibited duties of a dental assistant as relating to the scope of practice of dental hygienists.

We feel the addition of the wording: "provided that the rules shall not infringe upon or overlap or conflict with the duties and scope of practice licensed dental hygienists under chapter 447. No person shall employ, direct, or otherwise order a dental assistant or other person to perform services or procedures within the scope of practice of dental hygiene as provided in chapter 447, unless the person who performs the services or procedures is a licensed dental hygienist under section 447-1" is a much needed addition to HRS 448-3 (b). Having this in statute would allow changes in duties as technology advances, without encroaching on the scope of practice of another licensed profession.

In the future, HDHA would support the licensure or certification of dental assistants with expanded duties, like fluoride varnish application, should the proper HBODE course approved infrastructure be in place.

HDHA thanks you for your time and consideration of **HB 374**. We would like to convey our desire that dentists, assistants and hygienists continue to be integral members of the oral health team, and feel that the public is best served and protected when all oral health providers and highly trained and work within their practice acts.

HB 374 Relating to Dental Assistants

Dear Chairs:

I **OPPOSE HB 374** because it is unnecessary. Current Rules and Regulations cover and differentiate the duties of the hygienists and dental assistants.

Many dental hygiene schools do not teach the same duties that the dental assistant receive so that there are no cross-over duties.

Although, there are many technical changes in dentistry, far more occur within the field of the dentist and the dental assistant team than in dental hygiene. Therefore, the career in dental assisting is out pacing dental hygiene which is limited to just cleaning teeth and gum tissues. 3D imaging and fabrication of crowns out of solid ceramic blocks is an example where the dental assistant play a major roll whereas the dental hygiene will never utilize this process let alone receive any training.

I suggest a certification process be created and implemented for dental assistants rather than limit the treatments available for patients which will reduce access to care.

Hawaii now has a training program for assistants at Maui Community College and graduates about 18 students a year-after completing a two semester program.

This is a great program but still most of the assistants in our state are on the job trained. They have specific duties assigned to them that are within their job description and skill level. In the past the Board of Dental Examiners has sought to expand the duties of the assistants by a mere rule change. They have tried to assign duties to the assistants which are duties provided by licensed hygienists. Hygienists have been educated, tested and licensed to perform certain duties within their scope of practice. To allow on the job trained assistants to perform these same duties is not only demonstrating negligence by the Board in encroaching on the duties of licensed professionals already performing these duties but is a public safety issue as well.
