#### In consideration of HOUSE BILL 400 RELATING TO MAALAEA SMALL BOAT HARBOR

House Bill 400 proposes to correct an error in the Supplemental Appropriations Act of 2016 to clarify that the capital improvement program project for Maalaea Small Boat Harbor on Maui was for plans, design, and construction for pier improvements, rather than dredging. **The Department of Land and Natural Resources supports this measure.** 

The Supplemental Appropriations Act of 2016, Act 124, Session Laws of Hawaii 2016, appropriated the capital improvement project at the Maalaea Small Boat Harbor but inadvertently made reference to dredging rather than the intended pier improvement project.
