# In consideration of HOUSE BILL 404 RELATING TO BOATING

House Bill 404 proposes to require commercial thrill craft and parasailing operators to complete a water safety education course and appropriates funds. **The Department of Land and Natural Resources (Department) does not support this bill.** 

The Department acknowledges that there are challenges with the increased use of near shore waters by an ever increasing number of users who are participating in a variety of different activities.

The Department wishes to point out that the United States Coast Guard (USCG), Code of Federal Regulation (CFR), addresses the issues brought forth in this bill. The CFR mandates that operators of any commercial vessel are required to obtain a Merchant Mariner Credential. To obtain this credential, a person is required to complete a series of tests that include rules of the road, safe operations of vessels, and document at least 720 days of sea time. Additionally, Hawaii Administrative Rule §13-244-15.5, has been in effect since 2012. The administrative rule requires all recreational operators of motorized vessels to take a boating safety course approved by the State of Hawaii and the National Association of State Boating Law Administrators.

This measure proposes to require the Department to establish a mandatory annual water safety education course but does not describe what the course is supposed to entail. The Department does not have the staffing available to administer such a course. Also, the measure states that the course shall include awareness of traditional canoe practices but does not define what those practices are.
