Comments: The Land Use Research Foundation of Hawaii (LURF) provides the following COMMENTS and PROPOSED AMENDMENTS in support of the intent of HB 427, HD2 which establishes a Dark Night Skies Protection Advisory Committee to assist the University of Hawaii in developing a statewide dark night skies protection strategy.
