# H.B. 463 RELATING TO HAWAII STATE IDENTIFICATION CARDS

House Committee on Judiciary

The Department of Transportation (DOT) is **opposed** to H.B. 463 that will allow any satellite city hall in any county with a population of more than seven hundred thousand persons to issue Hawaii state identification (ID) cards.

DOT believes this bill is unnecessary, will result in the unnecessary expenditure of DOT funds, and will cause longer lines at Honolulu's Satellite City Halls. Honolulu's Satellite City Halls provide City services which include such services as motor vehicle registration type of transactions, issuance of disability parking placards, registration of bicycles and dogs as well as payment of City bills.

The City and County of Honolulu currently has five (5) driver license offices that issue state identification cards. During the calendar years 2015 and 2016, the City and County of Honolulu issued 13,591 and 17,443 state identification cards respectively. There are nine Satellite City Halls with only Ala Moana Satellite City Hall that is NOT located close to a driver license office and NOT currently offering driver license renewal and duplicate services.

Aloha Chair Nishimoto, Vice Chair San Buenaventura and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai'i for two decades. This testimony is respectfully offered on behalf of the approximately 6,000 Hawai'i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that approximately 1,400 of Hawai'i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Native Hawaiians, far from their ancestral lands.

HB 463 allows any satellite city hall in any county with a population of more than seven hundred thousand persons to issue Hawai'i state identification cards. Community Alliance on Prisons is in strong support of this bill.

Lack of identification is one of the biggest barriers to reentry for people exiting incarceration. Without it a person cannot open a bank account, cash a check, register to vote, secure a place to live, or even get a library card.

Community Alliance on Prisons thanks the committee for hearing this important bill and urges the committee to support HB 463!

## Position Statement Supporting House Bill 463

Chair Nishimoto, Vice Chair San Buenaventura, and committee members,

Thank you for the opportunity to testify in **STRONG SUPPORT** of House Bill 463, relating to Hawaii state identification cards. Practically, this bill would increase the locations to obtain a state ID. However, it would have greater implications for those receiving the ID, like access to housing, employment, and even access to the library.

Without a state ID, one cannot find employment, cash a check, open a bank account, or enter certain buildings-like the Prince Johan Kuhio Kalanianaloe Federal Building. Being able to visit more locations to obtain an ID can help people access needed services. For those individuals without their own transportation or limited funds, a greater variety of locations also increases the opportunity to obtain an ID.

When you have an ID, you may take it for granted. For those without however, it becomes the lifeline they need to succeed. Increasing the locations that can issue identification will help those who need it most. The YWCA O'ahu respectfully request the committee support House Bill 463. Dear Chair Nishimoto and Members of the Committee on Judiciary:

The American Civil Liberties Union of Hawaii ("ACLU of Hawaii") writes in support of H.B. 463, which allows certain satellite city hall locations to issue Hawaii state identification cards.

A means of identification plays a huge role for a former inmate's transition to public life. Having an official government-issued ID increases the likelihood for better job prospects, stable housing, educational opportunities, and other possibilities. Newly hired employees are often required to provide copies of state or federally issued identification. Even when individuals are able to find employment, the lack of identification makes it difficult to cash paychecks or open bank accounts. These barriers increase the likelihood of failure during initial attempts of reentry—which can result in individuals returning to crime as a means of survival. According to a study from the Legal Action Center<sup>1</sup> the first few weeks after discharge are extremely critical to successful reentry and preventing recidivism. Thus, it is imperative to make this transition as smooth as possible by allowing more expedient and convenient opportunities to obtain state identification.

For these reasons, the ACLU of Hawai'i urges the Committee to support H.B. 463.
