PURPOSE OF BILL: Appropriates moneys from the general fund for two specialist II positions within the Hawaii teacher standards board.

Chair Luke, Vice Chair Cullen, and Members of the Committee:

The Hawaii Teacher Standards Board (HTSB) thanks the House Committee on Finance for considering HB492 and <u>strongly supports</u> this bill to general fund Hawaii Teacher Standards Board's two specialists. These positions were originally created under the general fund, and are already established permanent, filled positions. The two individuals in these positions support the day to day licensing functions of the HTSB, working directly with approximately 12,000 teacher applicants and licensees in all Hawaii public schools. While their main function is managing the workflow for teacher licensing, they also lend support to preservice preparation, US Department of Education Title 2 reporting, and the review of licensing standards and testing. HTSB has a strong team that is able to meet these needs, and we hope to be able to continue to offer capable, efficient, effective support to teachers through the work of these two specialists.

HTSB's special fund is based solely on teacher licensing fees, and HTSB assumed payment of these two specialist positions and several clerical positions in FY2012. Over the past four fiscal years, since fully transitioning all personnel and operating expenses from the general to the special fund, the increase in salary and benefits for personnel costs have exceeded HTSB's special fund revenue from annual teacher licensing fees of \$48 per licensee. In order to offset this trend, HTSB has reduced its staff from thirteen full time employees to a current count of five full time and two

half time individuals, reduced office space by half, as well as taken other cost cutting measures. We feel that this is the minimum staff possible to effectively support all functions of the HTSB.

We humbly thank you again and ask for the House Finance Committee's support for our work, to help ensure that our licensed teachers have the appropriate training, knowledge, skills and dispositions to teach our most precious resource, Hawaii's Keiki.

Thank you for your support of education and for the opportunity to testify.

Chair Luke and Members of the Committee:

The Hawaii State Teachers Association <u>supports HB 492, HD 1</u>, relating to the Hawaii Teacher Standards Board.

In 1995, the State Legislature created the Hawaii Teacher Standards Board (HTSB) to set licensing standards for Hawai'i public school teachers. In 2002, the Legislature transferred responsibility for teacher licensing and State Approval of Teacher Education to HTSB. According to its mission statement, the board "envisions a highly esteemed public education system with rigorous professional teacher standards that foster student success" and aims to "collaboratively set high teacher licensing and credentialing standards" that:

- provide every child with qualified teachers;
- promote professionalism and teaching excellence;
- build public confidence in the teaching profession; and
- provide more accountability to the public.

Yet, HTSB has faced staffing cuts in recent years that have hampered its efforts. In 2012, HTSB relinquished all general funds, leaving personnel specialist II and educational specialist II positions to be funded through special fund appropriations. Since that time, the board has been forced to further reduce staff and office space, adversely impacting its ability to advance teacher quality.

To assist HTSB in overseeing teacher standards, the Hawaii State Teachers Association asks your committee to **<u>support</u>** this bill.

Chair Luke, Vice Chair Cullen, and Members of the Committee:

My name is Donald Young, and I serve as Dean of the College of Education at the University of Hawai'i at Mānoa. Today I am pleased to submit testimony in support of HB 492 HD1.

The Hawai'i Teacher Standards Board (HTSB) serves a vital function in our state being responsible for teacher licensing and monitoring, reviewing licensing standards and license testing, monitoring the accreditation of teacher preparation programs, reporting to the U.S. Department of Education, etc. In addition, HTSB has been responsive to necessary changes and innovations in teacher preparation and licensing, working collaboratively with all programs in Hawai'i that prepare educators.

The increased workload and the ability to continue to be responsive to needs in the field present HTSB with financial challenges. HB 492 HD1 seeks to shift the costs of two positions to the general fund. Such a shift will enable HTSB to remain solvent without raising licensing fees. As personnel costs have continued to rise, HTSB has adjusted by reducing the number of employees to the minimum they now have. Without additional financial support further cuts will be necessary threatening to reduce the vital services HTSB provides.

I therefore urge the committee to support HB 492 HD1.
