Aloha, I am writing in support of the two bills that encourage better treatment of dogs and less stressful confinement.

I live in a rural neighborhood and dogs are tethered on nearly every lot. They are often neglected, poorly fed, with

out water, and lack adequate exercise. As a dog owner who walks my dog, on leash, it is heart breaking to see how poorly

these tethered dogs are treated and the suffering is inhumane.

I would like to see a requirement that dog owners must provide a fenced yard for their dogs with adequate cover,

water and food.Some minimum square feet per dog.

I would also like to see mandatory dog training, ideally at puppy age, as the dogs in Hawaii act in vicious and threatening ways around other dogs as they have not been properly socialized. There are 'puppy kindergartens' that would prevent these hostile behaviors.

Many communities on the mainland have dog parks. But these would not be safe here due to the lack of training,

dog-to-dog socialization, and lack of owner's voice command control. Perhaps an incentive could be offered, free

dog license for 10 years if a dog goes to training? Or subsidized training options?

I feel unsafe myself walking my lane with dogs lunging to the end of their chains, viciously growling and barking.

There is a clear difference between a guard dog and an attack dog.

Violent or threatening dogs need to be kept a minimum of 30 feet from the roadside of any property, same as the building

set back, to allow for peaceable dog walking along our streets.

My name is Keith Dane. I am the Hawaii Policy Advisor for The Humane Society of the United States (HSUS), and I appreciate the opportunity to submit this written testimony on behalf of our Hawaii members and supporters in support of HB55, to limit the tethering of dogs.

This bill contains the same language as passed by the full House last session (HB1592 HD1) and will aid in enforcement and address the greatest public safety threats related to tethered/chained dogs such as aggressive behavior and potential attacks/bites, by prohibiting certain types of tethers (weight, length, materials, for puppies) that are most likely to increase animal suffering and aggression.

Dogs are naturally social beings who need interaction with humans and/or other animals. Intensive confinement or long-term restraint can severely damage their physical and psychological well-being. An otherwise friendly and docile dog, when kept continuously chained or intensively confined in any way, becomes neurotic, unhappy, anxious and often aggressive. Chained dogs are more likely to bark and be seen as a nuisance to the community.

It is common for continuously tethered dogs to endure physical ailments as a result of being continuously tethered. Their necks can become raw and sore, and their collars can painfully grow into their skin. They are vulnerable to insect bites and parasites, and are at high risk of entanglement, strangulation, and harassment or attacks by other dogs or people.

Tethered dogs may also suffer from irregular feedings, overturned water bowls, inadequate veterinary care and extreme temperatures. During periods of extreme heat, they may not receive adequate water or protection from the sun. Owners who chain their dogs are less likely to clean the area of confinement, causing the dogs to eat and sleep in an area contaminated with urine and feces. What's more, because their often neurotic behavior makes them difficult to approach, chained dogs are rarely given even minimal affection. Tethered dogs may become "part of the scenery" and can be easily ignored by their owners.

Unmonitored tethering is not only bad for dogs—it is a high risk factor in serious dog bites and attacks. Dogs unable to retreat from perceived or real threats can act out aggressively when approached. Dogs tethered for long periods can become highly aggressive. Dogs feel naturally protective of their territory; when confronted with a perceived threat, they respond according to their fight-or-flight instinct. A tied dog, unable to take flight, resorts to fight, attacking any unfamiliar animal or person who unwittingly wanders into his or her territory.

Tragically, the victims of such attacks are often children who approach the dog unaware of the risks. Furthermore, a tethered dog who finally does get loose from his chains may remain aggressive, and is likely to chase and attack unsuspecting passersby and pets because s/he has developed severe behavior problems from long-term, intensive confinement.

The Humane Society of the United States requests a favorable report on HB55.
