# Testimony COMMENTING on HB0614 RELATING TO FALL PREVENTION

1 **Fiscal Implications:** We appreciate the intent of HB0614, and defer to the Governor's

2 Executive Budget request for the Department of Health's (DOH) appropriations and personnel

3 priorities. HB0614 requests \$95,000 of general funds for a fall prevention and early detection

4 coordinator position.

5 **Department Testimony:** The Department of Health recognizes the significance of falls among 6 older adults. Falls and fall related injuries among older adults impose an enormous burden on 7 individuals, society, and Hawaii's health care system. Among adults 65 years of age and older, 8 falls are by far the leading cause of injury-related deaths (46% of the total), hospitalizations 9 (83%), and EMS attended injuries among older adults (81%). Direct medical charges for fall and fall-related injuries among older adults amount to nearly \$100.6 million annually, an amount 10 that is easily doubled if we include the costs of rehabilitation and long term care. Falls impact 11 12 the quality of life and independence of older adults. Over half of those hospitalized from a fall are discharged to a nursing facility or rehabilitation center and many never regain full 13

1	independence. The "Hawaii Special Emphasis Report: Fall Injuries Among Older Adults, 2011-
2	2015," provides a detailed report on the impact of falls on Hawaii residents 65 years and older.
3	Falls are not an inevitable part of aging and can be prevented. The Department is
4	committed to addressing this critical public health issue and has already taken steps to address
5	fall injuries among older adults with the resources we have. These efforts include working with
6	the Hawaii Fall Prevention Consortium and other stakeholders to implement and evaluate
7	evidence-based programs and practices for reducing falls among older adults prioritized in the
8	"Hawaii Falls Prevention State Plan, 2013-2018."
9	Considering the magnitude of falls among older adults and the anticipated increase in this
10	age group in the next 20 years to over 18% of Hawaii's population, funding for the established
11	position proposed in this bill will enable the Department of Health to have the dedicated
12	resources to continue to support and build a coordinated state-wide approach for preventing falls
13	and supporting healthy aging among older adults.

The Elderly Affairs Division (EAD) is Honolulu's designated Area Agency on Aging and operates in accordance with the Older Americans Act of 1965 to coordinate, advocate and improve services to assist older persons in leading independent, meaningful and dignified lives in their own homes and communities for as long as possible. We also serve as the designated Aging and Disability Resource Center (ADRC) for Honolulu.

This bill includes funding for important programs that support the needs of the increasing population of elderly residents in Hawaii. The funding included in this bill is essential to maintain the health and welfare of our most vulnerable seniors and their caregivers. We strongly support funding for HB 614.

Falls are among the leading causes of hospitalization and severe injury among the elderly. This oftentimes preventable occurrence can seriously affect the quality of life for the elderly individual and also impacts healthcare costs for the community at large. When family members call our Senior Helpline, they often share stories about how their loved ones may have fallen and require additional assistance as a result of that fall. For many people, falls late in life can create challenges with completing daily activities independently long into the future.

The funds being requested will allow for the further development of fall prevention programs statewide. Through the efforts of the Department of Health, Injury Prevention Systems Branch and the Fall Prevention Consortium, efforts have been made to conduct balance screenings, perform medication reviews, and provide increased community awareness. However, more is needed to address this growing issue within the community.

# RE: HB 614 RELATING TO FALL PREVENTION

I am Audrey Suga-Nakagawa, Advocacy Director for AARP Hawaii. AARP is a membership organization of people age fifty and over with more than 150,000 members in Hawaii. AARP advocates and provides information on issues that matter to our kupuna and their families, including affordable, accessible, quality healthcare, financial resiliency, and livable communities.

HB 614 appropriates \$95,000 for the full time fall prevention and early detection coordinator position.

# AARP Hawaii strongly supports HB 614.

According to Hawaii Department of Health Report on Falls Injuries among Older Adults (2011-2015), falls are the leading cause of injuries among Hawaii residents age 65 and older which resulted in 7,251 emergency room visits, 1,907 hospitalizations and 101 deaths. The associated costs with fall injuries among this age group are estimated to be over \$181 million annually.<sup>1</sup> A focal program to reduce and promptly detect falls especially among the elderly is needed. This bill provides the appropriation for a full time coordinator to oversee and coordinate a statewide approach.

We support that the fall prevention and early detection coordinator position be funded.

I am Gregg Pacilio, PT and Board President of the Hawaii Chapter of the American Physical Therapy Association (HAPTA), a non-profit professional organization serving more than 300 member Physical Therapists and Physical Therapist Assistants. Our members are employed in hospitals and health care facilities, the Department of Education school system, and private practice. We are movement specialists and are part of the spectrum of care for Hawaii, and provide rehabilitative services for infants and children, youth, adults and the elderly. Rehabilitative services are a vital part of restoring optimum functioning from neuromusculoskeletal injuries and impairments.

According to the CDC, more than one third of adults 65 and older fall each year in the United States and 20% to 30% of people who fall suffer moderate to severe injuries. Physical therapists can help in risk reduction and prevention of falls.

Physical therapists are integrated in the current Hawaii Injury Prevention plan created by the Department of Health- Injury Prevention and Control Section (IPCS), in regards to fall prevention awareness and wellness programs throughout the islands of Hawaii.

The plan has already implemented evidence-based practices with physical therapists including: 1. safe home assessments to reduce fall risks, 2. community fall prevention screening, 3. community education sessions on strategies for fall prevention and exercises.

HAPTA is supportive of efforts that the DOH have made in raising awareness in the community for fall prevention and look forward to future collaborations with them.

The Injury Prevention Advisory Committee <u>strongly supports HB 614</u>. This bill appropriates funds for the fall prevention and early detection coordinator position established by Act 153.

Established in 1990, the Injury Prevention Advisory Committee (IPAC) is an advocacy group committed to preventing and reducing injuries in Hawai'i. The IPAC membership include representatives from public and private agencies, physicians and professionals working together to address the eight leading areas of injury, including fall prevention among older adults.

Fall prevention is essential for maintaining quality of life and keeping our kupuna at home. Falls are the main cause of injury-related deaths, hospitalizations, and EMS attended injuries among adults 65 years and older. Every week in Hawaii, there is an average of 140 emergency department visits, plus 37 hospitalizations, and 2 deaths due to fall injuries among Hawaii residents 65 and older.

A fall prevention and early detection coordinator is necessary for coordinating statewide efforts, and together with the Fall Prevention Consortium, implementing and evaluating programs and policies that are based on the best available evidence to prevent and reduce the severity of falls among older adults.

We urge you to pass HB 614 because this measure will save lives and help to maintain the health and independence of our senior population.

# STATEMENT OF THE ILWU LOCAL 142 ON H.B. 614 RELATING TO FALL PREVENTION

The ILWU Local 142 **supports** H.B. 614, which makes an appropriation to the Department of Health for a full-time equivalent Fall Prevention and Early Detection Coordinator position established by Act 153, Session Laws of Hawaii, 2014.

When the elderly fall, the consequences are often catastrophic. Kupuna have weaker bones, and a fall usually means a break that requires hospitalization and rehabilitation. Falls are costly, not only financially but psychologically and emotionally. A fall can mean loss of independence and drastic changes to a person's lifestyle and quality of life.

Thus, fall prevention would seem to be a logical public health option. Indeed, programs already do exist to assist the elderly and their families to ensure that falls may be avoided. For example, Project Dana has a home safety program where professionals inspect the home for potential hazards and recommend remedies. But a coordinated effort is needed to reach a broader cross-section of the public and larger numbers of people.

H.B. 614 proposes a nominal appropriation to address this vitally important and needed program. A \$95,000 appropriation could help to save thousands of dollars more by preventing falls and the resulting medical services and inpatient admissions. We believe more money is needed, but the \$95,000 is a start and will be money well spent.

The ILWU strongly urges passage of H.B. 614. Thank you for the opportunity to provide testimony on this measure.
