## In consideration of HOUSE BILL 619 RELATING TO CONSERVATION AND RESOURCES ENFORCEMENT

House Bill 619 proposes to reestablish and revitalize the Division of Conservation and Resources Enforcement's Volunteer Officer Program in a cost effective manner by appropriating funds for the recruitment and training of Volunteer Conservation and Resources Enforcement Officers. **The Department of Land and Natural Resources (Department) generally supports this measure.** 

The Division of Conservation and Resources Enforcement's (DOCARE) Volunteer Officer Program is a valuable resource because it provides a force multiplier for the Department's law enforcement efforts. This Program allows volunteers who serve without compensation and who are trained to the same standards as full-time DOCARE Officers to provide essential law enforcement services for the Department.

The Department notes that the training of Volunteer Conservation and Resources Enforcement Officers is a significant investment of both time and funds. Current language in this bill proposes to appropriate the sum of \$500,000, or the amount necessary thereof from the general revenues of the State to reestablish and revitalize the program. The Department is concerned of the impact that this may have on the Governor's Executive Budget Request.

As we have experienced in the past even fulltime enforcement officers are challenged with understanding and enforcing the broad and diverse duties assigned to DOCARE Officers. Assigning such responsibilities to laypeople creates the potential for confusion in addition to unnecessary liabilities and litigation upon the division and DLNR.
