Chairperson Creagan and Members of the Committee:

Thank you for the opportunity to testify on House Bill 655. This bill would appropriate general funds to the Department of Land and Natural Resources to: fund the National Wildlife Research Center's assessment of the impacts of the parakeet and develop a control program to reduce the impacts of the parakeet. The department supports this measure.

The department recognizes that rose-ringed parakeet is an environmental pest and agricultural pest. It spreads seeds of noxious weeds into the forests which compete with and often overwhelm the native plants, changing the ecology of the forests. This then has secondary negative impacts on the native birds, insects, bats, etc. In addition, the rose-ringed parakeet feeds on fruit grown in agricultural areas resulting in a negative impact on agriculture production. The National Wildlife Research Center has begun, but has not completed, studies on the impacts of these birds in Hawaii. This funding will continue that research which will be needed to develop effective control measures.

### In consideration of HOUSE BILL 655 RELATING TO THE ROSE-RINGED PARAKEET

House Bill 655 proposes to provide funds to support research and control of rose-ringed parakeet on the island of Kauai. The Department of Land and Natural Resources (Department) supports this initiative, as long as it does not replace our priorities requested in the Executive Budget.

The Department recognizes that there has been an increase in reports of rose-ringed parakeet flocks on the Island of Kauai and that this species may be a nuisance to farmers. The proposed research by the National Wildlife Research Center (NWRC) would also examine whether this species poses threats to Hawaii's natural resources by feeding on native plant seeds or dispersing non-native plant seeds from low-elevation farms and forests into higher-elevation native forests. This funding would support development of a control plan for parakeets and would fund some initial control work under the guidance of this plan.

The Department notes that the Hawaii Interagency Biosecurity Plan describes the need for increased research and control of established pests, such as the rose-ringed parakeet, under action item #121 (PosTifs2.3).

I am writing to the House of Representatives in support to the bill HB655: Relating to the Rose Ringed Parakeet.

As the Extension Agent on Kauai designated to help educate and explore mitigation measures, cannot strongly express enough the urgency Kauai residents and guests need to find ways to control the Pose Ringed Parakeet. It is the topic that most occupies my work and personal time when my position within the university is mentioned.

I regularly visit farmer's markets to get up to date on various concerns of our growers, and I hear story after story of tangerine trees stripped of fruit in a day, and the loss of an entire lychee orchard directly before harvest. Many of our multicultural growers here are too shy or concerned about government to come forward and speak their mind about the losses they experience due to the Rose Ringed Parakeet, so I will speak for them. Our vegetable and fruit growers accrue significant losses due to feeding damage and now require at least one family member at all times in their fields in order to scare away birds. Scare tape, noise calls, scarecrows, and other tactics have failed immediately to prevent parakeet feeding, so a more effective and long-term control measure needs to be explored.

Beyond the crop losses, I am concerned for the food safety and public health concerns that the rose ringed parakeets bring to Kauai. These birds and their relatives leave significant excrement where they roost and have been known to vector many human pathogens. If they are regularly visiting restaurants and farms, then there is a strong potential that pathogens are being introduced into our food systems.

Thank you for your time and look forward to hearing the outcome of this bill. This Kauai County problem will soon become a problem on every island and I hope we are able to establish control measures to prevent the parakeets from being a permanent resident of the state like some of its invasive predecessors.

My name is Bennette Misalucha, Executive Director of the Hawaii Crop Improvement Association (HCIA). HCIA is a Hawaii-based non-profit organization promoting agricultural bio tech to help farmers and communities succeed. Through education, collaboration, and advocacy, we work to ensure a safe and sustainable food supply, support responsible farming practices, and build a healthy state economy.

HCIA is in support of HB655 which appropriates funds to the Hawaii State Department of Agriculture to assist and fund the National Wildlife Research Center (NWRC) with research of the negative impacts of the rose-ringed parakeet on Kauai and development and implementation of a control plan to reduce set negative impacts.

The Rose-Ringed Parakeet (RRP) is a substantial threat to agriculture in Hawaii, especially on Kauai. Over the past few years, local farmers have watched as the population of these environmental and agricultural pests have grown. The RRP feeds indiscriminately on the crops of both small and large agricultural enterprises.

RRP's measure approximately sixteen inches long, including tail feathers. Their average single-wing length is roughly 6.5 inches. These birds are most commonly found in flocks containing several dozen, allowing for the quick destruction of an agricultural field.

Secondary to their impact on crops from feeding, the RRP also spread seeds of invasive weeds. Left unchecked, the unwanted weeds lead to lower production yields and a myriad of other negative ecological impacts.

The NWRC has begun research of the negative impacts of the RRP on Kauai. The requested funding will allow them to complete their study and move forward with a much needed control plan to limit the negative impacts produced by these animals.



HCIA respectfully requests that this committee vote yes on HB655 to help local farmers protect their businesses and livelihoods.

On my 6 acre property, I have lemons, oranges, tangerines, grapefruit, longan, several varieties of mango, avocado, pineapple, rambutan, lychee, cacao and starfruit as well as a large vegetable garden. My small farm could easily be devastated by the Rose Ringed Parakeets, who are voracious eaters, The rose-ringed parakeet is becoming a considerable pest on Kauai. Parakeet populations exhibit a slow growth for several years before beginning rapid expansion. Kauai is currently experiencing the beginning of the rapid growth phase and the population must be controlled before it spreads across the entire island. Throughout the past two years I have witnessed huge flocks of these noisy birds descending on trees in Poipu and Lihue at dusk. The damage to agriculture through crop loss has been documented from small back yard growers to large scale seed farms. Tourist and residents in roosting areas are increasingly complaining about noise and feces as roosts expand and seek new locations. I understand that the effects on native birds and plants are less known; however there is growing evidence that parakeets are spreading invasive seeds into the forests while destroying native seeds and potentially spreading pathogens and human diseases. I urge the legislature to act rapidly before the population becomes too large and dispersed to control with the resulting losses to agriculture, tourism and the native environment.
