H.B. 727, H.D.1 RELATING TO MOTORCYCLES

Senate Committee on Transportation and Energy

The Department of Transportation **opposes** H.B. 727, H.D.1 that allows motorcycle and motor scooter lane filtering.

This bill permits motorcycles and motor scooters to proceed between stopped lanes of traffic (lane filter) in the same direction at a reduced rate of speed that does not exceed ten miles per hour.

The bill indicates that "lane filtering" would increase safety. However, in Hawaii, during calendar years 2009 through 2015, only two (2) out of 162 motorcycle and motor scooter fatalities involved rear end collisions. The description of the two fatal crashes are as follows: (1) a motorcycle operator struck another motorcycle operator from behind and (2) a motorcycle operator struck the driver of the motor vehicle from behind. Therefore, the data suggests that "lane filtering" will not address the current issues of motorcycle and scooter fatalities. Furthermore, "lane filtering" would increase the number of conflict points between motor vehicle drivers and motorcycle/motor scooter operators.

Also, with the recent trend of narrowing lanes on State and County roads to accommodate the current traffic volumes, the motorcycle rider and other vehicle operators have less room to maneuver. Allowing "lane filtering" on all roads statewide may cause an increase in collisions. If collisions were to occur that resulted in injuries as a result of "lane filtering" during "peak-hour" traffic, it would further exacerbate traffic congestion.

We thank SBU, one of the proponents of the bill for the opportunity to discuss the potential impacts. We further thank SBU for its testimony in previous hearings that recommended that the determinations of routes, times and locations that lane filtering is allowed be at the discretion of the DOT Director. If the bill is amended to include this provision, DOT has no objection.

Report Title: Transportation; Motorcycle Lane Filtering

Description:

Prohibits motor vehicle operators and occupants from interfering or obstructing motorcycle and motor scooter operators and passengers from cautiously travelling (at a speed not in excess of 10 mph) between lanes of samebound traffic that are stopped at a marked or unmarked intersection or due to congestion, when it is safe to do so, on main streets, roads, highways, and freeways.

SBU Recommends Its Members Support Bill HB No. 727 HD1

For the reason expressly described in the preamble to Bill H.B. No. 727 HD1 (the "Bill") SBU recommends its membership support the Bill and in particular, Lane Filtering as described in the Bill effectively achieves the following benefits at no expense or "external cost" to the Hawai'i motoring public at large:

(1) It reduces the risk of loss of injury and loss of life sustained by Motorcycle operators and passengers (Motorcycle is intended here to include Motor Scooter) caused by rear end accidents from automobiles and other motor vehicles generally. The Motorcycle Safety Foundation of in a report of the US Government Department of Transportation, National Highway Traffic Safety Administration stated:

"A motorcycle's narrow width can allow it to pass between lanes of stopped or slow-moving cars on roadways where the lanes are wide enough to offer an adequate gap. This option can provide an escape route for motorcyclists who would otherwise be trapped or struck from behind. There is evidence (*Hurt*, <u>1981</u>) that traveling between lanes of stopped or slow-moving cars (i.e., <u>lane splitting</u>) on multiple-lane roads (such as interstate highways) slightly reduces crash frequency compared with staying within the lane and moving with other traffic." ¹

Under the National Highway Traffic Safety Administration's ("NHTSA") National Center for Statistics and Analysis, 2005 Report studying causes of "Fatal Two-vehicle Motorcycle Crashes" of the 1,792 Motorcycle and passenger vehicle collisions reported 204 (11%) involved rear-end collisions involving Motorcycles either rear-ending the automobile 139 times (68%) or the automobile rear-ended the Motorcycle 59 time (29%).²

- (2) Motorcycle lane filtering will allow Motorcycles to move through stalled and stopped traffic, especially during gridlock on Oahu's freeways, thereby eliminating overheating problems associated with air-cooled Motorcycles, which, unlike motor vehicles, have no radiators and, therefore, rely on movement to maintain cooling. On freeways, stalled and overheated Motorcycles constitute an additional safety risk to their operators, passengers, and other motorists and safety vehicles. Motorcycle lane filtering eliminates the cause of overheating by allowing motorcycles and motor scooters to move through stopped and gridlocked traffic, thereby eliminating the risk of serious personal injury and property damage.
- (3) Third, motorcycle lane filtering allows motorcycles and motor scooters to move through stopped traffic, which allows alleviation of the traffic congestion and is a positive sum gain in relief from the immediate traffic congestion for all other motorists as well.

Points of Support:

SBU takes the position that the proposed Bill H.B. No. 727 HD1 should be strongly supported by its members as a safety measure for Motorcyclists in the form submitted, on the grounds described and for the reasons outlined above and in particular it accomplishes three clear benefits at no costs, traffic delays, or increased risk of safety or inconvenience to other motorist, in particular:

- 1. Reduced risk of injury or death to Motorcyclists by an approximately 11% reduction in rear-end accidents involving Motorcycles;
- 2. Reduced incidents of stalled and over-heated Motorcycles and thereby reducing the associated costs, inconvenience and risks of injury sustained by Motorists stranded on the highways and freeways by an overheated Motorcycle.
- 3. Some alleviation of traffic congestion as Motorcycles filter through traffic.

Dear Chair Inouye, Vice Chair Dela Cruz and Members of the Committee:

AAA Hawaii was founded in 1915 in Honolulu and is a leader in motorist services and a strong advocate for traffic safety. With more than 157,000 members, service to and the safety of our members, other motorists, and all road users is our founding and continuing purpose.

We have serious traffic safety concerns with the proposal to allow motorcycle lane splitting, sometimes referred to as filtering, in Hawaii, and OPPOSE the proposed legislation.

Hawaii is among the 49 states that prohibit lane-splitting. California is the only state that does not explicitly prohibit lane-splitting. Even in California, where such practice is authorized, in a poll of California drivers in 2012, most drivers disapproved of lane-splitting. They felt it was unsafe and that it might cause a crash. The U.S.D.O.T., National Highway Safety Administration (NHTSA), and the Motorcycle Safety Foundation are calling for more research to provide information about the safety or dangers of lane splitting.

Considering an almost unanimous national restriction on lane splitting, and the call by credible national traffic safety authorities for additional research on this issue, we believe that allowing lane splitting in Hawaii is ill advised and will put traffic safety at risk.

Comments: I am a Motorcycle Safety Foundation Basic and Advanced Rider Course instructor. I am a member of the UK Royal Society for the prevention of accidents, a former Service by Emergency Rider Volunteer for Suffolk-Cambridgeshire UK, and a licensed motorcyclist with 9 years experience. I have operated a motorcycle for 4 years in the UK, a country which allows lane sharing. I testify lane sharing is NOT the reckless act of speeding and weaving between cars. I testify that lane sharing reduces traffic congestion by motorcyclists not taking up a car space in traffic. Lane sharing is safer because rear end collisions are many times more fatal for motorcyclists than grazing accidents according to a study by U.C. Berkeley. There is less likeliness for a collision at intersection because the lane sharing motorcycle's position in the road is not conflicted with a car or truck path of travel. Lane sharing saves fuel and reduces emissions by reducing the amount of time the vehicle is idling in traffic. Lane sharing saves mechanical wear on a motorcycle by allowing air to flow through fins designed to maintain safe operating temperatures. Finally, lane sharing encourages citizens to use this congestion reducing, efficient form of transportation. I urge the Government of Hawaii to ensure the safety, efficiency and happiness of their citizens by supporting this bill.

I support for HB 727. I ride my motorcycle to work approximately 3-5 days a week from Royal Kunia to downtown Honolulu. I've been riding motorcycles for over 40 years and have had my motorcycle license for almost 30 years. I have four reasons I believe we should allow lane filtering:

1) Lowers the risk factor for serious or deadly accidents - Lane filtering would most likely occur when traffic is going at lower speed that is constantly being stopped. During these situations motorcyclists are more concerned about getting hit from behind then getting hit from either side. Lane Filtering provides the option for motorcyclists to put themselves in a safer position when appropriate and necessary.

2) Reduction in traffic congestion - for every motorcycle that is allowed to lane filter it provides an open space for a car or truck behind them to move forward at a stop light. This can allow more vehicles to pass thru an intersection than if the motorcycle were to take an entire lane himself or herself. Also, since motorcycles have a much better horsepower to weight ratio than a car or truck, a motorcycle can exit from a stop light intersection quicker than a car or truck. This allows the motorcycle to "clear out" and move ahead without any hindrance to a car or truck behind or adjacent.

3) Promotion of more fuel-efficient vehicle - Motorcycles average much better fuel efficiency than most cars and trucks. I average near 40 miles per gallon. Other smaller motorcycles can get around 50 MPG. Motorcyclist can save a considerable amount of money on fuel expense and also do less harm to the environment.

4) Creates more attentive drivers - As car drivers become more experienced with motorcyclist lane filtering, they will start to check more closely for motorcycles. This increased attentiveness for motorcycles will benefit all drivers on the road.

H.B. 727 Relating to motorcycles

I have been an active motorcycle rider for approximately 40 years and have operated motorcycles and other vehicles in many countries over that time without a serious accident. As you may imagine, these years of riding have given me an insight of what constitutes a high-risk maneuver. For example, the action of "lane-splitting", or riding a motorcycle between lanes of moving traffic is inherently dangerous to the rider and dramatically increases the probability of a collision. However, this bill proposes "lane-filtering", which is an entirely different action.

Lane-filtering is defined as moving between lanes of stopped traffic. This is an entirely safe operation provided that the rider does so in a responsible manner, including reducing his or her speed to less than 5 miles per hour, and being respectful of other road users when doing so. In my opinion and based on many years of safe riding, this bill in no way increases the probability of a collision, indeed, it may result in decreased collision rates.

Some may oppose this measure based on observations that some intersections may be too narrow to allow this maneuver. I believe that the vast majority of road users are able to distinguish between situations where lane filtering is safe and those where it is not so. To deny progress of this bill based on an assumption that a minority of road users would lane filter in an irresponsible manner is erroneous. Any ability for a motorist to pass another vehicle or change lanes in moving traffic should, by the same definition, be prevented by statute or regulation. Law enforcement personnel currently have statutory provisions to cite unsafe road users and this bill does not prevent them from doing so when a rider lane-filters in an unsafe manner.

The vast majority of road users operate their vehicles in a safe and responsible manner regardless of whether they operate a motorcycle or an automobile. This bill, is practical an sensible and should be endorsed on that basis.
