RE: HB905 (Frozen Food Product Labeling) Position: Oppose

The Hawaii Food Industry Association is comprised of two hundred member companies representing retailers, suppliers, producers, and distributors of food and beverage related products in the State of Hawaii.

As proposed, this labeling required would be inconsistent with federal requirements, and therefore, costly to implement. Hawaii imports 85% of the food consumed in the state. Hawaii's food demands are not large enough to force domestic and foreign fish suppliers to meet these labeling requirements. As such, the cost will be borne by Hawaii's consumers who already pay high prices for seafood.

This is a federal issue and should be dealt with at that level. In addition, the definition of "vendor" within the bill is unclear. We are assuming, however, that it refers to retailers. If this is indeed the case, then we believe that the onus for labeling resting with manufacturers and suppliers, not retailers.

This bill does not serve the best interest of the people of Hawaii- it is unnecessary; it will create huge added expenses for our businesses; and it will drive up the prices of food for all of us. Please hold this measure.
