Purpose of Resolution:

Department's Position:

The Department appreciates the scope and complexity of the question this resolution asks the Department of Budget and Finance to answer, and offers a comment.

Page 4 line 38 of the resolution requests the Department of Education and State Public Charter School Commission to provide data to the Department of Budget and Finance by June 30, 2017. This is a short turn-around time given that:

- 1. the cost categories and type of expenditures in those categories to be used to determine the per-pupil funding amount are not clearly defined by the resolution;
- 2. the data and format to be provided would need to be agreed upon by the Department of Education and State Public Charter School Commission; and

3. any other relevant fiscal information to provide would also need to be agreed upon. In light of the date the requested report is due to the Legislature is 20 days prior to the <u>2019</u> Session, which would be December 28, 2018, <u>allowing additional time for the two parties to</u> <u>agree upon and compile the data may be warranted</u>.

House Concurrent Resolution No. 81 requests that the Department of Budget and Finance (B&F) to conduct a study on: 1) the non-facility general fund per-pupil funding system for public charter schools to determine whether the present system ensures equitable funding among all public schools; and 2) whether the weighted student formula adopted by the Board of Education pursuant to Section 302A-1303.6, HRS, or other alternative weighted student formula funding methodology, may achieve greater funding parity and lead to financial and long-term operational sustainability.

B&F has concerns about the resolution and offers the following comments. Currently, B&F prepares the per-pupil calculation based upon Chapter 302D-28, HRS, and respective provisions within the Budget Acts and transfers general funds accordingly. The determination of funding parity for all public school students, Department of Education and charter schools should involve more than just the calculation of a per-pupil funding amount. The factors that would form the basis for a new or revised calculation should involve broader policy discussions among the stakeholders, including the Legislature.

In addition, policy discussions may need to involve facility funding for charter schools, the process to allocate equitable funding within charter schools, and other related discussions. In the past, working groups/committees have been established to examine similar issues related to funding parity for charter school operations and facilities. However, due to the complexity of the issues, a consensus resolution has yet to be determined, although the current funding formula provides a form of parity for operating funds.

Based on past experience, such complexities may make meeting the timeframes set by the resolution extremely difficult. Additionally, given limited staffing resources, it is unknown whether we can complete such a comprehensive study and report with practical and defensible recommendations.

The Office of Hawaiian Affairs (OHA) **STRONGLY** <u>SUPPORTS</u> HCR81, which is in OHA's current Legislative Package. This resolution requests the Department of Budget and Finance to conduct a two-year study to determine whether the non-facility general fund per-pupil funding system ensures equitable funding for public charter schools, and to consider whether alternative statutory funding options may achieve greater funding parity for public charter schools and lead to their long-term operational sustainability. <u>This</u> <u>measure seeks to better ensure that public charter schools receive their fair share of state education funds, by providing the Legislature with critical information on whether <u>funding parity exists between public charter school students and Department of Education (DOE) students, and/or whether charter schools should exercise their statutory option to receive funding through an alternative method.</u></u>

Our public charter schools, including our Hawaiian culture-based and language immersion schools, have demonstrated their potential to significantly advance the state's educational standards. This includes high rankings in a number of the latest Strive HI SY 2015-2016 performance measures, including in their students' American College Testing (ACT) scores, graduation rates, and college matriculation. However, long-standing concerns suggest that the realization of public charter schools' full potential may be inhibited by funding inequities and challenges.

As this measure points out, the State Public Charter School Commission (Charter School Commission) has warned in its annual reports that financial data from public charter schools reveal both short-term financial strain as well as long-term operational sustainability challenges. Further, questions have been raised about whether the current per-pupil funding system provides equitable funding for public charter schools as compared to DOE schools. Charter schools do have statutory options to receive funding through the weighted student formula adopted by the Board of Education for DOE schools, or through an alternative weighted student formula as proposed to the Board of Education through their authorizer, in lieu of the current per-pupil funding system. However, these

options are available only if approved by more than a two-thirds vote of charter school governing boards; inadequate information currently exists for these boards to weigh the costs and benefits of exercising either option. The study requested in this resolution will provide the Legislature, Board of Education, Charter School Commission and public charter schools with critical information on the adequacy of the current charter school perpupil funding system, and whether the statutory options for weighted student formula funding may result in more equitable outcomes.

OHA notes that a study on public charter school funding is consistent with the recently approved State Board of Education (BOE) updated State Education Strategic Plan 2017-2020 (Plan), which describes the "shared objectives for <u>equity and excellence</u> for every child across Hawai'i's nearly 300 public schools, including our <u>public charter</u> <u>schools</u> and Hawaiian language medium schools"; the Plan also recognizes the need to "<u>maximize allocation of resources toward strategic uses to advance equity and excellence</u> (e.g., through review of base funding in weighted student formula, charter schools' perpupil funding.)" [Emphasis added.]

Therefore, OHA urges the Committee to **PASS** HCR81.

On behalf of the Hawai'i Public Charter School Network (HPCSN), we respectfully submit our strong support for HCR 81, requesting the Department of Budget & Finance to study to the per-pupil funding system for public charter schools.

This concurrent resolution is a request for the Department of Budget and Finance to conduct a study on: (1) whether the non-facility general fund per-pupil funding system for public charter schools ensures equitable funding, and (2) whether alternative statutory funding options available to charter schools may achieve greater funding parity and lead to their financial and long-term operational sustainability.

For the current school year, public charter schools will receive roughly \$7,080 per pupil. This funding level has not been restored to the pre-recession level (approximately \$8,000 per pupil) and has not kept up with rising school costs year over year. A public charter school's per pupil allocation covers teacher and staff salaries, curricula, school services, utilities, facilities and maintenance costs, which are particularly challenging for start up charter schools, which are the majority of Hawaii's charter schools.

Hawai'i's public charter schools are intended to lessen bureaucracy, provide choices, and be innovative in education. State charter school laws have provided education leaders the opportunity to design and operate schools that are more responsive and attuned to the needs of their communities. Hawaiian cultural and language educators, which account for nearly half of the 34 existing public charter schools, are making great strides with providing education for Hawaiian families. Uneven resources to follow the child to their public school of choice and long-standing concerns suggest that the full potential of these schools may be inhibited by funding inequities and challenges.

HPCSN works to support Hawai'i's public charter schools and to be a voice for children and families that seek choice in an independent public school setting. We appreciate the opportunity to provide testimony and respectfully urges your passage of this legislation.
