I do not have current specific information of the ethnic/race or gender background among judges or applicants but it is obvious that Filipinos and women are severely under-represented among lawyers and judges. Appointing a very competent Filipino woman will add to the diversity of judges. Ms. Lendio Heim meets and exceeds the qualifications for this vacancy. Her appointment will be of great benefit to the judiciary and our state. There is good evidence and ethical reasons to support diversity. Programs, decisions and processes are better where there is a diversity of backgrounds, opinions and experiences. These women knew their true potential and did not let existing family, organizational and societal norms define their lives. While Darolyn has not confronted barriers as entrenched in the 1950's Virginia, her story is still remarkable. Darolyn is a Waialua High School graduate who through hard work attended the University of Southern California. After graduating with honors, she attended Boalt Hall at the University of California at Berkeley. Darolyn broke stereotypes when became a litigator first at Goodsill and later at the M4 firm. She next took on pioneering roles as Corporation Counsel and as the Vice President of Legal Affairs and General Counsel. At every step of the way she has worked creatively and with passion for her clients but being mindful of the law and legal ethics.
