- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

The HSBA President and the Executive Director met with Ms. Morikawa on March 29th to discuss the Subcommittee's findings. On March 30th, Ms. Morikawa was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Morikawa was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Heim in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

During the interview of the Ms. Morikawa which included a discourse on her background, professional experiences and reasoning for pursuing the position of District Court Judge of the First Circuit, the nominee demonstrated strong communications skills with her ability to clearly and succinctly respond to questions. In addition to her positive work ethic, Bar members noted her ability to see many facets of varied and complex issues. Ms. Morikawa's service on the Hawaiian Homes Commission and as Honolulu's Housing Coordinator required collaboration and decisiveness in adversarial environments similar to the courtroom setting. I am writing this letter in support of Trish K. Morikawa's nomination to the District Court of the First Circuit. I believe Ms. Morikawa is highly qualified for this position, and her exemplary skills as an attorney, per diem judge, leader and level-headed decision maker make her an excellent choice for District Court Judge.

As a trial attorney, Ms. Morikawa's trial skills are beyond reproach. I've known Ms. Morikawa for over twenty years, both personally and professionally. I have been a State deputy public defender for twelve years, and she and I have practiced law against each other while she was a deputy prosecuting attorney. I can certainly say that she is formidable and intimidating in the courtroom. As a deputy prosecuting attorney, she was highly respected by the attorneys of the Office of the Public Defender and the criminal defense bar. She was a straight-shooter who you could trust when dealing with her. I had many cases against her, and I could always trust her to be honest, prepared, and fair.

As a per diem Family Court judge, Ms. Morikawa takes a measured, well-thought-out approach to her role on the bench. She is not hasty in making her decisions and ensures that she is fully informed of all facts and issues before she rules. Ms. Morikawa possesses the right judicial temperament: calm, collected, measured, and firm. She is not someone who flusters easily, and she can handle herself in situations both good and difficult. She has a calm demeanor, and, because she is always prepared and has a strong command of the law, she can manage issues, personalities, and whatever else may come up in her courtroom. I have the utmost respect for her judgment, and often seek it. She is fair and respectful of others' opinions, even if they may differ from her own. She will carry herself with dignity and pride in all instances when she is presiding over cases.

Ms. Morikawa is highly respected and of the utmost integrity. She has earned my respect over the twenty years that I've known her. She is upfront and speaks with candor. If she says she will do something, she will do it. If she believes in something, she will support it. But, importantly, if she is wrong, she will admit it. I believe that this is the true indicator

of one's character. Ms. Morikawa is not so prideful that she cannot admit when she is wrong. While she is on the bench, she will listen with an open mind, not jump to conclusions, and not let her personal feelings impede her ability to rule fairly in cases. I trust her to make the right decisions, which is all we can ask of any judge.

Ms. Morikawa is dedicated to public service as demonstrated in her years as a deputy prosecuting attorney, deputy attorney general, with the City and County housing department, and as a per diem Family Court judge. In each position, the enormity of her responsibility to the public is not lost on her. She was a fair prosecutor who was experienced enough to know that just seeking a win was not her job: seeking justice was. If she didn't have a case or couldn't meet her elements, she acknowledged it. As a per diem judge, she doesn't just show up for her day of court. She juggles her full-time job at the law firm and her family to show up to Kapolei two days in advance to read through her cases and prepare for court. She takes her responsibilities extremely seriously and does not take her service for granted.

Ms. Morikawa will be an asset to the District Court bench. She is intelligent, levelheaded, realistic and fair – all qualities that I believe are needed in a judge. She is also organized and can handle the daily grind that is the District Court criminal calendar, while her civil background ensures that she can equally handle any civil matters that come her way. Her extensive experience in both criminal and civil law are an asset to the bench since she can handle with either calendar. The fact that she has been doing this job as a per diem Family Court judge for the past year and a half, where she has sat regularly and attended numerous judicial trainings, is even more of an asset. She will seamlessly transition into the position with minimal training needed. That she has been in private practice since 2010 is an added bonus in that she has been away from the Department of the Prosecuting Attorney for a long enough period of time that she has limited personal relationships with the new deputy prosecutors practicing in the District Court.

I support wholeheartedly the nomination of Trish Morikawa for District Court Judge for the District Court of the First Circuit (Oahu). I have known Trish for a little over 20 years; first, when she was a Deputy Prosecuting Attorney at the Honolulu Prosecuting Attorney's Office during two different stints; when she was a Deputy Attorney General in the Criminal Division, when she served under Peter Carlisle's mayoral administration for the City and County of Honolulu, and finally, when she was in the private practice of law with Gallagher, Kane & Amai.

This letter is in support of the nomination of Trish Morikawa to the position of judge of the District Court of the First Circuit.

I met Trish in 2005 while I was working at the Department of Hawaiian Homes Lands ("DHHL"). I was the assistant to the Director, Micah A. Kane. As you know, DHHL is overseen by a commission that has been approved by the State Legislature and Trish acted as one of the commissioners. I personally observed Trish act as a DHHL commissioner for 6 years.

Coming from a Hawaiian background and as a graduate of Kamehameha Schools, Trish was fully qualified to act as a DHHL Commissioner. Having a "Hawaiian heart" is a plus when acting as a commissioner of your peers. Each month, I attended these commission meetings and saw firsthand the challenges a commissioner faced. There were many times when Trish had to make difficult and sometimes heart wrenching decision about DHHL lessees.

For example, at a contested case hearing a commissioner must decide if a DHHL lessee will be evicted from their home because of nonpayment or illegal activities. Many were the times when a lessee would come before the commission and plead NOT to be evicted even though they had been warned many times beforehand that they needed to contact DHHL to prevent eviction.

At these hearings, I observed Trish month after month come to the hearing well prepared; asked questions that were pertinent to the lessee; and if appropriate, make the decision to vote yes or no. Trish knows her laws for sure.

But maybe just as important, she can "read between the lines" to determine if someone is not telling the complete truth. I've heard her call out a lessee for an inappropriate response to questions; heard her scold lessees for not responding to DHHL letters and phone calls. Trish is no push over.

Trish can be tough. When someone tried to pull "a fast one" and not tell the complete truth, she caught that right away. She's a good judge of people.

And Trish has a big heart. When elderly kupuna came before the commission and appeared bewildered by the process, she slowed everything down to be sure the kupuna understood what was happening. More often, Trish would vote to give the kupuna another opportunity to receive counseling from DHHL to find a way to keep a roof over a kupuna's head and to keep her family together.

On a personal side, Trish is a family centered person. In addition to working in a busy law office, she is a wife and mother to 2 children. She does all of this with a heart of Aloha.

I ask that you give Trish your consideration to being a Judge at the District Court of the First Circuit. I believe she will act fairly when necessary but be tough as nails when appropriate. When I think of a judge, I think of someone of unquestionable integrity who is knowledgeable, articulate, fair, committed to the task at hand, and has a strong sense of conviction. Trish exemplifies all of these traits, so in my view she is an ideal candidate. Furthermore, she is well-rounded with over two decades of experience in a variety of courtroom settings, including her work as a per diem judge, and as a prosecutor of career criminals, sexual offenders, child exploitation offenders, and other felons as a Deputy Prosecuting Attorney for the City and County of Honolulu and a Deputy Attorney General for the State of Hawai'i, and more recently as an attorney for insurance and civil cases. While her colleagues know of her legal expertise, I would like to highlight a different side of Trish-her commitment to serve the Hawai'i community.

In her role as team parent for the past three years, she interfaced between the coaches and parents, a diverse group of people brought together by their son's love of soccer. As premium soccer players, these boys had to demonstrate a high level of skill in order to make the soccer team, but there was a fair amount of turnover every season in the younger division. Bringing together a diverse group of parents, with a new bunch of parents thrown into the mix every season, involved a lot of Trish's time, patience, coordination and organization skills, and a good attitude! Her role included getting to know the new parents and players, updating contact lists and the team website, sending out frequent parent communications, compiling parent surveys and reporting back to the head coach, collecting fees, chasing parents to submit player registration paperwork by the deadline, coordinating the snack assignments, distributing and collecting the uniforms each season, organizing potlucks and team bonding events, and doing whatever was asked of her by the coaches and parents. It has been a pleasure working so closely with Trish for these three years. Thank you for giving me this opportunity to speak on Trish Morikawa's behalf.

I have known Trish Morikawa since 2010 when we both worked for the City and County of Honolulu. She was the City's housing coordinator and I was the Director of the Department of Facilities Maintenance. While I was at the City, the City enacted a sidewalk ordinance that required my department to keep sidewalks clear and unobstructed. This effort required displacing homeless and Occupy Honolulu supporters who were camping on the side of city streets and sidewalks.

I worked closely with Ms. Morikawa to develop a plan of action and process for enforcement. She was instrumental in coordinating the efforts of various city and state entities (including the Department of Parks and Recreation, HPD, HCDA), IHS and other homeless shelter providers -- as well as working with private property owners. During implementation of this program, Ms. Morikawa used her analytical and legal skills to guide us through the process. Being a former City Prosecutor, also helped, as she had worked closely and developed good working relationships with HPD in the past.

Throughout this enforcement effort, Ms. Morikawa often accompanied me and my crew to the homeless sites. There were many times when we were criticized, verbally abused, and intimidated by opposition groups. These activities are well documented in videos and are on the internet. During this effort, Ms. Morikawa remained calm, focused, and never forgot the task at hand. I admired her ability to work with diverse stakeholders, many of whom were extremely aggressive in blocking our efforts to enforce the ordinance. I admired her ability to work with the homeless and people from all walks of life to get the job done.
