#### Strong Support for **SB** 1109: Relating to Polystyrene Foam Containers

Dear Chairs Gabbard & Nishihara, and Members of the AEN & PSM Committees,

As the Hawaii Manager of the Surfrider Foundation, I am writing in strong support of SB 1109, the bill to regulate and reduce the use of polystyrene food containers. With five chapters and thousands of Surfrider members in Hawaii, we are committed to reducing the litter and environmental hazards of single-use plastics like styrofoam as part of our popular Rise Above Plastics campaign.

Along with being toxic, polystyrene food products are some of the most littered items in our Islands and the least recycled form of plastic. They are costly too. The recent Hawaii Department of Transportation (DOT) Trash Reduction Plan shows that styrofoam and plastic bags are the top two contributors to our waste stream, and it costs the state millions of dollars to clean them up.

Some opponents will say polystyrene foam containers are recyclable, but less than 1% is ever recycled. They will also say that it's a "litter problem," but the plastics industry has been using this tactic and blaming the public for decades without producing products that are not recyclable. An EPS foam ban was implemented in San Francisco, and there was a 30% decrease in EPS litter within one year (San Francisco Street Litter Re-Audit, 2008). Over 100 cities and counties across the country have enacted EPS foam bans. For an extensive list see: http://www.surfrider.org/pages/polystyrene-ordinances.

They will also say that banning polystyrene food containers will hurt small businesses, but there are many restaurants that have dropped these products and are doing just fine. In fact, the new Ocean Friendly Restaurants Hawaii program has certified more than 115 restaurants that are foam-free since Earth Day 2016!

During our monthly beach cleanups around the state, EPS foam products are among the top items we find every time. In fact, as part of International Coastal Cleanup Day last year, 17,383 cups, plates and pieces of EPS foam were removed from Hawaii's beaches in a single day on Sat., Sept. 19<sup>th</sup>, 2015! That's why we need this bill, which would help reduce these litter problems and environmental issues by requiring restaurants and food service vendors to stop using toxic EPS foam containers.

We embrace a policy of "1, 2, C," meaning products should be recyclable #1 & #2 plastics or compostable, which would help with the state's waste reduction goals. There are many compostable or non-toxic plastic alternatives that can be recycled. This bill provides vendors and restaurants enough time to use their remaining inventory and transition to safer products, which hundreds of restaurants have already done without any problems. Although foam products may be cheaper to buy, they have a hidden cost that counties and citizens have to pay to clean them up.

Although the FDA approved EPS foam products in 1958, the science since then has shown that these are toxic products. Here are some top reasons why EPS foam food service products are dangerous and wasteful:



- 1. EPS foam is a toxic form of plastic made from non-renewable fossil fuels and synthetic chemicals like styrene that leach out over time, especially in contact with hot, greasy or acidic food.
- 2. According to the National Institutes of Health (NIH), styrene is a dangerous carcinogen and neurotoxin that can lead to cancer, lymphoma and leukemia. The EPA says 100% of humans have styrene in their fat tissues.
- 3. Because EPS foam food service products are more than 90% air, they break apart easily and are often blown into our coastal areas and out to sea, where they are listed as one of the top 10 items collected at beach cleanups.
- 4. <u>EPS foam never biodegrades but only breaks into smaller micro-plastics.</u> These pieces act like sponges for toxic chemicals in the ocean and are consumed by marine creatures who mistake them for food. More than 180 marine species are known to eat plastics, including endangered species like sea turtles and albatross.
- 5. Hawaii has one of the highest per capita rates of take-out food in the country, and many food containers are made of EPS foam products whose toxic chemicals threaten the health of humans and the environment.
- 6. Most of these products are hauled to our overflowing landfills where they never degrade but begin to leach toxic chemicals like styrene, a known carcinogen.

Along with the facts above, there have been many scientific studies showing the harmful effects of polystyrene foam. That is why we don't want to delay taking action to reduce foam use and litter. In 2008, the Hawaii Senate passed SR78 SD1 to create a voluntary compliance program to switch from foam products to healthier alternatives, but nothing was ever done to move this forward. And in 2014, the Honolulu City Council passed Resolution 14-175, to study the effects of foam and other single-use products, but the study was never done.

The amount of testimony in both resolutions was overwhelmingly in favor of bills to reduce polystyrene food containers. But those legislative bodies seemed to have been swayed by the exaggerated claims of lobbyists for local foam producers and distributors. The irony is that these same companies already carry and distribute more eco-friendly, recyclable and compostable products because they see the writing on the wall. Scientific research and public sentiment have created a compelling case against these foam products, and more than 100 cities and counties have already enacted successful foam bans.

Hawaii has been an environmental leader in moving forward policies to ban plastic bags and create smoke-free parks & beaches. Now, we ask you to assert that same leadership on this issue. Because Polystyrene food service products are toxic to the environment and human health, their use should be banned. There are many available and affordable alternatives that are non-toxic, biodegradable and pose no threats to the environment or human health and will cost the state and teh counties less to clean up.

Protecting our land and people should be our top priority, not allowing a few companies to profit from outmoded products that harm the environment and our wildlife. Mahalo for your time and leadership on this issue and please feel free to contact me if you have any questions.

Aloha Chairs Gabbard & Nishihara, Members of the joint committee on AE & PSM,

My name is Ashley Nowak and I am a resident of Honolulu, HI. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors.

Working in health care I am absolutely disgusted by the amount of styrofoam waste that accumulates within only hours! A day's worth of cafeteria trash is enough to make me sick. While I understand the convenience and hygenic qualities of single use cups and plates, the magnitude of waste is appaling.

This is secondary only to the fact that nearly all of this waste comes from a material that is not biodegradable, not renewable, harmful to animals, harmful to the environment and toxic to create. Yet this material is so widely available, so inexpensive and so convenient that it is often the number one choice for businesses.

I see these containers everywhere, blowing out of trash cans, floating in the ocean, along fence lines, in streams, all over the beaches, along road sides, in parking lots, along trails, ect, ect. According to cleanup hours recorded across Hawaii's beach cleaning organizations and volunteer hour base rates, we spent \$750,000 - \$1 million on beach cleanups in 2016 alone.

This material should not be the first choice for use as carry-out containers and dinner ware, yet it is, and will continue to be due to it's availability and cost. Styrene is reasonably anticipated to be a human carcinogen and a confirmed animal carcinogen as reported by the National Institute of Health in their Report on Carcinogens (2011); this conclusion is also endorsed by the National Academy of Sciences (2014)¹ The material for fiber containers can be grown and then made here in Hawaii, so more jobs and sustainable ones, not jobs that are exposing workers directly to large amounts of toxic chemicals. EPS can also be made here, but raw, toxic source chemicals need to be shipped to Hawaii. I personally make every attempt to avoid styrofoam when possible and unfortunately that is not good enough due to its pervasive appearance in a majority of businesses. I firmly believe that banning this awful product is the only solution to the 'single-use plastic' problem that is quite literally taking over the world.

- Plastic is costing cities, counties, states, & countries millions of dollars and our global economy billions. Costs are passed to the taxpayers by burdening our storm water management systems with the need for expensive best management practices and the costs of cleanups.
- Hawaii State Department of Transportation has produced a trash plan that shows styrofoam and plastic bags as the top two contributors to the waste stream.<sup>2</sup>
- The Natural Resource Defense Council (NRDC) created a plastic cleanup valuation study for 90+ counties in California:<sup>3</sup>
  - o CA taxpayers are paying \$428 million per year to clean up plastic through storm drain management, street sweeping, and cleanups.
  - San Diego County (with population of 1.3 equivalent to Hawaii) spends \$14
     million alone on plastic cleanup
- United Nations Environmental Program Global Estimates are in the billions for the global cost to cleanup plastics, \$14 billion for marine plastic alone.<sup>4</sup>
  - o This cost is closer to \$78 billion annually if all costs are considered, including the cost lost in fossil fuel production and loss of resources.

#### **Environmental Impact**

- It is argued that styrofoam is acceptable because we can incinerate it for energy. However, this approach is not without significant impacts. According to the Hawaii DOH Clean Air Branch the Covanta H-POWER plant emits 0.15 million metrics tons of carbon dioxide<sup>5</sup> (a potent greenhouse gas) annually. Although touted as a "clean energy solution" for Hawaii, H-POWER only generates about 3% of Oahu's energy needs<sup>6</sup> while still emitting greenhouse gases through burning plastic.
- Further, <u>for each ton of polystyrene not produced</u>, 2.5 metric tons of carbon dioxide emissions are avoided. This directly supports Hawaii's greenhouse gas reduction goals as stated in the Aloha + Challenge and as mandated by the US EPA.<sup>7</sup>
- The U.S. Environmental Protection Agency's Waste Reduction Model (WARM) report shows that burning polystyrene emits more carbon dioxide equivalent than other

- plastics. For each ton of polystyrene incinerated, 1.64 tons of carbon dioxide equivalent are emitted.
- If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size. And burning compostable products come without the toxic ash or smoke that EPS foam creates in the burning process.
- Fiber clamshells are also less than half the volume of EPS, so a restaurant could fit about twice as many clamshells on the same amount of shelf space or have more space for other things.
- The material for fiber containers can be grown and then made here in Hawaii, so more
  jobs and sustainable ones, not jobs that are exposing workers directly to large amounts
  of toxic chemicals. EPS can also be made here, but raw, toxic source chemicals need to
  be shipped to Hawaii.
- EPS is designed to be used it once, and according to the US EPA less than 1% of foam is recycled nationally. 0% of EPS Foam is recycled locally.
- EPS Foam is composed of over 90% air, so even when properly disposed of, foam
  products easily fly out of trash bins and dumpsters, and they enter into the natural
  environment, eventually polluting our ocean and negatively impacting ocean health and
  threatening marine wildlife.
- EPS Foam also breaks apart more easily and quicker than other plastics, making it more difficult to clean up than other plastics and easier for animals to mistake as food and ingest
- According to the EPA Waste Reduction Model Report, 7% of plastic waste generation in US is polystyrene. Of our total plastic recovery, polystyrene makes up 0.7% of recycled plastic

My name is Natalie Wohner and I am a resident of Manoa. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors.

Expanded polystyrene (EPS) foam containers are the least recycled form of plastic and the most littering items found at beach cleanups. EPS foam is also the most toxic food container according to numerous studies, especially when served with hot liquids.

I am very confident in saying that such food containers are simply still in usage because of the lower cost compared to compostable food containers. The main argument in keeping EPS foams around is usually that small businesses could not afford alternatives. But this is wrong. In the state of Hawai'i the number of EPS foam free restaurants is steadily increasing. These restaurants are conciously not using EPS foams because of the above listed reasons. The Surfrider Foundation initiated a movement called Ocean Friendly Restaurants where such restaurants are certified as being EPS foam free. In the past few month 113 restaurants on the Hawaiian islands have been certified, mostly small businesses. The Aina and our health should be our highest priority and it is our role to protect it. I am very optimistic that Hawai'i can play a leader role in protecting our environment from such health and environmental hazards by banning EPS foam food containers.

My name is Samantha Steenhuis and I am a junior at Kaiser High School. I support this bill because I believe protecting the environment should be our number one priority. We can't keep thinking that we can take so many resources from the earth and not feel any consequences. Everything we do and use has a direct link to the environment.

I moved to the island a little over a year and a half ago from Washington state, and I instantly fell in love with the beaches and friendly atmosphere. I now live in Hawaii Kai and often visit the surrounding parks and beaches. However, every time I go to the beach I am disappointed to see so much trash on the shore, a lot of which is styrofoam and other plastics.

Since we live on an island, a lot of our waste ends up in the ocean! According to a study done by the World Economic Forum, they estimate that there will be more plastic in the ocean than fish by 2050 if we continue down this unsustainable path. We already have more than 150 million tons of trash floating in the ocean in forms of "garbage patches." There are multiple areas around the world that collect trash and become extremely hard to clean up because it is often in the form of small pieces, or micro plastics. Styrofoam is extremely harmful to our marine life because it breaks apart into small chunks, which then birds and fish think are food. Dianna Parker from the National Oceanic and Atmospheric Administration (NOAA) Marine Debris Program says, "We know that some species of birds and fish eat microplastics. They even eat some larger plastics. For example, the Laysan Albatross in the Northwestern Hawaiian Islands. We know that just about every dead albatross found on Midway Atoll has some form of plastic in its stomach. We don't know if that's what killed it, but we know that this is becoming a big problem. So we know that there are microplastics in the ocean. We know that birds and fish and even some larger marine mammals eat these plastics. We know there are chemicals in the plastics and we know that the chemicals can absorb other toxic chemicals that are floating around in the ocean."

The largest known area is known as the "Great Pacific Garbage Patch" and the majority of trash collected in it isn't biodegradable and doesn't wear down. According to the National Ocean Service, "about 80% of the debris in the Great Pacific Garbage Patch comes from land-based activities in North America and Asia." We are in an area where a lot of trash is constantly floating around us, and we will continue to contribute to the destruction unless we do something about it!

I have participated in many environmentally based activities, including beach cleanups and service projects. I am a member of LEAP club at my school, which stands for Leave Earth At Peace. Our club's main goal is to bring awareness of environmental problems to other students and people. We have done gardening events in the community and are also trying to make composting available at Kaiser. Passing this bill would allow for us to make a much bigger positive impact on minimizing our waste, because the styrofoam lunch trays our school currently uses would be replaced with biodegradable or compostable products. This bill would be a huge step forward in creating an eco-friendly future for schools across the islands and keeping our environment safe.

I hereby would like to testify in support of this bill. My name is Paula Moehlenkamp, I am from Senator Stanley Chang's district, and I have been living in Hawaii for 2 years now. I am a graduate student in the Department of Oceanography at UH Manoa.

I decided to become foam free, because I feel this is, where I can start contributing a little to a more sustainable world. Plastic waste is something that can successfully be regulated on a local level and make a great difference. In my opinion, it is largely unnecessary to eat from styrofoam containers as there is more sustainable alternatives available.

First of all, the environmental impact of EPS is large: EPS is being designed to be used it once, and according to the US EPA less than 1% of foam is recycled nationally. 0% of EPS Foam is recycled locally. EPS Foam is composed of over 90% air, so even when properly disposed of, foam products easily fly out of trash bins and dumpsters, and they enter into the natural environment. Snorkeling or diving in the waters around Hawaii, I have frequently encountered styrofoam containers or parts of them.

EPS Foam also breaks apart more easily and quicker than other plastics, making it more difficult to clean up and easier for animals to mistake as food and ingest. During my degree I have worked on microplastic pollution, which presents a threat for marine life and ultimately us as we base our living on resources from the ocean. Once released into the marine environment, wave action, sun and wind break large plastic pieces into microplastics, which then are impossible to collect and small enough to be ingested by organisms at the bottom of the food web. As plastic surfaces readily adsorb heavy metals and other toxins, bioaccumulation and magnification are valid concerns.

Besides environmental impacts, the onetime use of styrofoam is costly: Plastic is costing cities, counties, states, & countries millions of dollars and our global economy billions. Costs are passed to the taxpayers by burdening our storm water management systems with the need for expensive best management practices and the costs of cleanups.

This is largely unnecessary as we have good alternatives: Compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size. And burning compostable products come without the toxic ash or smoke that EPS foam creates in the burning process. The material for fiber containers can be grown and then made here in Hawaii, so more jobs and sustainable ones can be created.

In conclusion, the use of styrofoam presents an unnecessary environmental threat, because there are good alternatives. In addition, styrofoam is costly for the consumer and bears potential health risks.

For these reasons, I strongly support the Styrofoam ban. Thank you for your attention.

There are many better alternatives to styrofoam to carry food in from bringing your own container to more compact, but able, home grown fiber food containers. There is no way we should be using an unrecyclable, toxic burning, ocean clogging product on our fragile small island ecosystem. The U.S. Environmental Protection Agency's Waste Reduction Model (WARM) report shows that burning polystyrene emits more carbon dioxide equivalent than other plastics. For each ton of polystyrene incinerated, 1.64 tons of carbon dioxide equivalent are emitted. If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size. And burning compostable products come without the toxic ash or smoke that EPS foam creates in the burning process. Fiber clamshells are also less than half the volume of EPS, so a restaurant could fit about twice as many clamshells on the same amount of shelf space or have more space for other things. The material for fiber containers can be grown and then made here in Hawaii, so more jobs and sustainable ones, not jobs that are exposing workers directly to large amounts of toxic chemicals. My name is Kristen Harmon and I am a resident of Honolulu. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors. Polystyrene foam is one of the most littered and least recycled forms of plastic.

Plastic is costing cities, counties, states, & countries millions of dollars and our global economy billions. Costs are passed to the taxpayers by burdening our storm water management systems with the need for expensive best management practices and the costs of cleanups. Hawaii State Department of Transportation has produced a trash plan that shows styrofoam and plastic bags as the top two contributors to the waste stream. The Natural Resource Defense Council (NRDC) created a plastic cleanup valuation study for 90+ counties in California:CA taxpayers are paying \$428 million per year to clean up plastic through storm drain management, street sweeping, and cleanups. San Diego County (with population of 1.3 equivalent to Hawaii) spends \$14 million alone on plastic cleanup. United Nations Environmental Program Global Estimates are in the billions for the global cost to cleanup plastics, \$14 billion for marine plastic alone. This cost is closer to \$78 billion annually if all costs are considered, including the cost lost in fossil fuel production and loss of resources. Burden on the public. According to cleanup hours recorded across Hawaii's beach cleaning organizations and volunteer hour base rates, we spent \$750,000 - \$1 million on beach cleanups in 2016 alone.

It is argued that styrofoam is acceptable because we can incinerate it for energy. However, this approach is not without significant impacts. According to the Hawaii DOH Clean Air Branch the Covanta H-POWER plant emits 0.15 million metrics tons of carbon dioxide (a potent greenhouse gas) annually. Although touted as a "clean energy solution" for Hawaii, H-POWER only generates about 3% of Oahu's energy needs while still emitting greenhouse gases through burning plastic. Further, for each ton of polystyrene not produced, 2.5 metric tons of carbon dioxide emissions are avoided. This directly supports Hawaii's greenhouse gas reduction goals as stated in the Aloha + Challenge and as mandated by the US EPA. The U.S. Environmental Protection Agency's Waste Reduction Model (WARM) report shows that burning polystyrene emits more carbon dioxide equivalent than other plastics. For each ton of polystyrene incinerated, 1.64 tons of carbon dioxide equivalent are emitted. If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size. And burning compostable products come without the toxic ash or smoke that EPS foam creates in the burning process. Fiber clamshells are also less than half the volume of EPS, so a restaurant could fit about twice as many clamshells on the same amount of shelf space or have more space for other things. The material for fiber containers can be grown and then made here in Hawaii, so more jobs and sustainable ones, not jobs that are exposing workers directly to large amounts of toxic chemicals. EPS can also be made here, but raw, toxic source chemicals need to be shipped to Hawaii. EPS is designed to be used it once, and according to the US EPA less than 1% of foam is recycled nationally. 0% of EPS Foam is recycled locally. EPS Foam is composed of over 90% air, so even when properly disposed of, foam products easily fly out of trash bins and dumpsters, and they enter into the natural environment, eventually polluting our ocean and negatively impacting ocean health and threatening marine wildlife. EPS Foam also breaks apart more easily and quicker than other plastics, making it more difficult to clean up than other plastics and easier for animals to mistake as food and ingest. According to the EPA Waste

Reduction Model Report, 7% of plastic waste generation in US is polystyrene. Of our total plastic recovery, polystyrene makes up 0.7% of recycled plastic.

My name is Fred W. Styer and I am a resident of Kauai County. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors. Polystyrene foam is one of the most littered and least recycled forms of plastic.

Primary supporting factors:

#### Human Health

- A common practice is to re-heat food held in Styrofoam containers. Early combustion begins at 375° F emitting harmful and possibly carcinogenic by-products into the food they eat.
- Styrene is a confirmed animal carcinogen and a suspected human carcinogen (The National Institute of Health, 2011); this conclusion is also endorsed by the National Academy of Sciences (2014)
- We already have a healthy compostable alternative used in high-profile restaurants like <u>Duke's Canoe Club on Kauai</u>.
- The material for fiber containers is now cost-competitive and can be grown in Hawaii to produce safe, compostable food containers while also creating sustainable jobs.

### **Environmental Impact:**

- Polystyrene materials are extremely slow to decompose. They are very light and tend to follow where the wind goes, much like the plastic bags recently banned on Kauai. Foam quickly breaks into small particles and consumed by surrounding birds and ocean fauna.
- The U.S. Environmental Protection Agency (EPA) published a report showing that burning polystyrene emits more carbon dioxide equivalent than other plastics.
- If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size without the toxic ash or smoke that EPS foam creates in the burning process.

#### Cleanup Costs & Economic Benefits:

- Hawaii State Department of Transportation (DOT) just produced a trash plan that shows Styrofoam and plastic bags as the top two contributors to the waste stream. The plan says that banning these wasteful single-use products could save the state millions of dollars.
- United Nations Environmental Program estimates that it costs billions globally to clean up plastics, \$14 billion for marine plastics alone.
- To clean up this litter, much of the burden has been put on environmental groups whose volunteers spend thousands of hours cleaning up Hawaii's beaches and coastal areas.

Aloha,

My name is Jamee Allen and I am an undergraduate student at the University of Hawaii at Manoa studying natural resource management. I am also the environmental chair of the Young Progressives Demanding Action Honolulu chapter, a group of 570+ registered members of esteemed community members of Oahu. Given the nature of my studies, it has been called to my attention the adverse effects polystyrene foam and plastics have on our environment. Most people direct their concerns on the pollution of polystyrene – which is, of course, a valid point of concern. What I am bringing to your attention today, however, are the lifecycle impacts that polystyrene and other plastics have on our environment. For the purpose of this testimony, I will use Styrofoam and polystyrene interchangeably.

During the production of Styrofoam, hydrofluorocarbons (HFCs) are released into the air. This is a major greenhouse gas that is now believed to be 3-5 times more dangerous to the ozone than previously thought.¹ Styrofoam is made from the chemicals benzene and styrene which are both known to be carcinogenic to humans. Roughly 90,000 workers are exposed to these chemicals in production each year, increasing their likelihood of severe adverse health effects such as Parkinson's disease and leukemia.¹ Additionally, a report done by UNEP, *Valuing Plastic*, states that material extraction for Styrofoam causes \$13 billion in downstream environmental damages, of which they report is likely a generous estimate.

After production, the US EPA calculated that less than 1% of Styrofoam is recycled nationally. The rest is gone to landfill, incineration, or to the ocean – all of which have damaging impacts on the environment and human health. The UN states that roughly \$75 billion are spent in response to the negative marine and atmosphere impacts from incinerating plastic. Millions of dollars are going into cleanup efforts to remove Styrofoam and other plastics from beaches, oceans, streams, and other locations that attract tourists and natural biodiversity. Not only is Styrofoam pollution hazardous for wildlife (which can ingest or choke on smaller pieces of Styrofoam), it can also detract tourism. Nothing serves as more of an eyesore than large plastics sitting on beautiful, white sand beaches. As Hawaii's economy is predominantly dependent on tourism, preventing Styrofoam from landing on our beautiful beaches would be worth considering.

I ask you, our leaders, to prohibit Styrofoam from these beautiful islands. Although this bill will not make Styrofoam completely obsolete from Hawaii, it is certainly a big step that will stir momentum. If we can pass this bill, SB 1109, we will make a milestone for our generation, and future generations, to release our dependence on limited, unsustainable resources.

Jamee Allen Young Progressives Demanding Action Environmental Chair Aloha,

Please ban polystyrene foam – commonly referred to by the brand name Styrofoam. We need to join the numerous forward thinking cities like New York, who have banned the use of this outdated material.

The problems are numerous. Polystyrene foam doesn't break down easily, and it's easily dispersed by the wind, creating a litter problem in streets and local waterways. Aside from the litter problem, there are the health effects of the chemicals that make up extruded polystyrene foam or EPS.

The biggest concern that we should have as a state surrounded by marine environments are the problems caused by 'Styrofoam' when it leaks into marine environments and contaminates water. According to Douglas McCauley, a marine biology professor at the University of California, Santa Barbara, there are two main issues that polystyrene causes for marine animals - mechanical and chemical.

"The [mechanical root] is very straight-forward," said McCauley, "Oftentimes, we find polystyrene foam lodged in the intestines that causes blockages that can be lethal. If you think about how we worry about a mild blockage from eating the wrong thing, imagine eating a ball of Styrofoam. That's what some of these animals are doing."

Chemically, absorbent properties make 'Styrofoam' even more dangerous. "Polystyrene foams essentially act like little pollutant sponges, picking up and concentrating some of the nastiest contaminants in the ocean," McCauley says. "Then something like a sea turtle comes along and eats this thinking it is a jellyfish."

That's not just bad for the fish and the oceans. It could be bad for humans. We are already aware of the huge problem that microplastics pose to our islands and this merely adds to that. We should all be extremely concerned that the plastic eating fish are ending up back on our plates. Would you want you or anyone in your 'ohana to eat these fish?

There is the argument that instead of banning, we should aim to recycle. However, the difficulty in recycling EPS was a main reason New York City enacted the ban. It has not been proven that recycling dirty foam can be done on a large scale, and there is no demonstrated market for this material. Furthermore, due to the chemical process that turns polystyrene beads into EPS, it's nearly impossible to turn an EPS plate, for example, into an EPS takeaway box. You couldn't just take recycled Styrofoam cups and make molds again because it's already expanded," says Joe Biernacki, professor of chemical engineering at Tennessee Tech University.

If more cities across the country follow the lead of cities who have already instituted a ban, the alternatives will soon become more plentiful and will cost less.

Please join the ban on Styrofoam and mālama our 'āina.

I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors. Polystyrene foam is one of the most littered and least recycled forms of plastic. Cleanup Costs & Economic Benefits: • Hawaii State Department of Transportation (DOT) just produced a trash plan that shows styrofoam and plastic bags as the top two contributors to the waste stream. The plan says that banning these wasteful single-use products could save the state millions of dollars. • The Natural Resource Defense Council (NRDC) created a plastic cleanup valuation study for 90+ counties in California, showing that tax payers bear the burden of cleanup costs: o CA taxpayers are paying \$428 million per year to clean up plastic through storm drain management, street sweeping, and cleanups. o San Diego County (with population of 1.3 equivalent to Hawaii) spends \$14 million each year cleaning up plastic litter. • United Nations Environmental Program estimates that it costs billions globally to clean up plastics, \$14 billion for marine plastics alone. • To clean up this litter, much of the burden has been put on environmental groups whose volunteers spend thousands of hours cleaning up Hawaii's beaches and coastal areas. Environmental Impact: • The U.S. Environmental Protection Agency (EPA) published a report showing that burning polystyrene emits more carbon dioxide equivalent than other plastics. • If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size without the toxic ash or smoke that EPS foam creates in the burning process. • The material for fiber containers can be grown and made in Hawaii, and that would create more sustainable jobs and not expose workers to large amounts of toxic chemicals. • EPS Foam is designed to be used once, and according to the US EPA less than 1% of foam is recycled nationally. 0% of EPS Foam is recycled locally. • EPS Foam is composed of over 90% air. So foam products easily fly out of trash bins and dumpsters and enter into the natural environment. They pollute our coastal waters and negatively impact ocean health and threaten marine wildlife. • EPS Foam also breaks apart more easily than other plastics, making it more difficult to clean up and easier for animals to mistake it as food and ingest. • According to the EPA Waste Reduction Model Report, 7% of plastic waste generation in US is polystyrene. Human Health • Styrene is a confirmed animal carcinogen and a suspected human carcinogen (The National Institute of Health, 2011); this conclusion is also endorsed by the National Academy of Sciences (2014) • When combusted, styrene produces many harmful and possibly carcinogenic byproducts. #### SB1109

RELATING TO POLYSTYRENE FOAM CONTAINERS.

Prohibits the use of polystyrene foam containers by food vendors beginning 1/1/18, unless: (1) the county in which the food vendor works has established a polystyrene foam container recycling program; or (2) DOH allows an exemption.

As a 14-year resident of this beautiful state, I give my strongest encouragement to ban polystyrene foam food containers across Hawaii. Foam is terrible for the environment and our health. Please take this opportunity to provide unwavering leadership and stewardship of our precious island resources and environment.

#### **Economics**

Polystyrene is currently cheaper (cost per unit) because of economies of scale, but better alternative products (paper, biopolymer, etc) should become at least as affordable if not more so if the demand is there. The argument that polystyrene containers are "more affordable" does not factor in the critical (and largely irreversible) costs of a degraded and poisonous living environment. Short-term economic pain should not weigh on this decision — the legislature could support short-term subsidies toward alternative container costs to assuage restaurant owners' concerns.

#### Health

Polystyrene is horrible for our health. Toxic chemicals leach out of these products into the food that they contain (especially when heated in a microwave). These chemicals threaten human health and reproductive systems. Styrene is classified as a possible human carcinogen by the EPA and by the International Agency for Research on Cancer (IARC).

#### Environment

The process of making polystyrene pollutes the air and creates large amounts of liquid and solid waste. These products are made with petroleum, a non-sustainable and heavily polluting resource.

Polystyrene degrades poorly and ruins our land and marine environments. We all know that despite best efforts to reduce littering, an alarming amount of rubbish (including polystyrene products) finds its way onto our land and into our waterways.

Recycling polystyrene, although possible, is not practical and is not done here in Hawaii. The argument that most foam food containers are burned by H-POWER must consider the toxicity of burning polystyrene and the resulting ash. A 1986 EPA report on solid waste named the polystyrene manufacturing process as the 5th largest creator of hazardous waste. The National Bureau of Standards Center for Fire Research identified 57 chemical byproducts released during the combustion of polystyrene foam. H-POWER requires a minimum amount of rubbish burned each year, which is incredibly problematic and removes any incentive for the state to

encourage trash reduction, recycling, and composting. That large-scale composting is not done is no excuse for it not to be encouraged and implemented.

The polystyrene industry, like most entrenched industries, does not change easily and is incredibly powerful regarding economic positioning, governmental support, and consumer comfortability. It often takes too long without governmental intervention to do the right thing when it comes to protecting our health and our environment. Thank you for your leadership in instituting the change needed for us to continue a healthy, sustainable, and high-quality way of life.

Aloha Chairs Gabbard & Nishihara, Members of the joint committee on AE & PSM,

My name is Clarice Schafer and I am a resident of Moiliili, Honolulu, HI. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors.

Although many people have heard that Styrofoam is detrimental to the planet, few understand how Styrofoam harms the environment and our health. Over the years, information about harmful effects of Styrofoam/EPS on people's health and the environment have been accumulating. Here are some reasons why you should support SB1109:

### Cleanup Costs & Economic Benefits

- Plastic is costing cities, counties, states, & countries millions of dollars and our global economy billions. Costs are passed to the taxpayers by burdening our storm water management systems with the need for expensive best management practices and the costs of cleanups.
- Hawaii State Department of Transportation has produced a trash plan that shows styrofoam and plastic bags as the top two contributors to the waste stream.<sup>1</sup>
- The Natural Resource Defense Council (NRDC) created a plastic cleanup valuation study for 90+ counties in California:<sup>2</sup>
  - CA taxpayers are paying \$428 million per year to clean up plastic through storm drain management, street sweeping, and cleanups.
  - San Diego County (with population of 1.3 equivalent to Hawaii) spends \$14 million alone on plastic cleanup
- United Nations Environmental Program Global Estimates are in the billions for the global cost to cleanup plastics, \$14 billion for marine plastic alone.<sup>3</sup>
  - This cost is closer to \$78 billion annually if all costs are considered, including the cost lost in fossil fuel production and loss of resources.
- Burden on the public

 According to cleanup hours recorded across Hawaii's beach cleaning organizations and volunteer hour base rates, we spent \$750,000 - \$1 million on beach cleanups in 2016 alone.

#### **Environmental Impact**

- It is argued that styrofoam is acceptable because we can incinerate it for
  energy. However, this approach is not without significant impacts. According to the
  Hawaii DOH Clean Air Branch the Covanta H-POWER plant emits 0.15 million metrics
  tons of carbon dioxide<sup>4</sup> (a potent greenhouse gas) annually. Although touted as a "clean
  energy solution" for Hawaii, H-POWER only generates about 3% of Oahu's energy
  needs<sup>5</sup> while still emitting greenhouse gases through burning plastic.
- Further, for each ton of polystyrene not produced, 2.5 metric tons of carbon dioxide emissions are avoided. This directly supports Hawaii's greenhouse gas reduction goals as stated in the Aloha + Challenge and as mandated by the US EPA.<sup>6</sup>
- The U.S. Environmental Protection Agency's Waste Reduction Model (WARM) report shows that burning polystyrene emits more carbon dioxide equivalent than other plastics. For each ton of polystyrene incinerated, 1.64 tons of carbon dioxide equivalent are emitted.
- If burned at HPower, one compostable clamshell burns 1.76 times greater energy compared to one EPS Foam clamshell of the same size. And burning compostable products come without the toxic ash or smoke that EPS foam creates in the burning process.
- Fiber clamshells are also less than half the volume of EPS, so a restaurant could fit about twice as many clamshells on the same amount of shelf space or have more space for other things.
- The material for fiber containers can be grown and then made here in Hawaii, so more
  jobs and sustainable ones, not jobs that are exposing workers directly to large amounts
  of toxic chemicals. EPS can also be made here, but raw, toxic source chemicals need to
  be shipped to Hawaii.
- EPS is designed to be used it once, and according to the US EPA less than 1% of foam is recycled nationally. 0% of EPS Foam is recycled locally.
- EPS Foam is composed of over 90% air, so even when properly disposed of, foam
  products easily fly out of trash bins and dumpsters, and they enter into the natural
  environment, eventually polluting our ocean and negatively impacting ocean health and
  threatening marine wildlife.

- EPS Foam also breaks apart more easily and quicker than other plastics, making it more difficult to clean up than other plastics and easier for animals to mistake as food and ingest
- According to the EPA Waste Reduction Model Report, 7% of plastic waste generation in US is polystyrene. Of our total plastic recovery, polystyrene makes up 0.7% of recycled plastic

### <u>Human Health</u>

- Air pollution from polystyrene
  - Styrene is reasonably anticipated to be a human carcinogen and a confirmed animal carcinogen as reported by the National Institute of Health in their Report on Carcinogens (2011); this conclusion is also endorsed by the National Academy of Sciences (2014)<sup>7</sup>
  - When combusted, styrene produces benzaldehyde (US EPA classifies this as a hazardous substance), acetophenone (Group D carcinogen by US EPA, causes chromosomal damage on hamsters, but hasn't been tested in humans), styrene oxide (main metabolite of styrene, which is known as carcinogenic).
