So foam products easily fly out of trash bins and dumpsters and enter into the natural environment. They pollute our coastal waters and negatively impact ocean health and threaten marine wildlife. • EPS Foam also breaks apart more easily than other plastics, making it more difficult to clean up and easier for animals to mistake it as food and ingest. • According to the EPA Waste Reduction Model Report, 7% of plastic waste generation in US is polystyrene. Human Health • Styrene is a confirmed animal carcinogen and a suspected human carcinogen (The National Institute of Health, 2011); this conclusion is also endorsed by the National Academy of Sciences (2014) • When combusted, styrene produces many harmful and possibly carcinogenic byproducts.

#### RE: SB 1109 - OPPOSE

The American Chemistry Council (ACC) must respectfully oppose SB 1109. ACC and its members certainly support efforts to reduce litter and marine debris; however, SB 1109 appears to be drafted under the false assumption that alternatives to polystyrene food service containers are environmentally preferable.

All packaging leaves an environmental footprint regardless of the material type. It takes energy and raw materials to produce, transport, and recover or dispose of any material. So it is important to measure all of these impacts throughout the entire lifecycle of a product. Consider the following:

- Polystyrene cups weigh anywhere from two to five times less than comparable paper packaging products <u>which</u> means fewer air emissions when transporting products<sup>1</sup>.
- A polystyrene hot beverage cup requires about 50% LESS energy to produce than a similar plastic-coated paperboard cup with a corrugated cup sleeve, and creates significantly fewer greenhouse gas emissions than a similar coated paper-based cup with its corrugated sleeve.
- Studies conducted for Seattle Public Utilities (SPU) showed that banning polystyrene foam food take-out
  containers would dramatically increase environmental impacts by doubling the greenhouse gas emissions,
  energy use, and waste associated with the use of alternative products<sup>2</sup>.

The amount of polystyrene foam foodservice that makes up litter is very small – measured at 1.5 percent of the overall litter stream in detailed litter surveys conducted in the U.S. and Canada<sup>3</sup>. ACC certainly shares your concerns over the implications of litter; however, focusing on a single material type does not reduce litter. The City of San Francisco banned polystyrene containers, but according to a 2008 litter audit conducted for the city, paper cup litter increased after the ban was enacted<sup>4</sup>. Bans result in litter substitution, not elimination.

It is also important to note that "bio based" or "degradable containers" only "degrade" in a controlled composting environment – essentially a large industrial facility where temperatures can exceed 140 degrees for several days. Hawaii does not currently have a commercial composting facility to process compostable alternatives, so these products will

end up in a landfill. Biodegradable containers do not degrade if littered alongside the road, deposited into a trash can, nor will they degrade if they make their way into a storm drain or other water body.

The Biodegradable Products Institute (BPI), a not-for-profit association of key individuals and groups from government, industry, and academia seeks to educate manufacturers, legislators and consumers about the importance of scientifically based standards for compostable materials which biodegrade in large composting facilities. Under their "Myths of Biodegradation", BPI states:

- Myth: Biodegradable products are the preferred environmental solution because waste simply biodegrades in the landfill.
- Reality: Nothing biodegrades in a landfill because nothing is supposed to<sup>5</sup>.

Furthermore, replacements for polystyrene products will likely result in higher operating costs for restaurants, caterers, delis, and other food providers. Polystyrene containers cost 2-3 times less than replacement products, which in some cases do not perform well, especially for very hot and cold food and beverages.

For more than 50 years, the U.S. Food and Drug Administration has approved the use of polystyrene for foodservice products. Polystyrene foodservice products offer a sanitary way to serve fresh food and to help prevent the spread of disease at schools, restaurants, and hospitals.

Health experts and agencies (see included attachment) have all agreed and stated that styrene should not be confused with polystyrene, and levels of styrene in polystyrene foodservice products pose no risk to consumers. It's important to understand the differences between styrene and polystyrene. Styrene, a liquid, and polystyrene, a solid, are fundamentally different. Styrene is a liquid that can be chemically linked to create polystyrene, which is a solid plastic that displays different properties. Polystyrene is an inert plastic that can be used to make many products, such as polystyrene foam used to make disposable plates, cups and other foodservice packaging.

ACC and its members take seriously the issue of litter and marine debris. To that end, ACC is working domestically and internationally with government officials, retailers, anti-litter groups and consumers to devise solutions to prevent litter and marine debris.

Some of our more recent activity includes helping develop new and innovative recycling programs nationwide; promoting industry-wide practices to contain plastic pellets; partnering with governments and conservationists to encourage recycling and discourage litter; working to educate children on the link between litter and marine health; working with the National Oceanic and Atmospheric Administration to advance scientific understanding of marine debris; and continuing to innovate and develop smaller, lighter packaging. More information about our activities to help reduce marine debris can be found at: <u>http://www.marinedebrissolutions.com/default.aspx</u>

Additionally, last year ACC partnered with the City and County of Honolulu on a pilot project to find and close off potential pathways for trash from land-based sources to migrate into the marine environment. One of the primary sources of litter found near waterways and beaches on Oahu is uncovered public trash cans that allow garbage to blow out. Through our partnership, ACC and the City and County of Honolulu identified a better design for outdoor public garbage cans to keep trash out of parks, and most importantly, out of waterways and the ocean. We anticipate these new and improved bins to be installed in Ala Moana Park in March.

ACC believes that reducing landfill disposal, marine debris and litter requires the implementation of a variety of tools. In addition to efforts that seek to increase recycling and improve solid waste collection infrastructure, opportunities to recover non-recycled plastics may be an option as well. An emerging set of technologies is allowing governments and businesses to convert non-recycled plastics into energy, fuels, and feedstocks, or raw materials for new

manufacturing. A range of energy recovery technologies are being used to complement recycling in helping to divert more valuable post-use materials from landfills. Some of the most widely used and rapidly emerging technologies include waste-to-energy, plastics-to-fuels, gasification, and solid recovery fuels. It is for this reason that we support HB 749, legislation that would direct the state and each county to consider "waste-to-energy" as a potential solid waste management practice and process.

A twelve-member panel of international experts selected by the <u>Harvard Center for Risk Analysis</u> reported in 2002 that the very low levels of styrene present in foods – whether naturally occurring or from polystyrene foodservice products – does not represent a concern to human health.

S.B. No. 1109- Polystyrene Food Containers; Food Vendors; DOH

Good afternoon, honorable committee members. My name is Nadia Garcia and I am testifying as an individual citizen. My position is in support of SB 1109 relating to polystyrene foam containers.

As a citizen with experience as a local sandwich shop entrepreneur as well as a waste diversion leader for Sustainable Coastlines Hawaii for the past 3 consecutive years, I recommend cutting the ease of access to polystyrene foam containers on our island. As a waste diversion leader I help execute waste diversion strategies for the Vans Triple Crown of Surfing and other large scale and long term events on Oahu. I have seen the World Surf League make sustainability a top-line priority first hand and have observed participants partake with enthusiasm. There should be mandates in effect to decrease environmental impacts from our food market and improve community impact because it is viable on many levels.

Many factors make Hawaii unique, one of which being its geographical positioning. It is like a magnet for marine debris and thousands of pounds of trash that washe up from the ocean. We should not contribute to this predating problem. The demand to reduce plastic consumption, such as that of which is in question is at an all time high. We should stop this waste from being created in the first place by eliminating its acquisition. It is practicable to displace polystyrene food ware with alternatives, such as compostable food ware.

Polysterene foam is one of the most common and toxic forms of litter pollution in Hawaii. It is also listed as a human carcinogen on the US National Toxicology Report. Also, it is one of the main materials that the Ocean Friendly Restaurants program is trying to eliminate. The Ocean Friendly Restaurants program is an initiative of the Surfrider Foundation that encourages eateries to put the ocean before the bottom line. It now has now certified at least 113 restaurants state-wide and is consistently growing its base.

When I started a smoothie and sandwich shop, I went to Chef Zone for food ware supplies. The shop I coowned was an initiative to support local growth and food sustainability. I was dampened to find the compostable containers were significantly more expensive than the polystyrene foam containers. To purchase any container but polystyrene was unviable for me as a new business owner. Regretfully, I had to purchase the polystyrene foam containers. It was especially dissonant to me because I understood what detriments the purchase of polystyrene alludes to. This lack of accessibility to ecologically choice options for food vendors and their customers puts well intentioned consumers in a position that perpetuates an unattainable environmentally sustainable future.

Encouraging ecologically sustainable options for our food market will have long-term returns for the vitality of our environment and nurture our community en passant. I urge the committee to help us malama our community and perpetuate environmental stewardship by taking appropriate action and passing SB 119. I thank the committee for their time and consideration of my testimony.

My name is Marvin Heskett and I am a resident of Palolo. I am writing in full support of SB1109 to prohibit the use of polystyrene foam containers by food vendors. Polystyrene foam is one of the most littered and least recycled forms of plastic.

As a life time advocate and participant in beach cleanups, it pains me to consider how many Styrofoam clamshells and plates, discarded by residents and tourists, intentional or by accident, that I've picked up off of our leeward coasts. We have become painfully aware of the marine debris issue the coastal globe is currently facing. What pains me worse than the knowledge of how many hundreds of items I've personally removed, is all of those that I, and other concerned members of our community, missed. Hawaii shamefully currently contributes significantly to the growing garbage patch of the north Pacific Gyre. One of our greatest exports to the gyre is the lightweight, flyaway Styrofoam single use containers. We're sacrificing the Ocean environment that we love so much for a few moments of added convenience. Hawaii State Department of Transportation (DOT) just produced a trash plan that shows Styrofoam and plastic bags as the top two contributors to the waste stream. The plan says that banning these wasteful single-use products could save the state millions of dollars.

Not only are we shamefully sending off unsightly rubbish, to our pristine life support system, but we are poisoning her inhabitants as we do. On a recent work trip to the northwest Hawaiian Islands, I bore personal witness to the remains of once grand albatross, withered with body cavities full of single use plastics, especially light small pieces of Styrofoam. The mangled corpses were not insignificant in numbers. They lay by the hundreds, dead or dying along the ground on these atolls, ironically suffering from starvation as their stomachs were filled with this mildly convenient artifice we use to feed ourselves from quickly and conveniently. Any person both privileged and cursed, to view this sight understands quickly why a global ban on these products is needed immediately. Hawaii, of all places, can understand and feel the pain this pollution is creating right here at home and needs to help lead the cause to eliminate them.

For producers of these plastics to blame the end users for the fate of the pollutants is no different than the same excuses the same petrochemical companies made for Agent Orange or PCBs. The people of this nation demanded change. We demanded a ban on these chemicals for the knowledge of their inevitable fate was too much for any of us to bear. As we necessarily, demanded through federal law, to do away with these pollutants that were wreaking havoc on our health and the environment, we must too, ban the use of these acutely toxic killers of marine life.

I graciously ask you to consider the larger picture, to avoid being influenced by the very few who stand to gain by continuing to produce and sell these petrochemical products at the cost of our Ocean's health and support this bill. Future generations will surely thank you for having the courage to do so.
