TESTIMONY ON SENATE BILL NO. 1171, S.D. 1 – RELATING TO THE HEALTH CARE PRIVACY HARMONIZATION ACT.

TO THE HONORABLE SCOTT Y. NISHIMOTO, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Gordon Ito, State Insurance Commissioner, testifying on behalf of the Department of Commerce and Consumer Affairs ("Department"). The Department supports this bill if used for an All-Payer Claims Database project or similar purpose.

This bill identifies circumstances in which the State has a compelling interest in the use and disclosure of de-identified protected health information and recognizes that use and disclosure of de-identified protected health information is subject to 45 Code of Federal Regulations part 164.

We support the use of de-identified protected health information in a manner that is consistent with federal regulations. Such information may be helpful for an All-Payer Claims Database or similar purpose by providing data to help analyze health care cost drivers, and lead to activities for improving population health.

We thank the Committee for the opportunity to present testimony on this matter.

HPH **supports** SB 1171, SD1 which identifies circumstances in which the State has a compelling interest in the use and disclosure of de-identified protected health information under the Health Care Privacy Harmonization Act. We recognize that there may be circumstances under which the State has a compelling interest in protected health information as outlined in SB 1171. However, despite the State's compelling interests, it remains necessary to protect patient privacy and confidentiality. We appreciate the amendments contained in the current draft of the measure, specifying that the health information must be de-identified pursuant to title 45 Code of Federal Regulations part 164.

The Chamber of Commerce Hawaii ("The Chamber") **strongly supports** SB 1171 SD1, which identifies certain circumstances under which the State has a compelling interest in the disclosure, use, and production of de-identified protected health information under the Health Care Privacy Harmonization Act; provided that the information has been de-identified pursuant to title 45 Code of Federal Regulations part 164.

The Chamber is Hawaii's leading statewide business advocacy organization, representing about 1,600+ businesses. Approximately 80% of our members are small businesses with less than 20 employees. As the "Voice of Business" in Hawaii, the organization works on behalf of members and the entire business community to improve the state's economic climate and to foster positive action on issues of common concern.

On behalf of the Hawaii Health Systems Corporation (HHSC) Corporate Board of Directors, thank you for the opportunity to present testimony <u>in support of</u> S.B. 1171 relating to the Health Care Privacy Harmonization Act.

HHSC is in support of this measure insofar as it clarifies and confirms the permissible use of de-identified patient information for legitimate and necessary purposes, including but not limited to hospital operations. We believe that adequate safeguards for patient information are provided by the existing HIPAA framework that is applicable nationwide and here in Hawaii in accordance with the Health Care Privacy Harmonization Act. It is important and timely to clarify the scope of protections applicable to patient privacy under the Hawaii State Constitution via this Bill. We respectfully wish to clarify that once the requirements for de-identification under HIPAA are satisfied, the information is no longer considered "protected health information" under HIPAA, and HIPAA restrictions on use or disclosure cease to apply.
