SENATE BILL NO. 1205 RELATING TO AGRICULTURE

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 1205. This bill establishes a reimbursement transportation cost payment program (RTCP) in the Department of Agriculture for qualified "geographically disadvantaged" farmers and rancher with a portion of the cost to transport eligible commodities or inputs used to produce an eligible commodity. This program is not available to farmers and ranchers who ship their products to Oahu, and available to farmers and ranchers on all islands who export their eligible commodities out of the State. There is an appropriation in FY 2017-18 and the same sum or greater in FY 2018-19 to issue reimbursements. There are no provisions for hiring of personnel or development of program rules. The Department of Agriculture supports the intent but is very concerned about establishing a new program without personnel resources with the requisite program development and management expertise.

The RTCP program proposed in this bill partly duplicates the federal RTCP that is currently administered by the USDA Farm Service Agency (FSA) under a provision in the 2014 Farm Bill. Hawaii FSA personnel anticipate that the Program will not be extended into the 2019 Farm Bill. For 2015, there were 410 individual farmer applications for RTCP reimbursement in the State of Hawaii that were issued a net of

\$886,000 in partial reimbursement of transportation costs payments. The administration of this program is shared by FSA offices located in each county. FSA program managers are experiencing problems with questionable claims for reimbursement resulting from overly broad eligibility provisions.

SB 1205 - RELATING TO AGRICULTURE.

Establishes a reimbursement transportation cost payment program within the DOA for geographically disadvantaged farmers and ranchers to reimburse eligible producers with a portion of the cost to transport eligible commodities or inputs used to produce an eligible commodity. Appropriates funds to the DOA for the program.

Chair Gabbard, Vice Chair Riviere, and Members of the Committee:

My name is Dale Sandlin, and I am Managing Director of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the four county level Cattlemen's Associations. Our 150+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council <u>supports with amendments</u> SB 1205 as this bill would provide the ability to defray the high costs of shipping agricultural goods interisland.

The ability to transport cattle and beef has been a mainstay of our industry, and as our industry expands, this needs becomes even more critical. With very thin margins, our industry relies heavily in managing the input costs associated with production of cattle and transporting both cattle from pasture to plant and high-quality beef to consumers on the neighbor islands.

This effort would provide producers with much needed relief in transportation. The ability to develop a program like this would provide our industry and other ag industries a way to help provide more stability to their operations.

We do ask that Livestock in this bill be changed to reflect the following:

(7) Livestock, including but not limited to: elk, reindeer, bison, horses, and deer.

We ask the committee to pass this legislation and we appreciate the opportunity to testify on this important matter.

Aloha Chair Gabbard, Vice Chair Riviere, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

HFB supports SB 1205, which establishes a reimbursement transportation cost payment program within the DOA for geographically disadvantaged farmers and ranchers to reimburse eligible producers with a portion of the cost to transport eligible commodities or inputs used to produce an eligible commodity.

Interisland transportation has been a major issue with neighbor island farmers. The majority of agricultural lands are in the neighbor islands yet the population center is on Oahu. Neighbor island farmers are disadvantaged when competing with fellow farmers on Oahu due to additional transportation costs of bringing in supplies and sending product out. Each increase in interisland shipping rates means increased costs to these farmers and ranchers, costs that usually cannot be passed on to the vendor. This bill seeks to level the playing field by providing assistance to these farmers and ranchers.

Hawaii's livestock industry faces numerous challenges. These challenges have been a contributing factor to the decline of the state's livestock industry. Sustainability, self-sufficiency and growing agriculture are popular concepts seen in many of the measures before the legislature this year. This Legislative Session, there have been many bills introduced that support of Hawaii's agricultural Industry.

Our ranchers are struggling with the high cost of their operations. This measure also provides a reimbursement for transportation costs to assist Hawaii's livestock and aquaculture industries that export.

We believe that this program will help to reduce the operating costs for our neighbor island farmers and ranchers and eventually help reduce the cost of purchasing local agriculture products for local consumers.
