My name is Rattika Ou, a student from University of Hawaii, Myron B. Thompson School of Social Work in the MSW program, expecting to graduate Spring 2017.

I am writing in support of SB 1215 which appropriates funds to Department of Human Services for the housing first and rapid re-housing programs as well as to the Hawaii Public Housing Authority for the state rent supplement program. In which, these programs assist chronically homeless individuals, individuals who require financial assistance to avoid homelessness, and families at imminent risk of homelessness.

As a social work student, I strongly support the passage of this bill for individuals/ families who are currently experiencing homelessness or may be at risk of homeless due to instability. While there is no other underlying factors involved, individuals/ families may need minimal assistance to help them get back on their feet again, and often times those assistance may be short-term. If these programs are funded, the overall number of the homeless population could significantly be reduced. Further, the harm reduction approach is about being less aggressive and allowing the individual to make progress toward their goal one step at a time. Finding solutions to complex issues are indeed difficult because different individuals/families experience different challenges; therefore, there is not a "one size fits all" kind of approach. With continued support to these crucial components, the efforts to improve and to end this crisis may continue to have a positive outlook.
