### SUBJECT: SB 1217- RELATING TO SOCIAL SERVICES

Hearing: Monday, February 6, 2017, 3:10 p.m. Conference Room 016, State Capitol

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent of this bill. However, DHS respectfully opposes the measure, as currently drafted its passage will create a deficit in the State Supplemental Payment (SSP) appropriation. As a result, the Adult Protective and Community Services Branch Operating Funds will have to cover the deficit. If the State Supplemental Payment appropriation amount is increased to satisfy the increase of the Personal Needs Allowance (PNA), it may adversely impact priorities identified in the Governor's Executive Budget.

Additionally, DHS has not yet determined whether the increased amount of PNA would possibly make certain individuals ineligible for certain benefits they currently receive, such as medical insurance coverage or financial assistance. Once the question is resolved, DHS will provide the information to the committee Chair. DHS provides the following comments.

**PURPOSE**: The purpose of this bill is to increase the monthly needs allowance paid under section 436D-4.5 (a), HRS, from \$50 per month to \$75 per month. The SSP comprises of payments for domiciliary care operators and clients as specified in section 346-53 (c), Hawaii Revised Statutes (HRS) and payments to Nursing Facilities and patients as specified in section 346D-4.5 (a), HRS. The State Fiscal Year (SFY) 2017 SSP budget is \$17,810,955. The Maintenance of Effort (MOE) agreement with Social Security Administration (SSA) requires a minimum expenditure of \$16,785,143.91 in SSP payments to Domiciliary home and clients, and Nursing homes each year as specified in section 416.2096 (a), Code of Federal Regulations (CFR). This leaves a budget balance of approximately, \$1,025,811.09.

In addition, administrative fees and nursing home patient PNA payments totaling \$459,118.72 are also expended, reducing the balance to \$566,692.37.

Increasing the PNA from \$50 to \$75 for approximately 2,548 (SFY 2016 average enrollment) clients in domiciliary homes will increase the annual expenditure to \$764,400.

Also increasing the PNA from \$50 to \$75 for approximately 190 patients in nursing homes adds \$57,000 to the \$764,400, thus the total additional expenditure will be \$821,400 per year, with a grand total of SSP expenditure of \$18,065,662.

The proposed increase will exceed the SSP appropriation by \$254,708, and create a budget deficit.

In comparison, increasing the PNA from \$50 to \$70 for approximately 2,548 clients in domiciliary homes will increase the annual expenditure to \$611,520. Also increasing the PNA from \$50 to \$70 for approximately 190 patients in nursing homes adds \$45,600 to the \$611,520, thus the total additional expenditure will be \$657,120 per year. This additional expenditure will exceed the SSP appropriation by \$90,427.63.

In comparison, increasing the PNA from \$50 to \$65 for approximately 2,548 clients in domiciliary homes will increase the annual expenditure to \$458,640. Also increasing the PNA from \$50 to \$65 for approximately 190 patients in nursing homes adds \$34,200 to the \$458,640, thus the total additional expenditure will be \$492,840 per year. This additional expenditure will result in a budget balance of \$73,852.37. The current appropriation is able to cover an increase from \$50 to \$65.

We are cautious of proposed increases in expenditures of the SSP appropriation that will exceed the appropriation amount as well as any increase in clients and patients will increase expenditures. If proposed measure passes as drafted, the APCSB Operating budget will be negatively affected in providing its array of crisis intervention services.

Also, DHS is currently analyzing whether an increase in the PNA will make certain individuals ineligible to continue to receive certain benefits, such as medical insurance coverage or financial assistance. Once the question is resolved, DHS will provide the information to the committee Chair.

SUBJECT: SB 1217 – Relating to Social Services

The State Council on Developmental Disabilities **STRONGLY SUPPORTS SB 1217**. The purpose of the bill is to establish a personal needs allowance (PNA) for individuals residing in foster homes, care homes, domiciliary homes, and other long-term care facilities from \$50.00 per month to \$75.00 per month.

The PNA is intended for residents spend at their discretion on clothing, shoes, toiletries, bedding, towels, wash cloths, furniture, transportation (other than medical visits), personal postage costs, snacks, a meal out with friends, movies, recreational activities, hobbies, reading materials, and other incidental expenses of day-to-day living (cable, internet, cards/presents to send to family/friends, sun screen, lotion, etc.). Federal regulations prohibit long-term care facilities from charging residents' PNA for services that are included in Medicaid payments such as toothpaste, toothbrush, tissues, shampoo, and incontinence products.

Act 96, Session Laws of Hawaii 2007 increased the personal needs allowance from \$30.00 to \$50.00 a month. That increase amounted from \$1.00 per day to \$1.66 per day. The passage of SB 1217 would increase the PNA from \$50.00 per month to \$75.00 per month or from \$1.66 per day to \$2.50 per day. The last increase in the PNA was seven years ago and has not kept up with Hawaii's high cost of living. This amount can barely buy a decent cup of coffee.

Thank you for the opportunity to present testimony in **strong support of the passage of SB 1217**.
