

TESTIMONY OF THE DEPARTMENT OF THE ATTORNEY GENERAL TWENTY-NINTH LEGISLATURE, 2017

ON THE FOLLOWING MEASURE:

S.B. NO. 1271, PROPOSING AN AMENDMENT TO ARTICLE II, SECTION 1, OF THE HAWAII STATE CONSTITUTION TO CHANGE THE AGE QUALIFICATION FOR VOTING IN STATE AND LOCAL ELECTIONS.

Chair Keith-Agaran and Members of the Committee:

The Department of the Attorney General submits comments reflecting a concern about this bill.

This bill proposes an amendment to article II, section 1, of the Hawai`i State Constitution to change the age qualification for voting in certain state or local primary elections to include individuals who are 17 years old and will be 18 years old on or before the next state or local general election. The amendment proposed by this bill also includes the requirement that the voter have been "a resident of this State not less than one year immediately preceding the next state or local general election". See page 2, lines 13-15.

A durational residency requirement for voting has been struck down as a violation of the equal protection clause and therefore unconstitutional. *See Dunn v. Blumstein*, 405 U.S. 330 (1972) (state law requiring that a would-be voter have been a resident for 1 year and 3 months did not further any compelling state interest and violated the 14th Amendment). The Department therefore suggests that this bill be amended to delete the durational residency requirement on page 2, lines 13-15.
