The Liquor Commission, City and County of Honolulu (Commission), appreciates the opportunity to provide testimony in strong support of Senate Bill 1277, Relating to Public Agency Meetings.

The proposed measure will amend HRS Section 92-9(a) to permit an agency, board, commission, authority, or committee which is required to conduct meetings and to take official action to keep minutes of its meetings in analog or digital recorded format. This ability to use analog or digital recordings for the Commission's weekly hearing minutes will benefit the Commission and the public in several ways:

- Increase efficiency by reducing the personnel hours required to produce and maintain a hearings record in compliance with HRS Chapter 92.
- Improve the accuracy of the hearings record because the Commission's digital recording will capture both audio and visual components of the hearing.
- Enhance public accessibility to the hearings record through faster turnaround of the hearings record to any requestor.

Dear Chair and Members of the Committee:

My name is Brian Black. I am the Executive Director of the Civil Beat Law Center for the Public Interest, a nonprofit organization whose primary mission concerns solutions that promote government transparency. Thank you for the opportunity to submit testimony on S.B. 153. The Law Center **supports the intent of this bill, but wants to confirm that the bill will not delay access to recordings of Sunshine meetings**.

OIP requires that boards and commissions must disclose recordings of meetings *in less than* 30 days. *E.g.*, OIP Op. 02-06 at 9-10; OIP Op. No. 97-06 at 2-4; OIP Op. No. 92-13. The deadline for disclosure of such records would be a reasonable time not to exceed 10 business days. HAR § 2-71-13(a). The Sunshine Law, however, provides that Sunshine boards have 30 days to provide public access to "minutes". HRS § 92-9(b). *The Law Center would ask that the Committee clarify in its report that classifying a recording as "minutes" does not change the deadline for disclosure of such records.*
