SUBJECT: TRANSIENT ACCOMMODATIONS, Increase Funds Earmarked for Conservation

BILL NUMBER: SB 1300

INTRODUCED BY: SHIMABUKURO, S. CHANG, DELA CRUZ, ENGLISH, ESPERO, KEITH-AGARAN, KIM, RIVIERE, Kidani

EXECUTIVE SUMMARY: Changes the amount earmarked from the TAT to the special land and development fund to an unspecified amount. Earmarks decrease transparency and accountability of government operations and should be avoided.

BRIEF SUMMARY: Amends HRS section 237D-6.5 to allocate \$_____ million a year to the special land and development fund, which is to be expended in accordance with the Hawaii tourism authority strategic plan for: (A) protection, preservation, maintenance, and enhancement of natural resources, including beaches, important to the visitor industry; (B) planning, construction, and repair of facilities; and (C) operation and maintenance costs of public lands, including beaches, connected with enhancing the visitor experience.

EFFECTIVE DATE: July 1, 2017.

STAFF COMMENTS: Act 161, SLH 2013, made permanent the TAT rate of 9.5% and changed the allocations of TAT from a percentage basis to a specific dollar amount. Currently, TAT revenues are allocated as follows: (1) \$1.5 million goes to the Turtle Bay conservation easement special fund; (2) \$26.5 million is deposited into the convention center enterprise special fund; (3) \$82 million goes to the tourism special fund; (4) \$103 million is transferred to the various counties; and (5) \$3 million is allocated to the special land and development fund. Any remaining revenues then go to the general fund.

The proposed measure would change (presumably, increase) the siphon of TAT revenues to the special land and development fund and would perpetuate the earmarking of TAT revenues. Most of us understand that conservation of natural resources is a worthy goal. But does that justify grabbing a pot of TAT money without going through the normal budgeting process that also considers sweltering primary schools, underfunded state pensions, or homelessness? And what about the needs of the counties who are also jockeying for a larger piece of the TAT pie?

Rather than the continual earmarking of TAT revenues, a direct appropriation of general funds would be preferable. Earmarking the TAT revenues for a particular purpose that not only benefits the visitors but the community at large, decreases transparency and accountability.

Next, it should be remembered that revenues diverted for a special purpose, in this case to fund conservation, will not be counted against the state's spending ceiling or debt limit and will obscure the state's true financial condition.

Senate Bill 1300 proposes to increase the amount of Transient Accommodations Tax (TAT) revenue allocated to the Special Land and Development Fund of the Department of Land and Natural Resources (Department). The Department appreciates the intent of this measure and is in support, provided that it does not replace or adversely impact our current \$3,000,000 allocation per Section 237D-6.5(b)(5) Hawaii Revised Statutes, to the Special Land and Development Fund.

Comments: Please SUPPORT this bill. If passed, revenue could generate up to \$116 million for conservation and educational purposes, in addition to hundreds of job opportunities and money to combat against invasive species and the spread of Rapid Ohia Death. Hawaii has unique but severely threatened habitats stretching from the mountains to the sea. On Haleakala, the rate of invasive species introduction is 2,000 times the natural rate! Many of our most precious natural resources are also the ones most heavily used by the visitor industry. A number of studies have determined that visitors are willing to pay additional fees to ensure the preservation of the natural resources that they are traveling to enjoy. Surcharges on hotel rooms have been used in various places around the world as a way of raising funds for conservation. For example, in the U.S., 10% of the money raised by the state of Delaware's 8% tax on hotel rooms is earmarked (by law) to finance the state's "Beach Preservation Program." In the Florida Keys (Monroe County Florida), voters approved a Tourist Impact Tax equal to a 1% increase in the existing hotel tax, and half of this 1% tax increase must be used for acquisition of undeveloped open spaces. In 2015, Hawaii spent \$130,881,588 on natural resources departments. With climate change, the cost of natural resource conservation will only increase. This bill will help improve funding for DLNR and natural resource conservation in Hawaii.
