DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of this bill to provide funding to expand the Housing First program to the neighbor islands, and offers comments. Housing First is an evidence-based best practice targeted at the unsheltered homeless population with the highest acuity and chronicity. The DHS asks for the Legislature's support of the Governor's Executive budget request for \$3 million for Housing First.

PURPOSE: The purpose of the bill is to appropriate \$3 million for continued implementation of the State's Housing First program and expansion of the program outside of Oahu to assist residents who are chronically homeless.

Homeless Programs Office (HPO) plans to release a Request for Proposal (RFP) by the end of February (state fiscal year 2017) to continue the implementation of the State's Housing First Program on Oahu and expand the program to the neighbor islands. The proposal will be for \$3 million, with \$1.5 million allocated for the island of Oahu and \$1.5 million for the neighbor islands.

DHS would prefer the Legislature appropriate the funds through the Executive budget to support program continuity.

POSITION: The Governor's Coordinator on Homelessness appreciates the intent of this measure, as it proposes funding to address key aspects of the State's work to end homelessness. The Coordinator asks for the Legislature's support of the Governor's Executive Budget request, which includes \$3 million to the Department of Human Services (DHS) for Housing First statewide.

PURPOSE: The purpose of the bill is to appropriate funds to DHS to continue to administer the Housing First program, and to expand the Housing First program outside of Oahu, for chronically homeless individuals.

The Housing First program is a critical part of the State's framework to address homelessness. The Housing First program provides both housing and supportive services to chronically homeless individuals. Housing First is an evidence-based intervention, with demonstrated success in other communities across the country. Locally, the state's Housing First program currently provides permanent housing for 117 chronically homeless persons that include many individuals with serious and persistent mental illness and chronic health conditions. Hawaii Revised Statutes (HRS) §346-378 establishes the state's Housing First program, and describes the principles of a Housing First approach. HRS §346-378(e) defines "chronically homeless individual" as a homeless individual who has an addiction or mental illness, or both. The U.S. Department of Housing and Urban Development (HUD) defines a "chronically homeless" individual as a homeless person with a disability who has been homeless continuously for at least 12 months, or has been homeless on at least four separate occasions over the past three years. If this measure moves forward, the Coordinator respectfully requests that the state definition of "chronically homeless" be amended to conform to the HUD definition for consistency.

STRONG SUPPORT OF SB171, to continue Housing First program.

Thank you for the opportunity to provide testimony **in strong support** of SB 171, to continue the Housing First Program. I am Marya Grambs, a member of Partners in Care and a Board member of PHOCUSED (Protecting Hawaii's Ohana, Children, Underserved, Elderly, and Disabled).

Housing First has been funded on a year-to-year basis by the State Legislature. The current level of funding is \$3 million, split between Oahu and the neighbor islands. Because funding is not in the base budget, the sustainability of housing for individuals in the current program is at risk (up to 500 people, statewide, by the end of 2017).

We ask your support for \$3 million to continue the Housing First program statewide. <u>We also</u> respectfully urge that this funding be added to the **base budget of DHS**. Without this, the sustainability of housing for currently housed chronically homeless people would be at risk.

Housing First is different from other housing interventions because it focuses on providing people experiencing homelessness with housing as soon as possible, and then providing supportive services once the individual is housed. The program targets chronically homeless individuals who are medically vulnerable, and may have difficult accessing other housing programs due to their high level of need. These are the people who are most difficult to get off the streets. Housing First includes funding for (1) Permanent Housing subsidy; and (2) Intensive case management/supportive services ("wrap around services").

Our current Housing First (HF) program is successful: by the end of 2017, State and City Housing First programs will serve an estimated 500 people, statewide. HF programs enable these homeless to remain successful in permanent housing. HF programs have a high retention rate (combined rate of **98.1%**) when compared with other programs where the retention rate is less than 50%.

Housing First results in high public cost savings in healthcare alone. Early findings from the UH Center on the Family found a 43% reduction in healthcare costs after just 6 months in the State Housing First program. Costs were reduced by approximately \$4,590/person/month. For the estimate 500 people to be served by State/City Housing First programs, this could result in **nearly \$2.3 million per month is public cost savings.**

Thank you for the opportunity to provide testimony **in strong support** of SB 171, to continue the Housing First Program. I am Betty Lou Larson, with Catholic Charities Hawai'i. We are also a member of Partners in Care. This funding provides immediate solutions to homelessness.

Catholic Charities Hawai`i (CCH) is a tax exempt, non-profit agency that has been providing social services in Hawai`i for over 60 years. CCH has programs serving elders, children, developmentally disabled, homeless and immigrants. Our mission is to provide services and advocacy for the most vulnerable in Hawai`i. Ending homelessness is one of our top priorities for 2017.

The causes of homelessness are diverse but the KEY to ending chronic homelessness is Housing First. The chronically homeless population is growing (a 27% increase between 2015-2016), but we know Housing First (HF) is effective at addressing the needs of this population. We see them daily; nothing seemed to get them off the streets. Chronic homeless are the most visible and the hardest to reach—disabled and often mentally ill, most have been living on the streets for over 3 years and some for over 10 years. They are medically vulnerable, and may have difficulty accessing other housing programs due to their high level of need. With the HF rental subsidies and vital wrap around services, we are finally successful. By the end of 2017, State and City Housing First programs will serve an estimated 500 people, statewide. HF programs enable these homeless to remain successful in permanent housing. HF have a high retention rate (combined rate of **98.1%**) when compared with other programs.

We ask your support for \$3 million to continue the Housing First program statewide. We also respectfully urge that this funding be added to the **base budget of DHS**. Without this, the sustainability of housing for currently housed chronically homeless people would be at risk.

My name is Brandee Menino, CEO of Hope Services Hawaii, a non-profit organization based on Hawaii Island and lead provider agency addressing homelessness through a continuum of programs including Homeless Outreach, Emergency Shelter, Transitional Housing and Affordable Housing for low income families and individuals with over a 223 bed capacity at any given night at nine facilities across Hawaii Island. We are also a member of Hawaii Island's local continuum of care, Community Alliance Partners as well as the neighbor island's Balance of State Continuum of Care, Bridging the Gap. Ending homelessness is our top priority.

According to Hawaii's Homeless Point in Time Count report, the total number of chronically homeless individuals and families increased by 27% in 2016 with 1,949 persons in chronically homeless households, compared to 2015 with 1,534 in chronically homeless households. On the neighbor islands, there were 665 chronically homeless individuals identified & 194 persons in 42 chronically homeless families.

According to the Homeless Service Utilization Statistical Supplement Report for FY 2015, 54 chronic homeless adults and 52 chronic homeless families in Hawaii County moved into permanent housing and **NONE of them** returned to the homeless service system after one year. So, we know firsthand that Housing First works! **We ask your support for \$3** million to continue the Housing First program statewide. <u>We also respectfully urge that this funding be added to the **base budget of DHS**. Without this, the sustainability of housing for currently housed chronically homeless people would be at risk.</u>

Testimony in Strong Support

Chairs, Senator Green and Senator Espero, Vice Chairs, Senator Chang, and Senator Harimoto and members of the Human Services and Housing Committees. I am here today on behalf of Hawaii Habitat for Humanity Association and our seven county Habitat affiliates in Hawaii, to offer this testimony in strong support of SB171. This bill if passed would fund Hawaii's Housing First's efforts in providing shelter beds, and supportive transitional housing for Hawaii's chronically homeless, many of whom have serious health and mental health issues.

Hawaii Habitat for Humanity and its seven county affiliates have long recognized that decent affordable housing is not just an economic issue (the pathway out of poverty) it is a public health issue. Although we are on the top end of homeless/housing continuum we support the efforts our homeless providers in addressing this problem. We also recognized that the Housing First Model as having a positive impact in reducing homelessness, while at the same time providing supportive services that offered to maximize housing stability and prevent returns to homelessness as opposed to addressing predetermined treatment goals prior to permanent housing entry.

In closing, we would strongly recommend that the committees to move this bill forward.
