There is already a law for Gill nets to be labeled.

To extend the labeling to other nets especially aquarium nets is not needed. Please do not pass this bill or amend it to exclude aquarium fish nets which are always with diver and never catch bycatch. See below video link of divers catching aquarium fish with small mesh nets.

No fish get stuck in the small mesh nets it only blocks them for a short period of time until the figure out how to get around it. All unwanted fish are released unharmed. No gills get caught in these nets! The nets are kept in small bags for transport and any label makes it harder to put back into their travel containers.

In the past new laws require the registration and identification of all lay nets, limit their maximum dimensions, limit their fishing or soak times to not more than four hours in daylight hours only, and require attendance and inspection of nets when shed, ...

Lay gill nets violate the concept of taking only what is needed, can damage habitat, and can catch nearly anything swimming by, including protected species such as Hawaiian monk seals and green sea turtles.

I agree with that intent! But Aquarium fish nets do no damage like other nets. See for yourself in video below:
