In consideration of SENATE BILL 272, SENATE DRAFT 2, HOUSE DRAFT 1 RELATING TO RAT LUNGWORM DISEASE

Senate Bill 272, Senate Draft 2, House Draft 1 proposes to appropriate funds to support research, control, and outreach activities relating to rat lungworm disease. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Budget request.

The Department recognizes the threat of rat lungworm disease and the lack of information on statewide distribution of the parasite *Angiostrongylus cantonensis* and its hosts. The Department also notes that the Hawaii Invasive Species Council (HISC), which is administered by the Department, received proposals for research and education regarding this disease in Fiscal Year (FY)16 and FY17 but was unable to identify adequate resources to support all of these efforts. In FY17 the HISC is providing partial funding support to a project developing outreach programs and materials regarding rat lungworm disease under the direction of the University of Hawaii at Hilo. Additional funding support for a more comprehensive research, control, and outreach program, as described in this measure, would be strongly beneficial. The Department supports this measure, provided that the appropriations described therein do not impact appropriations to the HISC or other priorities indicated in the Executive Budget request.

The Department notes that Senate Draft 1 streamlined funding to the University of Hawaii at Hilo for the implementation of tasks described in the measure, and is supportive of this approach.

Chairperson Luke and Members of the Committee:

Thank for the opportunity to testify on Senate Bill No. 272 SD2 HD1, relating to rat lungworm disease. The Department supports the intent of this measure provided it does not impact the Department's priorities submitted in the Executive Budget.

Rat lungworm disease is a serious and relatively new pathogen to plague the consumption of fresh produce grown in the islands. There is a great need to conduct research into the biology of the carriers of the disease, the ways in which it can be spread, outreach to the public in understanding the condition, and methods that can be employed to control and/or contain it.

The department supports the intent of SB272 provided it is funded at a level in which research can be conducted and carried out to achieve implementation of prevention measures. It is especially critical that Integrated Pest Management practices can be identified that minimize the use of chemicals and employ a variety of management techniques that will provide long term control of the pathogen. Outreach is an especially critical component of any IPM tactics. The more that the public understands the hazards of the disease, the less of a public health issue it will become. As noted in the bill, the medical expenses associated with contracting the disease can run into the millions. Research dollars spent in developing long term and effective

management programs are minor compared to the expected medical bill associated with those who contract the illness.

SENATE BILL 272 SENATE DRAFT 2, HOUSE DRAFT 1 RELATING TO INVASIVE SPECIES

Senate Bill 272 Senate Draft 2, House Draft 1 proposes to appropriate funds to support research, control, and outreach activities relating to rat lungworm disease. **The Hawaii Invasive Species Council (HISC) supports this measure.**

The HISC recognizes the threats posed by rat lungworm disease and has received proposals for research and education regarding this disease in Fiscal Year (FY)16 and FY17. Due to limited funding, the HISC was unable to fully support all of these efforts. In FY17 the HISC is providing partial funding support (totaling \$65,634) to a project developing outreach programs and materials regarding rat lungworm disease under the direction of the University of Hawaii at Hilo. The amount of funding needed for a comprehensive research, control, and outreach program, as described in this measure, would be strongly beneficial and is beyond the current resources of the HISC. The HISC therefore supports this appropriation, provided that it does not negatively impact other requests for invasive species funding in the Executive Budget.

The HISC notes that increased resources for research, control, and outreach relating to rat lungworm disease are critical components of the Hawaii Interagency Biosecurity Plan (including HIBP action items BorTifs1.5, PosPro1.1, PosTifs1.5, and PwsPro1.7). Passage of this measure would support timely implementation of the Biosecurity Plan.

Aloha Chair Luke, Vice Chair Cullen, and Members of the Committee:

I am Randy Cabral, President of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

Hawaii Farm Bureau supports SB 272, SD2, HD1, relating to Rat Lungworm Disease.

Providing safe and wholesome food is a priority for the Farm Bureau and its members. Unfortunately, not enough is currently known about Rat Lungworm Disease, or angiostrongyliasis, to fully protect the public. For example, although we know that people in Hawaii can get the disease by eating food contaminated by the larval stage of *A. cantonensis* worms found in raw or undercooked snails or slugs, and we know that people have also become infected by eating raw produce that contains a small infected snail or slug, or part of one, it is *not* known whether even just the slime left by infected snails and slugs is able to cause infection.

This is critical information since the disease can cause a rare type of meningitis (eosinophilic meningitis) that is extremely painful, debilitating, and can be deadly. Because there is no specific treatment for the disease, patients are only given supportive therapy and pain medication.

As more people are encouraged to grow their own food in backyard gardens, and school gardens are becoming more prevalent, the risk of being infected with this disease increases. Nutritionists advise the public to eat plenty of fresh leafy vegetables. However, without knowing enough about the transmission of rat lungworm disease, this advice may

be risky in areas infested by snails and slugs. We need to know if the slime alone can cause the disease, and if washing or other pre-consumption measures will prevent transmission. Backyard gardeners and others who may not practice pest management to effectively control snails and slugs, or those who purchase greens from these sources, may be particularly at risk.

HFB supports funding of the University of Hawaii at Hilo and their collaboration with state agencies to help learn more about the disease and to prevent the spread of it and other food-borne diseases, especially to children through school garden projects.

SB 272 SD2 / HB 474 - RELATING TO RAT LUNGWORM DISEASE

Chair Luke and Vice Chair Cullen and members of the House Committee on Finance,

My name is Dr. Susan Jarvi and I am a Professor in the Department of Pharmaceutical Sciences at the University of Hawaii at Hilo, Daniel K. Inouye College of Pharmacy. My lab has been the lead in rat lungworm education and research for the past 5 years in the state. I am speaking as a concerned individual in strong support of SB 272 SD2 / HB 474 Relating to Rat Lungworm Disease (RLWD).

Rat lungworm disease (RLWD) is a global disease. The earliest cases of RLWD in Hawaii were reported in 1959, so this disease has been established for some time. More recently we have seen an increase in the number of cases occurring, many of which originate from east Hawaii Island, however cases have been reported on all main Hawaiian Islands. A couple who recently came to Hana, Maui, to get married were diagnosed with RLWD. The parasite is also detected on the mainland in Florida, Louisiana, Texas, and Oklahoma, and last year three cases of human RLWD acquired in Texas after a flood. It's not just in Hawaii, but why are we seeing such an increase in the number of cases?

My lab has been working on RLWD since 2011, and we are trying to address this question. We've completed a number of research and educational outreach projects with relatively little funding. We have provided evidence that we have fairly high infection rates in humans, in slugs and in rats. Last year we screened people from east Hawaii for the presence of antibodies against RLW indicating they had been exposed to the parasite and 30% were positive. We've developed a molecular test to estimate the level of infection in slugs and snails and they have very high infection rates (10's of thousands), especially the semi-slug. The semi-slug was introduced to Puna ~ the turn of the millennium and has since spread across the Island. These slugs are very mobile and good climbers. That might be one reason we are seeing a high number of RLWD cases. The semi-slug was recently found on Maui. The rats are also highly infected. Last month we captured nearly 560 rats from the Hilo area to isolate adult rat lungworms from the hearts and lungs to develop a diagnostic. Nearly 94% of them were infected. High levels of infection! We need to monitor slug infection rates and track movement, we also need to educate the public on the best practices for slug/snail and rat control. While vector control is important we don't think vector control alone will control this disease. To drop rat infection rates, we tried a vaccine, which unfortunately didn't work. How about deworming rats?

Many people in east Hawaii are also on catchment. We know that slugs and snails climb into catchment tanks. We have shown that infective stage larvae can live for weeks outside a slug host in a wet environment. It was shown 50 years ago that rats can get infected by drinking contaminated water. If rats can get infected, humans can too. Additional research is needed to evaluate catchment system design. **Strong evidence suggests that the increase in RLWD cases in Hawaii County could be related to the introduction of the semi-slug and residential and agricultural catchment use.** We have completed much of the groundwork in some of these studies and are poised to carry out these larger studies outlined in SB272 through collaborative efforts. We appreciate your full support of SB 272.

Aloha Hawaii State Representatives,

My name is Donna Mitts and I reside on the Hamakua Coast of Hawaii Island. I have been involved with school learning gardens here for around 15 years. I am testifying in support of SB 272 as the need for funding for the University of Hawaii at Hilo for research and education for rat lungworm disease is essential. The University of Hawaii at Hilo has been the leading proponent for research and education on rat lungworm disease since 2012, and they have been operating with very little funding. Increased funding is crucial for the following reasons:

• Over the past 15-years cases of rat lungworm disease in Hawaii have been increasing in number and severity, costing people their lives, livelihoods, savings, health, and well-being. There have been deaths and disabilities from the disease, many people never recover fully. Those of us who know about the disease are afraid of getting it as we have seen or have heard about the impact it can have on one's health. The disease has affected people in Hawaii, Maui, Oahu, and Kauai Counties, and the parasite has been found on all of the major Hawaiian Islands with the exception of Lanai.

• Case numbers are under-reported because many doctors are not familiar with the disease and there is no easy diagnostic. Diagnosis currently requires a spinal tap, which is a costly dangerous procedure, and therefore many, many cases go undiagnosed.

• Rat lungworm disease, a food-borne illness, is detrimental to Hawaii's efforts to become food secure. This problem will hurt our farmers, grocers, school gardens and consumers. Already there are those of us who do not purchase fresh vegetables grown in Hawaii, and many of us will not consume salads at restaurants because we don't know how well the lettuce has been washed. Education for food handlers is important!

• There needs to be more education available for residents, especially new residents, and visitors who know nothing about the disease. There also needs to be education for the school garden projects so our keiki are safe.

• The vectors of rat lungworm disease are all invasive species, as is the parasite itself, and there is a need for host control. When case numbers started to rise 10 years ago control efforts should have begun. The semi-slug is an important carrier of the rat lungworm, and it has spread around the island because there has been no education or efforts for host control. All slugs and snails, and some flatworms can be carriers, and they all are invasive species. Rats are also bad for Hawaii and should be controlled.

• Studies are showing the potential for infection through water, and Hawaii Island relies heavily on rainwater catchment, which may be a reason cases of rat lungworm disease are higher in Hawaii County. We need to know if filters, what size filters, and if UV light will keep the parasite out of household water in a catchment system. There is a need for education for those using rainwater catchment. The use of rainwater catchment for agriculture needs to be explored to ensure prevention of crops.

People who know about rat lungworm disease and are taking precautions and some are still getting sick. This problem is endangering residents and visitors, as well as Hawaii's reputation as a tropical vacation paradise. I am in support of SB 272 because rat lungworm disease must be addressed in order to ensure that the health and mental well-being of Hawaii's residents and visitors are protected. Please fully support SB 272 and provide funding for UHH to continue to do their work with adequate monies. Mahalo,

After I got sick...It took months to find out what was wrong with me...I was sent home 3 times from the hospital (first they thought it was the flu, then second time they gave me antibiotics thinking it was leptosporosis).

It is a hard bill to get passionate about, I get it. I got sick from the disease and it pains me every time I have to beg councilmembers to support these bills. And so I am hoping and praying that you....sitting in this room will hear this final plea. Likely you haven't gone through this disease nor do you know anyone who has contracted this illness, and so it isn't anything more than a story you've heard about.

And right now....you have the power to support this bill and perhaps prevent this disease from becoming something personal. Something that impacts YOUR community. YOUR family. YOUR children.

I've had to leave my home, my community, my work, and my dreams and ambitions because of this illness. It has been the most painful, depressing, and humbling experience of my life. I am having to start my life over from scratch. Learning how to walk and talk and read and pee again.

I am testifying on SB272 relating to rat lungworm disease. I am testifying in support of full funding of SB272. I volunteered to interview rat lungworm survivors and film them because when I was working for the College of Continuing Education at UH Hilo organizing public lectures by faculty members, I was amazed to see how many people showed up at the lecture by Dr. Susan Jarvi, who runs Hawaii Island Rat Lungworm Working Group. I kept track of the turnouts of all lectures for 1.5 years, and no other lecture had a tremendous turnout like that one—the large lecture room was completely full. There were so many people concerned about the disease. Since I was a well-known figure among the community at that time because of my Facebook page called "Lower Puna Infographics by Dr. Mark Kimura," I offered my help and we decided to document people's voices. While we were visiting rat lungworm disease survivors/victims, I directly interacted with them got to hear their stories. In fact, I learned there are a lot more to this horrific disease as a social issue than official records by the department of health. Please consider watching the documentary film to hear what they have to say.

In conclusion, I am supporting full funding of SB272 because it is a real and serious social issue throughout the state of Hawaii and it needs to be addressed today. Aloha,

My name is Kathleen Howe and I am in support of SB 272 regarding rat lungworm disease. Eight years ago my son contracted rat lungworm disease on Hawaii Island. The disease changed our lives, dashed hopes, dreams, health, and eviscerated us financially. Ours are not the only lives to have changed because of this disease. Rat lungworm disease has had a serious impact on the residents and visitors who have been unfortunate to contract it, has spread fear through communities that have been impacted by it, and adversely affects farmers, grocers, and consumers and thereby impacts Hawaii's efforts to be food secure.

The rat lungworm parasite and the disease it causes is not new, first cases were reported in 1959 and 1960 on Oahu and both cases resulted in the death of the victim. Serious cases requiring hospitalization have been occurring on Hawaii Island for more than ten years. Deaths have also occurred as have cases that have resulted in permanent disability. A study done in 2005 by Robert Hollingsworth, the CDC, and Hawaii DOH determined that >75% of all semi-slugs tested were positive with the rat lungworm parasite and this slug carried much higher parasite burdens than other species. The study also found that 54% of rats tested had adult rat lungworms, and 100% of lung tissue samples taken from all the rats were positive for the parasite by qPCR, indicating all rats had been infected at some time. One astute person from CDC remarked that the increase in cases was most likely due to overexposure of highly infected organisms and that control efforts could be warranted. Unfortunately, no control efforts were initiated and so the infection has spread unabated.

Studies done at UH Manoa and UH Hilo in 2012-2013 show the semi-slug still continues to be an important carrier of the rat lungworm parasite with an approximate infection rate of 65%. A rat study conducted in early 2017 by the Hawaii Island Rat Lungworm Working Group at UHH, in collaboration with USDA-APHIS and with support by HDOA vector control, showed an infection rate of ~94% in wild-trapped rats from the Hilo area. The spread of high rates of infection are most certainly related to the increase in serious cases of rat lungworm disease in Hawaii. In 2010 there were four hospital discharges related to rat lungworm disease. In 2016 this rate rose to 22 hospital discharges. Because of the difficulty of diagnosis of this disease we know we are only catching the tip of the iceberg of cases. As of this past week the semi-slug is now known to be on Maui and may well be responsible for the increase in cases happening there. Recently two tourists came to Hawaii to get married and they got rat lungworm disease as well. This is unacceptable.

For too long this serious disease and the vectors that carry the parasite have been ignored. Funds have been found for other invasive species that cause problems for residents and visitors and funds must be found for this problem before it ruins more lives. Besides humans, farm animals, pets, and zoo animals are at risk. There are a number of research projects, vector control initiatives, and education outreach efforts that need to be conducted immediately to solve this serious issue for Hawaii. Full funding of SB 272 will be a very good start in the right direction for the State of Hawaii. Please support full funding of SB 272 to UHH for research and education for rat lungworm disease.
