Criteria for inclusion on the "terror watch list" are undisclosed, even to those who may be erroneously on the list, does not reach the level of probable cause, is fraught with errors per a GAO report, and extremely difficult to be removed from. Individuals wrongly on the list have included an 8 year old child, active duty military members, and serving US legislators.

Imagine if instead of being barred from owning firearms the prohibitions for those on the list included being banned from voting or exercising your First or Fifth Amendment rights. Would you think that appropriate?

No one wants terrorists getting firearms, but this bill, if passed, will impose unacceptable restrictions on individuals without adequate due process. Two very basics of our legal system is the presumption of innocence until proven guilty and the ability to confront one's accusers with any evidence they may have. This bill removes that presumption of innocence and turns that basic tenet on its head and presumes an individual on the list guilty. Furthermore, it makes the ability to confront the accuser nearly impossible and shields any evidence from production to the accused. That is not the way our legal system should work.

We urge you to NOT pass this bill.

Comments: I strongly oppose Senate Bill 280. I do not want terrorists or dangerous people to have firearms, any suggestion otherwise is offensive and wrong. However, I am opposed to a secret government list, which a large number of Americans mistakenly end up on every year, that is used to deny individuals their constitutional right without proper due process of the law. This legislation would affect law-abiding individuals who mistakenly end up on the list for unbeknownst reasons. The terrorist watchlist is not public record: both the list of individuals and the criteria which is used to determine who is added to the list is secret. Additionally, there is no know process for being taken off the list. Due process is a pillar of the American justice system, and a constitutionally protected right cannot and should not be taken away on the basis of a secretive or unsubstantiated accusation. When utilizing the National Instant Check System (NICS), individuals on the terrorist watchlist are already queried and denied a firearm if they are found to be a prohibited person. Additionally, law enforcement is already notified every time a person on the terrorist watchlist attempts to purchase a firearm. Law enforcement is then able to make a case by case determination on the appropriate follow-up for each circumstance.
