Title of Bill: SB 0298, SD1 RELATING TO SCHOOLS.

**Purpose of Bill:** Establishes a workforce readiness program within the department of education to allow students to graduate from an extended high school enrollment with a high school diploma and an industry-recognized associate's degree. Appropriates moneys to develop and implement the program. Takes effect on July 1, 2050. (SD1)

#### **Department's Position:**

The Department of Education (Department) supports the intent of SB 298 SD1 to establish a workforce readiness program. The Department values its ongoing collaboration with the University of Hawaii to develop a new industry-led career and technical education (CTE) and appreciates the recognition of the necessary resources to implement such a program.

The Department has launched Connect to Careers, or C2C, an industry-led coalition for Hawaii's economic future to collaboratively prepare students for success in high-skill, in-demand careers at both state and regional levels. It is a business-led effort with aligned K-16 curriculum and opportunities that will be tracked for effectiveness via data and industry feedback. Partners include employers, state educational systems, funders, and workforce and economic development agencies. Lastly, the Department estimates \$1,054,000 for 17.0 FTE 12-month positions (15 complex area resource teachers and 2 educational specialists) and \$250,000 in operational funds to support the start up and establishment of a workforce readiness program for school year 2017-18 provided that the passage of SB 298 SD1 does not replace or adversely impact priorities indicated in our Board of Education-approved budget.

## **RE:** SENATE BILL 619 SD1 RELATING TO EDUCATION

Chair Woodson, Vice Chair Har, and Members of the Committee:
