TESTIMONY ON SENATE BILL NO. 343, RELATING TO DENTAL LICENSURE.

TO THE HONORABLE ROSALYN H. BAKER, CHAIR, AND MEMBERS OF THE COMMITTEE:

My name is Paul Guevara, D.M.D., M.D.S., Chairperson of the Board of Dental Examiners ("Board"). I appreciate the opportunity to testify on Senate Bill No. 343, which expands the qualifications for dental licensure by including passage of other examinations which are substantively similar to ADEX, dental licensure in another state, and other qualifications.

The Board supports the intent of this measure, however, it cannot support the bill as written. The Board is opposed to reciprocal licensure as some states license dentists through additional education without the passage of a clinical examination. The Board believes there may be a public safety issue by not focusing on the competency of the practitioner rather than the quantity of practitioners. Passage of the clinical examination is essential in measuring competency and ensuring the safety of the public.

Aloha Chair Baker, Vice Chair Nishihara and members of the committee! My name is Dr. Chris Lee and I serve as the president of the Hawaii Dental Association, a professional association comprised of nearly 1,000 member dentists. The Hawaii Dental Association (HDA) is a statewide professional membership organization representing dentists practicing in Hawaii and licensed by the State of Hawaii Board of Dental Examiners. HDA members are committed to protecting the oral health and well-being of all of the people of Hawaii, from keiki to kupuna and everyone in between.

We are writing to respectfully **oppose** SB 343 which expands the required qualifications that applicants may fulfill as part of the requirements for dental licensure to include passage of other examinations substantively similar to ADEX and dental licensure in another state, along with other qualifications.

We recognize the legislature's intent to ensure the health and safety of Hawaii residents. We believe, however, that this bill will not advance that goal. Licensing by "reciprocity" does not adequately ensure safety and appears to seek to address a shortage which does not exist. We ask that you do not advance this measure.

The Hawaii Dental Association is committed to improve oral health in Hawaii. We look forward to continuing to work collaboratively with you on key policy initiatives to accomplish those goals. In addition, and consistent with our longstanding public positions, we believe that water fluoridation would make significant contributions to improving oral health in our state. Mahalo for this opportunity to testify.

I am submitting testimony to oppose SB343.

This bill will essentially allow dental licensure by credentials and will remove the ADEX exam as our licensure exam. The ADEX examination is both a didactic and clinical exam, which includes showing competency doing procedures on actual live patients. There are some states that allow licensure by only completing a post-graduate residency and no clinical competency exam at all (example, New York state.) So, if this bill passes we would be allowing dentists to practice in our state without showing any clinical competency on an exam. I have been an ADEX examiner for the last four years, both here in Hawaii and on the mainland. This exam is currently accepted in 43 US states and jurisdictions, including recent acceptance in California. It is on track to becoming a national exam and is given around the country throughout the year. As an examiner, I have seen firsthand dental work come to be graded which is highly substandard and could cause injury to a patient. I recently returned from grading the exam at NYU dental school in New York City and saw dental work done that I would not want to see any patient receive. There is no reason to change this proven and fair exam. Reciprocity will allow any dentist who has been licensed for a minimum of 5 years to get a Hawaii license simply by doing the paperwork involved with the DCCA and showing their credentials. As an analogy, you would not want the pilot of your plane to have only received training on a flight simulator. As a dental board examiner, I am charged with protecting the safety of the public. The last time this was allowed to happen, Dr. Lilly Geyer, as well as an oral surgeon, who obtained their licenses during a short period of time that we allowed licensure by credentials, to kill or seriously injure patients under their care. I feel this bill would endanger the public safety.
