Comments: The Land Use Research Foundation of Hawaii (LURF) SUPPORTS SB 354, which establishes a temporary task force for the purpose of creating a single definition of "bona fide agricultural producer" to be used across state government or creating different definitions to be applied for different uses; requires a report to the Legislature; and makes an appropriation. LURF supports the proper designation, use and preservation of important agricultural lands (IAL), and partnered with the Hawaii farm Bureau and other Agricultural Stakeholders to propose and pass the IAL laws in 2005 and 2008. However, because there are a multitude of different types of agricultural operations and circumstances, we believe that it will be a difficult task to develop a single definition of "bonafide agriculture" - the definition will need to be broad enough to encompass various agricultural operations. Perhaps it may be beneficial if this effort is combined with a review of, and designation of "Rural" districts, to address issues where the lands currently designated as "Agriculture" may not be fully utilized for "agricultural" purposes. LURF respectfully urges the favorable consideration of this measure by this Committee.
