

SB435 RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS

The Office of Hawaiian Affairs (OHA) Beneficiary Advocacy and Empowerment Committee will recommend that the Board of Trustees **OPPOSE** SB435, which would require the OHA Board of Trustees to appoint the "deputy administrator, chief financial officer, and corporation counsel" for a term determined by the Board and make these positions subject to removal for cause by a two-thirds vote of the Board. This proposed change is potentially unconstitutional and is contrary to established Board policies, thereby infringing on the autonomy of our Trustees to oversee OHA operational policy.

SB435's proposed changes to the hiring and removal authority within OHA may be unconstitutional. Article XII, § 6 of the State Constitution provides that "[t]he board shall have the power to exercise control over the Office of Hawaiian Affairs through its executive officer, the administrator of the Office of Hawaiian Affairs, who shall be appointed by the board." The State Constitution thus establishes a centralized management authority for OHA, where the OHA Board of Trustees have a single report, the OHA Administrator, who is responsible for the day-to-day operations of OHA and the implementation of policies adopted by the Board. This attempt to extend the Board's hiring and removal authority beyond the OHA Administrator alters the way that the Board of Trustees exercises control over OHA and may therefore conflict with the State Constitution.

The centralized authority of the OHA Administrator over operations, including hiring and removal authority, is well-established in the bylaws and policies adopted by the OHA Board of Trustees. Under Hawai'i Revised Statutes § 10-4(1), the Board has the power to adopt bylaws "governing the conduct of its business." As related to administration staff, article VII.B. of the OHA Bylaws provides that "the Administrator may employ and retain such employees as deemed necessary to carry out the function of the Office." The OHA Executive Board of Trustees Executive Policy Manual, § 3.10.i. further provides that "[t]he hiring and firing authority resides with the [Administrator]" The OHA Board of Trustees have taken no position that suggests a desire to modify these adopted policies, therefore any attempt by the Legislature to unilaterally change the Administrator's authority would infringe upon the autonomy of the OHA Board of Trustees established in the Hawai'i Constitution and state law.

Accordingly, OHA urges the Committee to <u>HOLD</u> SB435. Mahalo nui loa for the opportunity to testify on this measure.
