Comments: While I'd like to support the intent of this Bill, I find that I OPPOSE SB 435 RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS. Allows the Office of Hawaiian Affairs Board of Trustees to appoint a deputy administrator, chief operating officer, and corporation counsel by a majority vote. Allows for their removal for cause by two-thirds vote. Clarifies that the administrator shall not employ a deputy administrator, chief operating officer, or corporation counsel. I liken the actions of this Bill to allowing the bosses Boss to choose who will work with the Boss. For example, allowing the constituents of each legislator to choose the legislators Office Manager, Admin Clerk, Legislative Aide, etc. Each of these positions must be filled by people that will work with the Boss to fulfill the bosses Boss (the CONSTITUENTS) needs.
