Aloha Chairs Espero and Gabbard, Vice Chairs Harimoto and Riviere, and Members of the Committees

Life of the Land is Hawai'i's own energy, environmental and community action group advocating for the people and 'aina for 47 years. Our mission is to preserve and protect the life of the land through sound energy and land use policies and to promote open government through research, education, advocacy and, when necessary, litigation.

SB 577 is a dangerous bill that needs to be held.

The preamble contains two dangerous statements.

"The legislature finds that ... in the urban core, where impacts to the environment may be inconsequential due to the existing development and population, additional impact statements and studies do not provide additional safeguards to the environment."

Imagine an argument that the Honolulu Rail from Middle Street to wherever, does not need an Environmental Impact Statement (EIS), because it is in the urban core, or that EIS-based cultural impact statements for Kaka`ako need not be completed, even though iwi have been found throughout the region.

The second statement states that because private developers get away without adequate EIS review, state projects should sink to that level.

"The legislature further finds that one of the triggers for environmental assessments and environmental impact statements is the use of state or county funds for the project, while privately financed projects do not similarly trigger environmental assessments or environmental impact statements."

In reality, the need for an environmental review should be based on potential impacts, not location. The fact that the bill identifies a weakness in current law, that privately financed projects on private land escapes adequate environmental review, does not imply that State projects should sink to that level, but rather, that private projects should rise to the level where adequate reviews are possible.

Affordable housing would be in the picture, if developers were not able to avoid building units, by sliding money to the government. High rises that sell all of their units in less than 24-hours, before they are built, indicate that a slightly higher unit price, to cover some affordable units, would be quite possible.

Instead, the environmental review process is blamed for the lack of affordable housing.
