SB 616

Chairman Kidani and members of the committee

I am Marcia Linville speaking for the Education Caucus of the DPH, in support of SB 616. Have been a librarian since 1960, serving in Federal, state, city, and special libraries. Have served as President of the Librarians Association of Hawaii and as Children Section Head for the Hawaii Librarians Association, as Agency Council Head Unit 13, DOE, HGEA, for almost 20 years, served as observer of the BOE since Marion Saunders recruited me in 1970, for the various library associations, HGEA, the Democratic Party, the League of Women Voters, the Education Caucus, the Native Hawaiian Library, and more groups than I can remember. I served as resource teacher in the DOE for three years, and for Early Childhood Education. I have visited libraries in Europe and Asia for People to People, and visited libraries in most of the Unite States. I was a board member of Hawaii Literacy for over 10 years. I was a founding member of the Education Caucus and have served as its chairman and presently serve as it's State Central Committee representative These are some of my qualifications.

SB 616 is a very important bill for Hawaii's children and the future of Hawaii's economy. The last Smarter Balance test showed that only 47% of Hawaii's 4th graders are competent in reading. Testimony at the BOE stated that over 70% of Hawaii Island students will graduate without ever having a library experience. The last figures I had from Hawaii Literacy gave the illiteracy rate for Hawaii as 20% and the alliteracy rate as 40%. (alliteracy means I can read, but I don"t.) The last figures for the number of homes in Hawaii without any books or newspapers was shocking. And the Ed caucus was unable to find out from the DOE how many schools still had functioning school libraries. These facts are not unconnected. Children do not learn to read and love reading from textbooks. Even with the best teachers. People read because they have used it as a tool to give them information they want, enjoyment, escape from intolerable situations. access to other times and places, different ideas. To do that you have to have access to books and magazines. Hawaii's Children today are denied that access.

This was not the vision of those created the new State of Hawaii"s Dept. of Education. They wanted a library within reach of every child. And in the '60s they thought they had provided for it with a library for every school. But then came the time of retrenchment and school librarians were jerked out of libraries to become teachers. They never went back. That was followed by the Weighted Student formula. And the difficulty to retain teachers. Principals felt they needed teachers more desperately than librarians. You could always keep the school library open with a clerk to check out books. Well, turns out that didn't work our so well.

We badly need SB 616. Please give it your support. I am available to answer any questions you may have.

I strongly support SB616. Providing a library at every school is so self-evident that there should not even be a need to write it into law. Alas, the need is there. My children have been attending Shafter Elementary School since the fall of 2016, and they have had no access to a full library that entire time. The library is currently being used full time as a class room for 3<sup>rd</sup> grade. If we are lucky, our library will be restored to its original use at the beginning of the 2017/2018 school year—provided the portables currently being installed have been taken into service and the school does not further increase its student body.

In the mean time, my older son's classroom is visited by a small cart of books once a week. He reads at a higher grade level than most of the kids in his class, and the tiny cart rarely offer any books of interest to him. My kindergartener has yet to bring a library book home.

Please support this bill so our children can gain a lifelong love for reading, so our children can learn more than mere classroom instruction may teach them, and so our children can discover the excitement of being surrounded by books containing every topic of the world.

**Testimony supporting SB616** 

There is an alarming trend in the public schools of not having certificated qualified librarians especially among small elementary schools partially caused by the student weighted formula. The amount of dollars per student has decreased every year and with needed money for a school to survive such as operating costs of electricity, etc. and crucial teachers' position, then support staff such as school librarians are eliminated. Before the student weighted formula, every school was allotted a librarian, counselors, etc. thus ensuring that no matter how small or large the school's student population, there would be support staff to help the teachers and students. From the school librarians' directory located on the Librarians' Corner site, is the data of how many schools have no librarians. So statistically, according to the 2013-2014 directory, there are no librarians' position at 56 out of 264 public schools which represents 21% of all the public schools. In a comparison with the 2011-2012 school librarians' directory, there is a 4% increase of no school librarians' positions.

Why is this a major concern? \*Studies have demonstrated that students from schools with credentialed librarians, enriched resources within the libraries and open access to these opportunities are likely to out perform students without these assets. Also there is a correlation between the reading that the student does inside as well as outside of school that leads to increased comprehension, vocabulary and information acquisition in which the school library is the primary source for obtaining such reading materials pertinent to their learning. Thus, another major problem is the budget of the school library. When a school's budget is solely dependent upon the student weighted formula (no title 1 or other federal money), the amount of the budget leans heavily upon the number of students in the school, so in some cases, librarians have a \$0 budget to purchase books and have up-to-date resources for the students. No matter from what perspective one looks at these difficulties, there is the clear picture that the end game is one in which the student will suffer the consequences of these unresolved dilemmas in the schools.
