SB 676 - RELATING TO THE UNIVERSITY OF HAWAII

Chair Kahele, Vice Chair Kidani, and members of the Committee:

The University of Hawai'i System supports the intent of SB 676, which would provide resources for the system wide Pamantasan Council to promote access and diversity. The word "Pamantasan" is a Filipino word meaning "higher education". The Pamantasan Council, established in 1987, is open to all students, administrators, faculty and staff from the various UH campuses.

The Pamantasan Council addresses issues of representation, curriculum and research, partnerships with public schools, universities in the Philippines and other states, workforce development and community services. The Council holds annual and periodic workshops to identify priority issues and needs consistent with the University's commitment to access and diversity. On April 1, 2016, UH Maui College hosted the annual conference on its campus. Even with limited resources, the Pamantasan Council has successfully supported University initiatives including the Maui College exchange agreement with Philippine Universities, the Leeward Community College Sulong Aral federal transfer project, and the recent hiring of a UH Hilo Philippine Studies faculty member.

The Pamantasan Council needs resources to implement (a) recommendations of the 2008 SCR 120 report to the Legislature regarding Philippine language courses, teacher training and certification; and (b) Pamantasan conference recommendations such as developing courses for articulation between community colleges and 4-year campuses. With additional funding and positions, UH and the Pamantasan Council can provide necessary expertise and energy to increase the University's national leadership in Philippine Studies (UH Mānoa and Leeward CC are leaders in offering academic programs). In addition the appropriated funds will be used to support on-going recruitment and retention efforts (federal programs such as GEAR UP at Waipahu high school) to increase the number and success of Filipinos at each campus, including undergraduate and graduate degree programs, faculty, staff and administrators. Also, the funds will expand the curricular content on Philippine language, Philippine Studies and Filipino American Hawai'i ethnic studies, which at this time are very limited or not available at the various campuses. SB 676 includes information on recent census, UH

and DOE data on Filipinos (second largest group in the state and the department of education) and their underrepresentation among college graduates, and current UH students, staff and faculty.

The University supports the intent of SB 676, and would like to note that the UH Board of Regents approved biennium budget does include a request for \$584,000 to drive student success for Filipino students, a key population.

Thank you for the opportunity to testify and for the legislature's continuing support of educational access and diversity.

On behalf of the University of Hawai'i Pamantasan Council, I respectfully submit testimony for the House Committee on Higher Education hearing in strong support of SB 676 relating to the University of Hawai'i, to provide resources for the Systemwide Pamantasan Council to promote access and diversity. Filipinos are now the second largest population group in Hawai'i, the largest immigrant group, and the largest Asian ancestry group in the state, however they continue to be underrepresented in higher education.

The Pamantasan Executive Council is the UH systemwide organization concerned with the status of Filipinos on all UH campuses throughout the state. The Council was established in 1987 to address the representation and success of Filipinos on campus and to ensure that Filipino American and Philippine courses are represented in the curriculum. The Executive Council is also charged with issues concerning Filipinos in the Department of Education, Filipinos in the work force, and international relations between colleges in Hawai'i and the Philippines. The Pamantasan Council currently has no budget and is a volunteer organization comprised of University of Hawai'i students, staff, faculty, and administrators who are committed to access and diversity issues.

Funding for Pamantasan positions and projects will ensure that the state champions educational equity and diversity in higher education. We thank the legislature for introducing this important bill and for their continued commitment to diversity to ensure that underrepresented communities in Hawai'i are supported. This testimony does not represent the official testimony of the University of Hawai'i system, but reflects the support of the Pamantasan Council. We strongly encourage the passage of this bill. Please support SB 676, relating to the University of Hawai'i and Pamantasan.

My name is Charlene Cuaresma, Chair, NaFFAA Region 12, which represents the interests of Filipinos in Hawai'i, Guam, and the Commonwealth of Northern Marianas Islands. We are an affiliate of the National NaFFAA. Washington policy-makers, private industry and national advocacy groups recognize NaFFAA as the Voice of Filipinos and Filipino Americans throughout the United States. We are a non-partisan, non-profit national affiliation of more than five hundred Filipino-American institutions and umbrella organizations that span twelve regions throughout the continental United States and U.S. Pacific territories. I am happy to submit strong support for this bill.

Institutional support through funding and staffing for the UH Pamantasan Council is essential to promote access to higher education, diversity, and leadership development of our Filipino students. The UH Pamantasan Council provides an infrastructure that has a broad and deep statewide reach that will produce competent leaders and innovative stewards on every island for the benefit of all of Hawai`i. The current model of volunteers serving on the Pamantasan Council cannot effectively address the systemic and persistent disparities where Filipinos comprise over 20 percent of public school students, but only 12 percent of students at UH Mānoa; where Filipinos make up a large segment of community college students, but their transfer rates to 4-year degrees and advanced professional degrees at the University of Hawai'i Mānoa are disproportionately low. Subsequently, it is unacceptable that Filipinos, compared to other groups, are over-represented in entry level service jobs and underrepresented in executive positions. Rising to become the second largest ethnic group (15% by one race only, 25% by more than one race) in Hawai'i since 2010 is not keeping pace with the investment in resources needed for parity to uplift a disproportionate part of our community from service workers to colleagues, who can make substantive contributions in fields vital to Hawai'i's economic health and quality of life.

Thank you for hearing this bill, and for the opportunity to offer strong support for you to advance student excellence and equity in Hawai`i's institutions of higher learning.

My name is Jake Manegdeg. As president of the Filipino American Citizens League, I am proud to submit our full support of this bill. The Filipino American Citizens League was formed over ten years ago to contribute to the advancement of civil rights and social justice for minority groups, underserved populations, and vulnerable communities through education, advocacy, and social action.

The achievements and contributions of Filipinos in Hawai'i since 1906 have been well documented. But as we enter upon the 111th year of Filipinos in Hawai'i, Filipinos still have a long way to go to attain parity in society.

Our Coalition is concerned about the disproportionate number of Filipino students who are under-achieving and struggling in our public schools and underrepresented in our state colleges and university. What are the root causes of this? Filipinos are under-represented in executive positions, and over-represented in low-paying entry level positions with little or no job security in the visitor, service, food, retail, construction, and agricultural industries. This segment of Filipinos in Hawai'i's workforce can never afford the cost of middle class comforts and stability for themselves and their families because of income inequality, no matter how many part-time jobs they squeeze into 24 hours, often, at the expense of not seeing their children.

That is why we taxpayers should be investing in, not divesting from education for our Filipino students in the University of Hawai'i statewide system to ensure that Hawai'i produces leadership, scholarship and stewardship that will transform our struggling students in low achieving schools to civic-minded, productive leaders in our communities and families.

Thank you for the opportunity to support this bill and speak up on behalf of our next generation of Filipino youth. Because of our sheer numbers, the second largest group in Hawai'i, Filipinos can contribute positively and significantly to benefit our island state.

Today, I am testifying as chair of the Hawai'i Civil Rights Commission in support of SB676. HFCR endorses programs and policies that support diversity, inclusion, access and non discrimination. I am a retired Manoa faculty member and was the assistant vice chancellor for student diversity and director of the office of student equity, excellence and diversity. Last year, I worked with VPCC Morton, Interim West O`ahu Chancellor Doris Ching, Hilo Chancellor Don Straney ad Interim VC Students Lori Ideta on the Pamantasan budget request for \$615,000 and six positions. The Pamantasan budget was included in the BOR budget but was not included in the Governor's budget.

HFCR supports sb 676 which provides funds and six positions for the UH Pamantasan Council, a council with representatives from each of the ten campuses. Council activities over the decades helps University programs and initiatives to expand courses on Philippine language and Philippine Studies, classes and research on the Filipino experience in Hawai'i, initiatives to increase transfer from two year campuses to four year programs, to improve the bachelor's and professional degree graduation rates of Filipinos, the largest underrepresented group at UH.

Although program activities will be at all ten campuses the requested six positions will be based at Honolulu CC, Kauai CC, Maui College, Hilo, Manoa and West O'ahu. With full-time staff, the Council will be more effective in meeting the University's strategic direction to increase graduates (the Hawai'i Graduation Initiative), and to support the state's workforce development goals, and our community's aspiration for inclusion. The Filipino students, their families and the community seek access to higher education.

I respectfully request your support of sb 676 for the UH Pamantasan Council.

Aloha! Kumustakayo amin! (how are you all?)

My name is Rouel Garingo Velasco. I write to you in support of SB 676. As the son of migrants from Ilocos Norte and Ilocos Sur, Philippines, I am a proud graduate of the University of Hawai'i at Manoa UHM) for both of my bachelor's and master's degrees. My family first lived in Kalihi and later settled in Ma'ili of Wai'anae, where I grew up. Wai'anae is a predominantly Native Hawaiian community, followed by a strong Filipino population. After graduation from high school, not many graduates pursued a higher education; many went to work or joined the military. It seemed that access to higher education for young people from my community was not as promoted as in other communities. Out of a graduating class of 400, 11 of us attended UHM. It is truly a privilege for me to attend UHM and I would like to share that opportunity with others. My college journey at UHM was one that was filled with personal empowerment through appreciation for my Filipino heritage. Courses in Ilokano Language, Filipino Language as well as History courses allowed me to learn more about my Filipino heritage, the Philippine languages, as well as struggles and successes. This learning experience gave me a full sense and deeper appreciation for who I am as a Local Filipino. The in-and-out of the classroom experiences with other students of Filipino ancestry as well as staff and faculty, allowed me to connect to the culture in meaningful and purposeful ways. The Filipino community on the UHM campus allowed me to feel belonged, not marginalized; given me the connections and confidence to get involved in campus-wide student involvement and leadership opportunities. All these experiences combined allowed me to shape my academic, personal and career goals. In addition, as a student, I benefitted from the support and services provided from the UHM Office of Multicultural Student Services, where they assisted students from disadvantaged communities and underrepresented groups. This office fostered a safe and welcoming space for Filipinos students as a gateway to other services on the UHM campus.

As a student, I participated in the Pamantasan Conferences to connect with other students, staff and faculty across the UH System. This gathering formed a pipeline of support for students matriculating from the community colleges to the university. I also had the opportunity as an undergraduate student to coordinate the Pamantasan conference. This was truly a transformative learning experience. Since moving to University of Hawai'i - West O'ahu, very little is available to support and understand the concerns facing students of Filipino ancestry. I am in a position to encourage our students to get involved in the Pamantasan Conferences.

It is my hope that UHWO students of Filipino ancestry have access to Philippine-related language and history courses as well as the opportunity to attend Pamantasan conferences to further expand their appreciation for their Filipino heritage and be a part of the growing Filipino community within the UH system.

As a student affairs professional at the UH West O'ahu, I see the growing need for such courses and programs to be available as students of Filipino ancestry comprise the second largest student population behind Native Hawaiian. This bill, SB 676, will give an opportunity to the students at UH West O'ahu and other campuses throughout the UH System the opportunity to further explore and affirm their Filipino identity, establish meaning and purpose directly contributing to achieving their academic, personal and career goals. I thank the Senate for introducing SB 676 and hope that through its passage, students of Filipino ancestry as well as professional staff and faculty members may continue to improve access, retention and persistence for students in higher education. As a Filipino graduate of Leeward Community College, the University of Hawai'i (UH) at Mānoa, and as a current administrator at UH Mānoa, I strongly write in support of HB 902 that will provide resources to support the University of Hawai'i system wide Pamantasan Council.

According to the 2010 Census, Filipinos are now the second largest ethnic group in Hawai'i at roughly a quarter of the population. However, Filipinos continue to underachieve in higher education and remain among the lower socioeconomic groups in Hawai'i. In the UH system, Filipinos are well represented in the community colleges, yet remain underrepresented at the university levels, particularly at UH Hilo and UH Mānoa (the flagship campus of the system and the only Carnegie Doctoral Extensive institution in our State).

With higher education as key means to social mobility, this condition is of grave concern.

The Pamantasan Council serves to explore these and other issues related to Filipinos in the UH system with the primary goal of supporting the higher education progression of Filipino students.

However, the Council operates with virtually no budget and only volunteer students, faculty, staff, and administrators in the UH system who are committed to issues of higher education access and diversity. Funding for the Pamantasan Council will help to ensure its organizational structure, provide stability, and strengthen the efforts in achieving its goals.

Both as a student and as a faculty member, I have personally benefited from the work, support, and networking I have received from the Pamantasan Council.

Filipinos have a rich and valuable history in Hawai'i and those with the desire and capacity to succeed in higher education need to be supported.

With their ever growing numbers in our community, all of Hawai'i will benefit through the work of the Pamantasan Council to improve the condition of Filipinos in Hawai'i public higher education.

Hello, my name is Nicolita Garces. I am an archivist and librarian. As a University of Hawai'i alumna and an active member in the local Filipino community, I strongly write in support of SB 676.

While a UH student, I participated in several Pamantasan conferences as an attendee and panelist. I also participated in a Pamantasan Council led teach-in when the funding for the Philippine languages programs was being threatened. For some students, Pamantasan Council gave them their first exposure to learning more about their roots. I experienced first-hand and witnessed the importance of young adults being empowered and decolonialized through knowing their heritage and culture. In doing so, they gain the confidence needed to enroll and graduate from college, thereby becoming productive members of society.

Filipinos have been in Hawai'i for 111 years since the first *sakadas* arrived to work in the plantations. The 2010 U.S. census reported that Filipinos are the largest "ethnic group" in Hawai'i. Despite a long history and a large presence in Hawai'i, Filipinos are still on the bottom rung of the socio-economic ladder. In the UH system, Filipinos comprise of 12% of the student population. Pamantasan Council continues to address the disparities between representation of Filipinos in Hawai'i and in the UH System by providing resources to assist Filipino students enroll and matriculate through college.

It is sensible to fund the six full-time positions for the system-wide Pamantasan Council to increase the number of Filipino students in the UH system. This solution will also meet the UH system's strategic goal of access and diversity. I am Winona Lee, a Native Hawaiian/Filipino pediatrician and Assistant Professor in the Department of Native Hawaiian Health at the University of Hawai'i at Mānoa's John A. Burns School of Medicine. This testimony is in strong support of SB 676. This bill appropriates general funds for 6.0 FTE positions for the UH Pamantasan Council to promote access and diversity, including programs and policies related to Philippine courses and Filipino students.

I support this bill for the following reasons:

- Despite the high numbers of Filipinos in the general population and within the public DOE system, students and faculty members of Filipino ancestry are underrepresented within the University of Hawai'i system. Filipino students comprise only 12% percent of the University of Hawai'i system student population and only 0.5% of University of Hawai'i Mānoa (UHM) faculty.
- Since 1987, the UHM Pamantasan Council has demonstrated a strong history of promoting access and diversity for Filipino students and serves as a vocal advocate, effective collaborator, and solid community resource. Providing this critical support to college students enhances and contributes to the development of stronger academic, professional, and personal support networks that will potentially contribute to Filipino student success in higher education.
- As a Native Hawaiian/Filipino, first generation college student, I found the path to medicine challenging, particularly in my early undergraduate years. My dreams to pursue higher education became possible with the help of family, mentors, and support networks. I would not have become a pediatrician, educator, and mentor for other students were it not for the help that was provided to me.

Thank you for the opportunity to provide testimony. The Graduate Student Organization at the University of Hawai'i at Mānoa (GSO) stands in support of SB676. The GSO represents approximately 4,700 graduate students at the University of Hawai'i at Mānoa, about 200 of whom are of Filipino ancestry.

If passed, SB676 will create 6.0 FTE positions for the UH Pamantasan Council to promote access and diversity, and create programs and policies related to Philippine courses and Filipino students. Although people of Filipino ancestry are the second largest ethnic group in Hawai'i and nearly 21% of students in the Department of Education, Filipino students only represent 12% of the entire University of Hawaii system student population, and only 4.5% of the graduate student population.

We, the GSO, find these statistics very troubling and believe we need to do more to provide higher education access to the people of Hawai'i—especially people of Native Hawaiian, Pacific Islander, and Filipino ancestry. The University of Hawaii System is committed to diversity and ranks as the most diverse university in the nation. However, there is always room for improvement. The university needs to build better infrastructure to support Filipino students, and we believe SB676 will help to achieve this goal. By providing funding for 6.0 FTE system-wide positions dedicated to advancing support for Filipino students, the legislature can help to institutionalize current efforts that provide access and programing to an underrepresented community. Increasing access and programing for Filipino students can also help Hawai'i reach its goal of having 55% of its residents obtain a college degree by 2025, which will lead to a more educated society and innovative economy. For these reasons, we urge you to support SB676.
