In consideration of SENATE BILL 700, SENATE DRAFT 1, PROPOSED HOUSE DRAFT 1 RELATING TO ANIMAL CRUELTY

Senate Bill 700, Senate Draft 1, Proposed House Draft 1 proposes to amend Chapter 711, Hawaii Revised Statutes (HRS), so that the offense of cruelty to animals in the first degree includes indigenous birds and cruelty to animals in the second degree includes restraints to dogs that deprive them of necessary food or sustenance. The Department of Land and Natural Resources (Department) offers the following comments with regards to SECTION's 2 and 3 of this measure as it relates to indigenous birds.

The Department notes that the definition of indigenous bird as proposed under this bill covers all indigenous birds in Hawaii including those that are threatened and endangered. The Department agrees with this definition as it is consistent with the Department's definition of indigenous birds.

The Department also notes that the offense of cruelty to indigenous birds under Section 711-1108.5(1)(c), HRS, is considered an offense if two or more indigenous birds are affected. The Department feels that the protections under this Statute should be provided if even one indigenous bird is tortured, mutilated, or poisoned, and should not be limited to a threshold of two birds.

The Department suggests Section 711-1108.5(1)(c), HRS, be amended (bracketed, stricken, and highlighted) on page 4, lines 8-9, to read as follows:

(c) Tortures, mutilates, or poisons, or assists another in causing the torture, mutilation, or poisoning of [two or more] indigenous birds.

Chair Creagan and Members of the Committee:

The Department of the Attorney General appreciates the intent of this bill while noting some concerns. The concerns identified below pertain only to the S.D. 1 portion of the bill that seeks to include "indigenous birds" within the animals covered by the felony offense of Cruelty to Animals in the First Degree, section 711-1108.5, Hawaii Revised Statutes (HRS).

The preamble to this bill notes discordance with the lack of protection afforded to indigenous birds as they may not fall within the protections of the Endangered Species Act of 1973 ("Act") or chapter 195D, HRS. In light of this, the bill proposes protection for these perceived unprotected birds.

However, neither the Act nor Chapter 195D create felony consequences for the destruction of endangered animals. Penalties for violations of these provisions range from petty misdemeanors to misdemeanors.

Wildlife, including indigenous birds, currently receive similar protections in chapter 183D, HRS, and section 13-124-3, Hawaii Administrative Rules, adopted by the Department of Land and Natural Resources. Any person convicted of killing such animals, under either system, shall be subject to misdemeanor penalties.

Moreover, indigenous birds currently fall within the purview of Cruelty to Animals in the Second Degree, section 711-1109 HRS. Penalty under this section constitutes a misdemeanor.

Hawaii case law prohibits law enforcement from charging individuals with a higher level offense when their conduct fairly amounts to a lesser offense. The above-referenced provisions each makes it difficult to establish that a prospective defendant's conduct constitutes a felony versus the misdemeanor.

Finally, one distinction between the misdemeanor offenses discussed herein and the proposed bill's felony offense is the italics mens rea, or state of mind required to establish guilt. The bill's intentional or knowing state of mind would require the prosecution to prove, beyond a reasonable doubt, that a defendant intentionally or knowingly killed an indigenous bird meaning, among other things, that a defendant intended to kill a bird that was indigenous, or that the defendant knew that the bird being killed was indigenous. Chair Creagan, Vice-Chair DeCoite and members of the House Committee on Agriculture, the Department of the Prosecuting Attorney of the City and County of Honolulu submits the following testimony in <u>support</u> of S.B. 700, S.D. 1.

The purpose of S.B. 700, S.D. 1 is to amend the offense of cruelty to animals in the first degree to include indigenous birds. The Department believes that indigenous birds would be an appropriate fit within our existing animal cruelty laws, which already provide felony penalties for torture, mutilation or poisoning of pet animals and equine animals.

Hawaii is fortunate to still have some indigenous birds that are not endangered, and we should not wait for them to become endangered before taking measures to protect them. To our knowledge, the only indigenous land animals in Hawaii are the hoary bat and monk seal, which receive heightened protection as endangered species, so it would not be necessary to consider any broader terms for this bill to protect Hawaii's indigenous land animals.

For the foregoing reasons, the Department of the Prosecuting Attorney of the City and County of Honolulu supports the passage of S.B. 700, S.D. 1. Thank you for the opportunity to testify on this matter.

My name is Keith Dane. I am the Hawaii Policy Advisor for The Humane Society of the United States (HSUS), and I appreciate the opportunity to submit this written testimony on behalf of our Hawaii members and supporters in support of SB 700 Proposed HD 1, to add indigenous birds to the felony cruelty code and limit the tethering of dogs, with a requested amendment.

Regarding the language updating the felony cruelty code, HSUS supports legislation to allow felony animal cruelty charges to be filed against individuals who torture, mutilate, or poison any animal, or assist another in causing these actions. In addition to the inclusion of indigenous birds as proposed in SB700, <u>we request that all animals, as defined</u> by the cruelty statute, be afforded protection from felony-level animal cruelty.

Under the current statute, it is a felony to intentionally or knowingly torture, mutilate or poison "pet" or "equine" animals but it is not unlawful to commit such heinous acts against other animals. All animals, regardless of whether they are our companions or free-roaming, should be protected from extreme acts of cruelty.

Abuse of animals has been consistently linked with other violent criminal behaviors. In fact, the FBI is now tracking crimes against animals alongside felony crimes like arson and murder because such acts are a strong early predictor of human violence. Studies have shown that up to 67 percent of violent offenders have committed acts of animal cruelty compared to nonviolent offenders. In one NJ study, 88 percent of families with physical child abuse also had histories of animal abuse and research shows that 43 percent of school shooters have histories of abusing animals.

Protecting animals from purposeful violence protects humans. This simple, commonsense update to our animal cruelty statute will protect all animals from intentional cruelty and make our communities safer.

In the event that the bill is not amended to include all animals, we request an amendment regarding the indigenous bird provision. Under the current version of the bill, it is an offense of the first degree to intentionally or knowingly torture, mutilate or poison, or assist another in causing the torture, mutilation or poisoning of 'two or more indigenous birds.' We recommend inserting the words 'any indigenous bird' in place of 'two or more indigenous birds' because any such action to a single bird should be a felony, just as it is with regard to pet and equine animals. This minor change will make the provision consistent with the rest of the section and reflect the serious nature of such actions.

With regard to the language limiting the tethering of dogs, this bill contains similar language to legislation passed by the full House last session (HB1592 HD1) and will aid in enforcement and address the greatest public safety threats related to tethered/chained dogs, such as aggressive behavior and potential attacks/bites, by prohibiting certain types of tethers (weight, length, materials, for puppies) that are most likely to increase animal suffering and aggression.

Dogs are naturally social beings who need interaction with humans and/or other animals. Intensive confinement or long-term restraint can severely damage their physical and psychological well-being. An otherwise friendly and docile dog, when kept continuously chained or intensively confined in any way, becomes neurotic, unhappy, anxious and often aggressive. Chained dogs are more likely to bark and be seen as a nuisance to the community.

It is common for continuously tethered dogs to endure physical ailments as a result of being continuously tethered. Their necks can become raw and sore, and their collars can painfully grow into their skin. They are vulnerable to insect bites and parasites, and are at high risk of entanglement, strangulation, and harassment or attacks by other dogs or people.

Tethered dogs may also suffer from irregular feedings, overturned water bowls, inadequate veterinary care and extreme temperatures. During periods of extreme heat, they may not receive adequate water or protection from the sun. Owners who chain their dogs are less likely to clean the area of confinement, causing the dogs to eat and sleep in an area contaminated with urine and feces. What's more, because their often neurotic behavior makes them difficult to approach, chained dogs are rarely given even minimal affection. Tethered dogs may become "part of the scenery" and can be easily ignored by their owners.

Unmonitored tethering is not only bad for dogs—it is a high risk factor in serious dog bites and attacks. Dogs unable to retreat from perceived or real threats can act out aggressively when approached. Dogs tethered for long periods can become highly aggressive. Dogs feel naturally protective of their territory; when confronted with a perceived threat, they respond according to their fight-or-flight instinct. A tied dog, unable to take flight, resorts to fight, attacking any unfamiliar animal or person who unwittingly wanders into his or her territory.

Tragically, the victims of such attacks are often children who approach the dog unaware of the risks. Furthermore, a tethered dog who finally does get loose from his chains may remain aggressive, and is likely to chase and attack unsuspecting passersby and pets because s/he has developed severe behavior problems from long-term, intensive confinement.

The Humane Society of the United States requests a favorable report on SB 700 Proposed HD 1, with our requested amendment.

The Hawaiian Humane Society supports the passage of Senate Bill 700, which intends to protect indigenous birds from cruelty and would prohibit the use of specific tethering equipment and techniques that have been found to be injurious to dogs.

Cruelty is unacceptable when directed at any creature, human or animal. A significant body of research reveals overlap between people who abuse animals, of any kind, and those who abuse human beings.

While the Society does not distinguish between endemic, indigenous or introduced species in calling for the humane treatment of all animals, we appreciate the fact that SB700 means to fill a loophole that denies birds like the Laysan albatross the same legal protections afforded threatened or endangered birds. We prefer the bill's original language applying the charge to even a single bird that has been tortured, mutilated or poisoned.

The Society strongly supports most of the tethering provisions in SB700 SD1 HD1 proposed. However, while we support the intentions behind the language prohibiting 24-hour tethering we believe the measure will have negative unintended consequences as written.

Our field services team regularly educates owners about the danger that constant confinement and isolation poses to both dogs and the people around them. The difficulty in proving more than 24 consecutive hours of tethering may make the measure less effective than educational outreach. We would like to work with the Chair and committee members to craft an enforceable provision with the same goal in mind.

I, Angie Ali, founder of Amanie K9 **was bit by a once chaince dog.** The poor dog was also fed gunpowder to make him a fighter. (yes chained-tethered dogs are rarely treated well and often portend serious problems such as domestic violence, drugs, dog-fighting or serious violence in society). My hand has Not worked the same since. I also have a beloved retirement property in Volcano that is worth less due to the barking chained dogs next door, no-one living there, just pit bulls on chains having more pitbulls. We dont go up there anymore and its practically unsellable. This is Ok with Hihs and current law. The article below showing child victims explains exactly how these kids get mauled and includes the 17 month old that was mauled to death in Hawaii. We also lost an elderly lady in mountian view mauled to death by dogs chained and let lose to kill in the evenings. This needs to change as Hawaii is Far Behind on Nationwide Animal Welfare Laws including Tethering and the result is impacting our entire lives in the community as we know it. 25 other states And counting have adopted tethering laws for the safety of their communities.

When asked if they feel the law has been a good thing, here is what some of the No chain county Animal Control Directors had to say ~ In direct opposition to our Hawaii HIHS lobbying against animal welfare laws -

(north Carolina) Ms. Brown said the ordinance has been "absolutely good" for the dogs in the communit y. Dogs that are chained without human contact and love become problems for the community. (N. Carolina Wilmington)

Carthage Missouri - Ms. Artym said that some residents do not like the ordinance, but it has been good for the community. Since the ordinance was enacted, which was around 1993, there are less dogs at large in the community and less dog bites reported. She said chained dogs are much more aggressive. (Carthage,Missouri)

Ms. Destreza believes the ordinance has been a good thing in that it has helped with the pitbull fighting rings and with incidents of aggression. They felt the chaining led to aggression and a low quality of life for the dogs. Ms. Destreza states most of the chained dogs are pit bulls and they've had a problem with pit bull fighting in the area. She feels the ordinance has helped them additionally with this problem. (New orleans, Louisiana)

Do you feel the law has been a good thing? Lawton Oklahoma - Rose Wilson- Animal Control Director, stated ~ Yes. While some dogs are relinquished, if they can be rehabilitated and are friendly, they are placed up for adoption. Ms. Wilson says dogs that are not adopted and ultimately euthanized, are better off because they were out of control and dangerous to the community. Lawton has seen a decrease in the number of dogs dying from heat strokes and from strangulation on chains. Ms. Wilson states that chained dogs are bad for the community because they are much more likely to bark and also more likely to bite. The chaining causes them frustration and stress.

(Lawton, Oklahoma)

HIHS is **NOT** an animal welfare organization - they are animal control and extermination organization whose lobbying is in violation of their 501c3 status. The conflict of interest comes from their 2 million dollar extermination contract with the county of Hawaii. whereby they are testifying against animal welfare laws.

In 1997, the **USDA ruled** that people and organizations regulated by **Animal Welfare Act** cannot keep dogs continuously chained.

So - what problems are associated with dog tethering ?

1-Chaining is inhumane and unsafe for dogs

Dogs are, by nature, social beings who thrive on interaction with people and other animals. A dog kept chained in one spot for months or years suffers immense psychological damage. A continuously chained dog usually becomes neurotic, anxious, and aggressive.

In many cases, the necks of chained dogs become raw and infected from too- tight collars. Dog tethers can easily become entangled with other objects, choking or strangling the dogs. Chained dogs cannot escape threats such as floods, storms, or attacking animals.

2-Chaining is a safety hazard for people

Dogs naturally feel protective of their territory. When confronted with a perceived threat, they respond according to their fight-or-flight instinct. A chained dog, unable to take flight, often feels forced to fight. A study by the Centers for Disease Control found that chained dogs are 2.8 times more likely to bite. The dogs most likely to bite are male, unneutered and chained. Tragically, the victims of chained dog attacks are usually children. Dogs shouldn't be allowed to run loose either. Dogs should be socialized and kept inside the home or in fenced yards.

If the 24 hour clause is so objectionable to HIHS we are ok with removing it entirely to read - No tethering or chaining AT ALL unless surpervised activity. That would certainly simplify things - This is how it appears in many other states -

Here is an example from randolph county - fliers -

ATTENTION - CHAINING/TETHERING OF DOGS NOT ALLOWED IN RANDOLPH COUNTY The Randolph County Animal Control Ordinance has changed. Tethering or chaining of dogs is no longer allowed in Randolph County.

Residents have until January 1, 2017 to find another way of keeping dogs on their property.

Dog owners can:

 $\cdot\,$ tether a dog for a reasonable period of time to allow for bathroom breaks

 $\cdot\,$ tether a dog on a runner for a reasonable period of time that allows the dog to exercise

On January 1, 2017, residents who tether or chain their dogs will receive a warning citation. If the dog remains tethered, there will be a fine.

Dear Chair Creagan, Vice-Chair DeCoite and Agriculture Committee members,

The West Hawaii Humane Society <u>fully supports SB700</u>, proposed HD1, to add indigenous birds to the felony animal cruelty statute and to limit the tethering of dogs.

Many know that a number of our indigenous Albatross were brutally killed at Kaena point last year. Unfortunately, even give the malice and torture involved in these killings (legs cuts), the perpetrators only face misdemeanor charges. SB700 would raise the penalties for the intentional killing of these animals, as all animals deserve protection from such brutal and unnecessary treatment. Felony level penalties, which carry higher fines and possible jail time, would help to deter such future heinous acts. Given the potential to deter future crimes we recommend that this apply to any (1) bird, not 2 or more.

Regarding the addition of provisions to prevent inhumane dog tethering, extensive research demonstrates that tethered or chained dogs are 3 times more likely to bite and of those cases, 5 times more likely to bite children. Limiting the tethering of dogs to only those periods of time or activities where they are supervised by their owners, helps to improve both the dogs' welfare and community safety. Dogs are highly social species and need interaction and socialization to decrease the likelihood of aggression and other dangerous or nuisance behaviors.

The language in the proposed HD1 relating to dog tethering contains the same language as passed by the full House last session (HB1592 HD1). This language was determined by the Honolulu Police Department and contracted animal control agencies (county humane societies) to be the most fair and enforceable. While we encourage all pet owners to keep their dogs indoors, we appreciate that there may be limited periods of time when an owner, without a fence for example, may need to temporarily tether their dog. This is acceptable when the owner is on the property to ensure the dog does not get loose or become entangled.
