RELATING TO DEFERRED MAINTENANCE

Senate Bill No. 719, S.D. 1, amends Chapter 37, HRS, by adding a new part called "Deferred Maintenance Plan" that includes: 1) target dates for eliminating deferred maintenance costs; 2) alternative target dates based on different scenarios and contingencies; 3) standards and criteria for calculating deferred maintenance costs and improvements; 4) the designation of the State Executive agency responsible for calculating the deferred maintenance costs of State-owned buildings, facilities, or other improvements; 5) an estimate of the total amount of funds necessary to eliminate deferred maintenance costs; 6) a proposed schedule for eliminating deferred maintenance costs by the target date; and 7) alternative schedules to the proposed schedule based on the alternative target dates. Senate Bill No. 719, S.D. 1, requires the Office of the Governor to prepare a plan that is to be updated annually to help reduce the backlog of deferred maintenance on State-owned buildings, facilities, or other improvements and appropriates unspecified general funds for its preparation.

Although we support the general intent of trying to address deferred maintenance of public facilities in a timely manner, the Department of Budget and Finance has concerns with this bill. Currently, estimates of deferred maintenance costs are collected and submitted as part of the Executive Budget per Act 150, SLH 2015. In the Executive Budget for FYs 17--18 and 18--19, the Executive departments reported \$3,162,368,655 in total estimated deferred maintenance costs in all means of financing. However, it is difficult to estimate as departments have varying staff capabilities and the timing of the repairs is likely to have a cost impact, not included in the estimates.

Departments currently provide information on repair and maintenance needs as part of their budget request. This information is based on the best information and resources available at the time of the request. We defer to the individual departments regarding the effort and resources needed to develop a deferred maintenance plan required to comply with this measure, as there is presently no state-level resources to verify the accuracy and consistency of the information.

Bill No. and Title: Senate Bill No. 719, S.D. 1, Relating to Deferred Maintenance.

Purpose: Requires the Governor to prepare a deferred maintenance plan to gradually eliminate the deferred maintenance costs of all state-owned buildings, facilities, and other improvements. Requires the initial plan to be submitted to the Legislature with the executive budget for the fiscal biennium 2019-2021. Requires the Governor to prepare annual updates. Imposes the same requirements on the Chief Justice for Judiciary-owned buildings, facilities, and other improvements. Makes an appropriation to the Office of the Governor and to the Judiciary. Takes effect 7/1/2050.

Judiciary's Position:

The Judiciary respectfully offers the following comment about Senate Bill No. 719, S.D.1.

The Judiciary suggests certain common assumptions and a common format be developed for presentation of the deferred maintenance plans. For example, there should be an understanding that all projected expenses be stated in dollars as of the plan due date or a standard escalation rate assumed so that, as various scenarios and target dates are explored and adjusted by various

agencies, results are calibrated for reasonable comparison of repair and maintenance costs over defined time horizons.
