SUBJECT: SB 748 – RELATING TO CHILD CARE FACILITIES

Hearing: Friday, January 27, 2017, 2:45 p.m. Conference Room 016, State Capitol

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) appreciates the intent of this measure and offers comments. In particular, DHS is currently working on complying with recent changes in federal and state law that require DHS to post similar monitoring and inspection information to a public website. DHS expects the information to be available on a public website by 2018.

**PURPOSE**: The purpose of the bill is to require the Department of Human Services to post its inspection records of the child care facilities on a public website and submit an annual report to the Legislature of certain information from inspection records related to child care facilities.

The primary focus of DHS child care licensing program is on the health and safety of all children in care. Congress passed and on November 19, 2014 President Obama signed into law the Child Care and Development Block Grant (CCDBG) Act of 2014, Public Law (P.L.) 113-186, which reauthorized the Child Care and Development Fund (CCDF). The CCDBG Act of 2014 made expansive changes focused on protecting the health and safety of children in care, ensuring parents and the general public have transparent information about the child care choices available to them, and improving the overall quality of early learning and afterschool programs.

To bring Hawaii law into compliance with federal law, the Hawaii legislature passed Act 88, Session Laws of Hawaii (SLH) 2016, which became effective July 1, 2016. Part of the Governor's bill package (HB2343/SB2872), Act 88 (SLH 2016) made substantial amendments to safety provisions to protect children in child care consistent with the CCDBG Act. In addition to enhancing and expanding background checks, training and monitoring provisions of exempt providers caring for children whose families receive a CCDF subsidy, Act 88 (SLH 2016) amended section 346-153, to allow DHS to post records of deficiencies and complaints on a public website. DHS is currently working to implement these extensive changes in the regulation of child care providers.

The U.S. Department of Health and Human Services, Administration for Children and Families (ACF), issued the Final Rule 45 Code of Federal Regulations (CFR) Part 98 for the CCDF program and which became effective November 30, 2016. The 45 CFR Part 98 rule revision provided needed guidance regarding P.L. 113-186 requirements to the states, territories, and tribes that receive CCDF grants and clarified that the consumer education information website requirement for each state will need to include:

- a. The process of licensing child care providers;
- b. The process for conducting monitoring and inspections of child care providers;
- Policies and procedures related to criminal background checks for child care providers;
- d. The offenses that prevent individuals from serving as child care providers;
- e. A localized list of all licensed child care providers searchable by zip code;
- f. Results of monitoring and inspection reports and those reports due to major substantiated complaints about failure to comply with the provisions of health and safety;

The reports on the public website shall include information on the date of such inspection, information on corrective action taken by the state and the child care provider, where applicable, any health and safety violations, including any fatalities and serious

injuries occurring at the provider, prominently displayed on the report summary, and a minimum of 3 years of results where available.

DHS has been diligently working toward improving the health and safety system through meeting the requirements of the CCDBG Act, P.L. 113-186 and 45 CFR Part 98, and DHS anticipates the implementation of the public consumer education website by late 2018.

DHS provides further comments for the committee's consideration. There may be unintended consequences if this bill is adopted as drafted as it is inconsistent with federal provisions and creates uncertainty. Page 1, line 15 insertion of "shall" and deletion of "may" would require DHS to post all complaints of alleged violations received by DHS. DHS is concerned that because there is no minimum standard of evidence required to submit a complaint to DHS, families, consumers and the public may be confused by postings of complaints in which DHS did not find any evidence of violations of the child care rules or laws.

Congress and the ACF through P.L. 113-186 and 45 CFR Part 98 understood that consumers and the public should have information posted regarding *substantiated* complaints in which the state has found violations of regulatory requirements; such posting of only substantiated complaints would allow the public and parents to access critical information quickly without having to sift through other information, like unsubstantiated reports where the state did not find violations of any regulatory requirements.

If the Committee finds that posting of all complaints is necessary for consumers and the public, DHS may need to consider additional IT system modifications to accommodate this change as DHS is currently in the planning and development process of the public website to meet the requirements of P.L. 113-186 and 45 CFR Part 98. Changes to state law may result in additional delays to DHS meeting the targeted implementation date of late 2018. DHS would also need to consult with the ACF as to whether or not such additional unsubstantiated complaint information posted would risk the department's ability to comply with CCDBG Act P.L. 113-186 and 45 CFR Part 98 as consumers would have to sift through the additional information to determine for themselves which complaints are 'critical information' and were substantiated complaints by DHS.

DHS proposes leaving page 1, line 15 as "may," since P.L. 113-186 and 45 CFR Part 98 already require DHS as a condition of continued receipt of the federal CCDF grant to post such substantiated complaint information and results of monitoring and inspection reports on a public website.

Administratively, DHS does not anticipate any additional costs to the department to implement the proposed public website under the requirements of P.L. 113-186 and 45 CFR Part 98, as DHS is already working on meeting these requirements. Any additional requirements that the public website would need to meet under this bill would likely have additional costs involved of an estimated \$80,000 and additional time of 6 - 12 months to implement would likely be needed. DHS asks that the committee provide an effective date to give DHS sufficient time to implement any required changes.

My son Wiley Muir, was not quite four months old when he passed away under suspicious circumstanced under the care of a State licensed day care provider, Therese Manu-Lee in February 2014. Following Wiley's death, Manu-Lee's State license was suspended while DHS supposedly conducted an investigation regarding the circumstances of this death. Despite the license suspension, Manu-Lee opened up a day care at another location and continued watching children. Over this same period, Manu-Lee also took deposits from parents, and did not disclose that her license was suspended. She did not provide child care services to those parents, and many never received their money back. Parents sought her out and trusted her because she held a state license, and believed that there were safeguards in place to prevent her from committing fraud. Despite complaints about her fraudulent behavior being reported to DHS, her license was reinstated once the investigation regarding Wiley's death was closed. As a result, parents continued to entrust their children and money to her care.

In July of 2015, Manu-Lee was shut down once again after she was caught with 14 children in her care, 8 of which were infants. The legal limit for in home day care in Hawaii is 6 children, only two of which can be infants. According to her records, a total of 18 children were receiving care, though they were not all present at the time of the inspection. Her license was again suspended, this time on the grounds of physical neglect of children. Manu-Lee also had two adult men living in the house who were not approved by DHS to be present with the children. They were her sons, but they had not undergone the standard background checks and approvals. Given that her mother ran a state licensed day care prior to her taking it over, she was well aware of the requirements to disclose their presence. Other parents noted that she would at times leave her house to run errands, leaving the children with an assistant and/or her sons.

The State Attorney General's office has since verified that Therese Manu-Lee was indeed employed by Wilson Home Care. This is a trusted assisted living home health care service for the elderly on Oahu. A company that runs criminal and abuse background checks. Despite that my baby died under suspicious circumstances in her care, that she committing fraud innumerable times (and eventually filed for bankrupty), and that she was caught neglecting four times the legal number of infants, Therese Manu-Lee was still able to secure a position in elder care, because there is no record publicly available of all of the violations she amassed.

Without these records systems in place, there is no opportunity for the public or employers to thoroughly evaluate potential care givers who are responsible for our most innocent and vulnerable.

Upon further investigating this provider and engaging in a lengthy and unfruitful bankruptcy proceeding where myself and 27 other families have lost out on a total of \$43,000. I believe that there should be a public database that parents can access to ensure they have chosen a trustworthy and compliant caretaker. SB748 is a necessary step that must be taken to ensure that childcare providers who do not comply with state laws are listed on a public database. **SB748** - I have recently experienced the difficulties and lack of transparency associated with current DHS and CWS rules regarding complaints and closures of a licensed daycare facility within the Puna district. Only by chance did I find out what the complaint regarded, and was able to ask my then 2 year old more questions about his child care situation. After asking questions (although NOT leading) my son disclosed that his penis was tickled by an adult at the in-home center, and that he stopped it because, "But I told him NO!" My son also disclosed similar information to police. CWS did not find sufficient evidence to support the complaint, and now the complaint is private and the daycare was cleared. DHS is finishing its investigation but is relying on CWS for the information, so the facility will most likely be reopened. Any investigation that is cleared is currently not made public.

TWO toddlers telling police that they were inappropriately touched was not enough to keep this place closed - the very least we can do to protect our keiki is to make sure that anyone interested in looking-up the history of a daycare facility can make his/her own choice.

Comments: Aloha Senators Green and Chang, and Members of the Committee, I appreciate the opportunity to submit testimony on this important issue. For many of those who are parents or guardians, finding affordable, safe and guality childcare is not easy, especially for infants. Providing notice for inspection records of child care facilities on a public website and submit an annual report to the legislature of certain information from inspection records related to child care facilities is a positive first step, but it needs to be coupled with other initiatives that help to build a high quality childcare system. My son is going on four-years-old now, but I distinctly remember the difficult experience I had searching for what I believed at minimum was a safe and secure place for my child to be cared for while I went back to work. Like any parent, we want the best we can get for our children. But with just a minimum number of spaces (6 at most for infant care) available at only a handful of larger childcare facilities and even fewer (2 at most for infant care) spaces by home-based childcare providers there are very few options to chose from. Waiting lists in the larger facilities were about 6 to 15 months. So, finding even two or three options within a 5-6 mile radius of the workplace are nearly impossible for people with resources to secure a spot, let alone being able to afford the care which ranges between \$700 to \$1700+/mo for out of the home infant care. Unlike childcare centers that can gain accreditation from the National Association for the Education of Young Children (NAEYC) or other recognized accreditors that provide periodic evaluations and publish scores for facilities they accredit, many home-based child care providers do not have this option. Some states like Washington have created their own 5-tiered ranking system, which gives parents the ability to evaluate the quality of care they receive for their child and gives a subsidy or tuition award provider the ability to reward quality for child care givers and provide other incentives like tuition help to community-college based/career education programs to help caregivers gain appropriate training necessary to improve their skills and service. Providing transparent notice of inspection records is a positive step for parents to know what the minimum level of quality is; however, without the ability to gain appropriate levels of training to improve service and input from parents who are consumers of this system, it is just one tool in a box of many that are needed to build a quality system of childcare and preschool services in the state.
